CHAPTER LXXXV.

AN ACT

To improve the navigation of the river Delaware.

Commissioners named.

Sect. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That Jacob Mixsell, of the borough of Easton, and Lewis S. Corvell and colonel John Kinsey, of the county of Bucks, be, and they are hereby appointed commissioners, who shall have power, and it shall be their duty to cause to be removed all obstructions which impede or injure the navigation of the river Delaware, and to commence at the head of the "foul rift" in Northampton county, to the falls at the Trenton Delaware bridge, and for that purpose to employ suitable persons to perform the said work.

Sect. 2.
