# CHAPTER XCVI.

#### AN ACT

To amend and continue "An act for establishing a Health Office, and to secure the city and port of Philadelphia from the introduction of pestilential and contagious diseases," and the supplements thereto.

Sect. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That the act, entitled "An act for establishing a Health Part of for-Office, and to secure the city and port of Philadelphia from mer acts rethe introduction of pestilential and contagious diseases," pas- pealed. sed on the seventeenth day of March, eighteen hundred and six, together with the supplements thereto, passed on the thirty first day of March, eighteen hundred and twelve, and the twenty-fifth day of March, eighteen hundred and thirteen, (except so much of the said act and its supplements as is hereinafter altered and supplied,) be, and the same are hereby continued in force for three years from and after the twentyfifth day of March next.

Sect. 2. And be it further enacted by the authority aforesaid. And be it further enacted by the authority aforesaid, That it shall be the duty of the said board of health, and surplus funds they are hereby authorised to invest all sums of money which may at any time be in the hands of their treasurer, over and above the amount which may be necessary to meet their current expenses, in the funded debt of the United States, and to sell and transfer the stock of the same, at such times and in such portions as necessity may require.

Sect. 6.
