

pitching, curbing and paving any street or foot-way in front of said real estate, before any other lien : *Provided* the paving and assessment shall be made conformably to the provisions of the act to which this is a further supplement, and the supplement thereto, passed the thirtieth March, one thousand eight hundred and eleven, and that nothing herein contained shall in anywise impair or affect such liens as are existing at the time of passing this act.

CHAPTER CL.

AN ACT

To authorise the directors of the poor of Bucks county, to convey a certain estate therein mentioned.

WHEREAS it is represented to the Legislature, that Jacob Fox, late of Bedminster township, in the county of Bucks, by his last will and testament, in writing, bearing date the thirty-first day of March, one thousand seven hundred and eighty-three, after certain specific bequests to his wife and grand children, and a bequest of one shilling to each of his sons, did devise and bequeath the residue and remainder of his estate to the poor of Bedminster township, in said county. And whereas the inhabitants of said township are willing that the estate so devised and bequeathed, should be granted and enjoyed by the heirs and legal representatives of the said Jacob Fox:

Therefore,

SECT. 1. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same,* That the directors of the poor and of the house of employment of the county of Bucks, be, and they are hereby au-

thorised to grant and convey, in fee simple or otherwise, to the heirs and legal representatives of Jacob Fox, late of the township of Bedminster, in said county, deceased, in such proportions as they would have been entitled to respectively had the said Jacob Fox died intestate, all the estate, real, personal and mixed, which the said Jacob Fox, by his last will and testament bequeathed and devised to the poor of the said township of Bedminster; and any deed or deeds or other instruments of writing, duly executed for the purpose aforesaid, shall vest the said estate in the said heirs and representatives as fully and absolutely as though the said Jacob Fox had died intestate.

CHAPTER CLI.

AN ACT

To vest in Hanna Carrol and her legal representatives, the right of this Commonwealth to the estate of Patrick Carrol, late of Londonderry township, in the county of Chester, deceased.

SECT. 1. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That all the right, title and interest which this Commonwealth may have acquired by reason of any escheat or supposed escheat, from the want of heirs or known kindred of Patrick Carrol, late of Londonderry township, in the county of Chester, deceased, in and to the estate, real and personal, whereof he died seized or possessed, shall be, and the same is hereby vested in Hanna Carrol, to be held by her and her heirs and assigns forever: Provided, That no right of this Commonwealth, except that derived by the said escheat or supposed escheat, shall pass by virtue of this act, nor shall*
