be by them expended in improving the road across said mountains; and the said commissioners, or a majority of them, shall have power to vacate any part of said road as they shall judge proper, and to lay out the same anew, on such ground as they find better adapted to the making a good road: Provided they do not materially deviate from the general course of the road already laid out, and they shall be held responsible for a just and faithful discharge of the trust reposed in them by this act, and shall settle their accounts with the auditors of the county, in the same manner and at the same time they settle the public accounts of the county, and the report of the said auditors shall be made as in other cases of public accounts, and shall have the same force and effect.

To authorise the Governor to incorporate a company for erecting a bridge over the river Lehigh, at the Water Gap, in Northampton county.

Sect. 1. BE it enacted by the Senate and House of Repre-

sentatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the Commission. same, That David Snyder, Peter Rumble, William Fenstermacker, Stephen Balliet, junior, and Jacob Saegar, of Lehigh county, Thomas Craig, John Snyder, Nicholas Snyder and Jacob Stem, of Northampton county, be, and they are hereby appointed commissioners to do and perform the several duties hereinafter mentioned, that is to say, They shall, on or before the first day of June next, procure at least three books and enter therein as follows: "We, whose names are hereunto subscribed, do promise to pay to the president, managers and company for crecting a bridge over the river Lehigh, at the Water Gap, in Northampton county, twenty-five dollarsfor every share of stock in said company set opposite to our
