CHAPTER CXIV.

AN ACT

To suspend for a time the making certain sections of a state road in Allegheny and Somerset counties, laid out in pursuance of an act of the General Assembly of this Commonwealth, entitled, "An act authorising the Governor to appoint commissioners to view and lay out a state road from Washington through Williamsport and Somerset, to intersect the turnpike road from Harrisburg to Pittsburg," passed the seventeenth day of March, one thousand eight hundred and twelve.

Sect. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same; That the opening or making so much of said state road as passes through Elizabeth township, in Allegheny county, and so much of said road as lies cast of Somcreet, be and the

same is hereby suspended for the term of three years, from and after the passing of this act.

CHAPTER CXV.

A SUPPLEMENT

To the act, entitled "An act providing for the sale of the State House and State House Square in the city of Philadelphia.

WHEREAS by an act passed on the thirteenth day of March in the year of our Lord one thousand eight hundred and fifteen, the commissioners of the county of Philadelphia were required to take charge of the State House in the city of Philadelphia, and to lease the same in the name of the. commonwealth, giving a preference of all the upper part of the house to the proprietor of the museum. And whereas by another act passed on the eleventh day of March eighteen hundred and sixteen, the Governor is authorised to contract with the mayor, aldermen and citizens of Philadelphia for the sale of the said State House and Square with the exception of certain lots; and in pursuance of such power the Goveroor did on the twenty-third day of April in the year last aforesaid, sell to the said mayor, aldermen and citizens of Philadelphia, the premises mentioned, payable in three annual instalments, two whereof have been paid into the Bank of Pennsylvania to the credit of the commonwealth. whereas it has been represented that the commissioners of the county of Philadelphia refuse to deliver up possession of the lower part of the said house to the said mayor, aldermen and citizens of Philadelphia.
