

CHAPTER CXXVI.

AN ACT

Granting to the American Antiquarian Society a copy of the laws and journals of this commonwealth.

SECT. 1. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same,* That the Secretary of the Commonwealth, be, and he is hereby authorised and required to deliver when demanded, to the secretary of the "American Antiquarian Society," of Worcester, Massachusetts, for the use of the said society, or his order, one complete set or copy of the statute laws and journals of the legislature of this commonwealth, or so far as the same can be obtained at the seat of government, free of any charge to the said society whatsoever.

CHAPTER CXXVII.

AN ACT

Making appropriations to defray certain expenses of government therein mentioned, and for other purposes.

SECT. 1. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same,* That for the payment of the expenses hereinafter mentioned, the following sums are hereby appropriated, to wit: For clerk hire in the office of the Secretary of the Commonwealth for one year, two thousand three hundred dollars: For clerk hire in the office of the Secretary of the Land Office for one year commencing on the first of April one thousand eight hundred and eighteen, the sum of three thousand seven hundred dollars, which together with the permanent appropriation of sixteen hundred dollars, may be expended by

Auditor Gen-
eral. said officer in the employment of as many clerks in his office as he may find necessary: For clerk hire in the office of the Auditor General, one hundred dollars in addition to the permanent appropriation of one thousand dollars, and the further sum of eight hundred dollars to pay for the employment of one additional clerk in said office from the first day of April next: For clerk hire in the office of the State Treasurer, two hundred dollars in addition to the permanent appropriation of two thousand and sixty-six dollars and sixty-six cents: For Surveyor General. clerk hire in the office of the Surveyor General, for one year commencing on the first day of April aforesaid, the sum of two thousand two hundred dollars, which together with the permanent appropriation of two thousand dollars for that office, may be expended by the Surveyor General in the employment of as many clerks in his office as he may find necessary: For the employment of an additional clerk in the office of the State Treasurer the sum of six hundred dollars; and the clerk hire aforesaid shall be paid quarterly in the usual manner: To the Auditor General the further sum of fifty-six dollars and sixty-six cents, to pay a debt for extra clerk hire by the Auditor Gen-
eral. eral. for the last year: For contingent expenses in the office of the Secretary of the Commonwealth for one year, two thousand five hundred dollars: For contingent expenses in the office of the Secretary of the Land Office for one year, one thousand dollars: For contingent expenses in the office of the Surveyor General for one year, including the expenses of the board of property, six hundred dollars: For contingent expenses in the Auditor General's office, two hundred dollars in addition to the standing appropriation of four hundred dollars; and the sums hereby appropriated shall be paid by the State Treasurer out of any money in the treasury, previous to which the officers holding the aforesaid offices shall exhibit their accounts and vouchers for said expenditure, to the accountant department to be adjusted and settled.

and paid. **SECT. 2.** *And be it further enacted by the authority aforesaid,* That the Auditor General be, and he is hereby authorized and required to adjust and settle certain accounts of detachments from the first brigade of the fifteenth division, for services rendered guarding British prisoners at Pittsburg; and that he draw his warrant on the State Treasurer in favor of a paymaster who he shall appoint, for such sum of money as he shall find justly due for said services.
