### CHAPTER CXXXIII.

#### AN ACT

Altering the time of holding the courts in the sixth judicial district.

Sect. 1. BE it enacted by the Senate and House of Repre-

sentatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the Sixth judicial same, That from and after the first Monday in August next, district, how organized.

Sixth judicial from and after the first Monday in August next, wisional counties of Erie, Crawford, Mercer, Venango and the provisional county of Warren, shall be and constitute the sixth judicial district, and the several courts of quarter sessions and common pleas shall commence on the following days in each and every year, to wit: In the county of Erie on the said ding courts.

## CHAPTER CXXXIV.

## A FURTHER SUPPLEMENT

To an act, entitled "An act to regulate the trials of contested elections," passed the twenty-ninth day of September, one thousand seven hundred and ninety-one.

Sect. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General

Assembly met, and it is hereby enacted by the authority of the same, That from and after the passage of this act, no order Petition conshall be taken on any petition addressed to the legislature, testing the complaining of an undue election or false return of a person election of elected Governor, or a member of either branch of the legis. Governor, lature, unless presented within five days after the next meeting of the legislature, nor unless five or more qualified election of days, and tors signing such petition, shall take and subscribe an oath or tobe founded affirmation before some judge or justice of the peace, in and on oath or for the county or counties in which they reside, a copy whereaffirmation. of shall accompany and be annexed to such petition, that the facts stated in such petition are true to the best of their knowledge and belief.

SECT. 2. And be it further enacted by the authority aforesaid, That if the facts stated in the petition or petitions as costs shall be aforesaid shall not be established, then the county or counties paid. in which the petitioners reside shall pay the costs; but if the fact or facts stated in such petition or petitions shall be established, then the county or counties in which the facts com-

plained of took place shall pay the costs.

SECT. 3. And be it further enacted by the authority afore-said, That so much of the third section of the act to which Part of form-this is a further supplement, as provides that the committee er act not to to be appointed under the authority of said act shall be dis-be in force. solved, if three members thereof should be absent for more than three days, shall not be in force after the passage of this 9 of the comact, but in case of such an event the remaining members of mittee may the committee (if not reduced to less than nine) shall proceed proceed and to enquire into the facts, and seven of their number shall be 7 decide. competent to decide.

Secr. 4. And be it further enacted by the authority aforesaid, That so much of the other parts of said act and the supplement thereto, passed March sixth, one thousand seven hundred and ninety three, as are hereby altered or supplied, be,
