SECT. 2. *And he it further enacted by the authority aforesaid,* That any person entitled to the benefits of this act, shall be entitled to a patent on payment of the purchase money, together with an advance of twenty per cent. on the amount of the original purchase, together with the interest on the aggregate amount from the time or times when the interest commenced on the original purchase money, and such payment shall be deemed and taken as an equivalent for the conditions of settlement, improvement and residence required by the act to which this act is a supplement.

What payment shall be an equivalent for the conditions of settlement, &c.

CHAPTER CXXXVII.

A SUPPLEMENT

To the act, entitled “An act to enable the Governor to incorporate a company to make an artificial road from the court house in the borough of Lewistown, to Alexander Reed’s in Kishacoquillas valley.

SECT. 1. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same,* That the president and managers of the Lewistown and Kishacoquillas turnpike road company, be, and they are hereby authorised to make and extend the said turnpike road from Alexander Reed’s tavern to the division line between the counties of Huntingdon and Mifflin, and for that purpose to increase their capital stock by additional subscriptions, in such manner as to them may seem expedient for the purpose of making said road, and that they shall have like powers, authorities and privileges, and be subject to all the duties, qualifications, fines, forfeitures, and be entitled to receive and

collect like tolls and profits as are granted to them by the act to which this is a supplement.

CHAPTER CXXXVIII.

A SUPPLEMENT

To the act, entitled “An act to incorporate and endow an Academy or Public School in the borough of Reading, in the county of Berks.

WHEREAS by the act to which this is a supplement, five thousand acres of land, together with six per centum allowance for roads, was granted to the Reading Academy to be laid out, surveyed and patented free of expense. And whereas it is represented by the trustees of the said academy that owing to a mistake of the deputy surveyor five thousand four hundred and forty-eight acres and eighty-one perches of land, have been surveyed and returned on warrants taken out in pursuance of the said grant, and that the officers of the land office conceive they have not the power to grant a patent for the same.

Therefore,

SECT. 1. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same,* That the officers of the land office be, and they are hereby authorised and required to accept of the surveys made for the Reading Academy, on warrants issued in pursuance of the act to which this is a supplement, and deliver a patent for the land contained therein to the trustees of the Reading Academy on demand, free of expense.
