#### AN ACT

Divorcing Vachel Stephens and Rachel his wife from the bonds of matrimony.

SECT. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That the marriage contract entered into between Vachel Stephens and Rachel his wife, late Rachel Peairs, of Fayette county, be, and the same is hereby dissolved, and the parties respectively set free and apart from all duties and obligations arising from said contract, as fully and effectually as if they had never been joined in marriage.

## CHAPTER XXXVIII.

#### AN ACT

Incorporating the Western University of Pennsylvania.

WHEREAS the happiness and prosperity of every community (under the direction of Divine Providence) depend greatly on the proper education of youth.

And whereas by the petition of a respectable number of the inhabitants of the western parts of this commonwealth, it appears that the institution of an university near the town of Allegheny, in the county of Allegheny, for the instruction of the rising generation, would highly promote the best interests of the state, and in part fulfil an important constitutional injunction.

And whereas the trustees of the Pittsburg academy, by memorial have represented that institution though in a respectable state of improvement, as inadequate to the accommodation and complete education of the students at present And have expressed their desire attending that seminary. that a university should be established in their vicinity, and that the funds of the academy may be transferred for the use of such university.

# Therefore,

Sect. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That there shall be erected and established near the town of Allegheny, in the county of Allegheny, an university for the education of youth in the learned and foreign languages, the useful arts, sciences and literature, by the name and style of "The Western University of Pennsylvania;" the Constitution. constitution whereof shall be, and is hereby declared to be as is hereinafter mentioned and defined, that is to say:

issues, profits, income and interest of the same, and to apply the same to the proper use and support of the said university. And by the same name to sue, commence, prosecute and defend, implead and be impleaded in any court of law or equity, and in all manner of suits or actions whatsoever; and generally by and in the same name to do and transact all and every the business, touching or concerning the premises, or which shall be incidentally necessary thereto, as fully and effectually as any body politic or corporate within this commonwealth have power to manage their own concerns. And to hold, enjoy and exercise all such powers, authorities and jurisdiction as are customary in other universities in the United States of America.

III. That the said trustees shall cause to be made for their Common use, one common seal, with such devices and inscriptions seal, thereon as they shall think proper, under and by which all deeds, diplomas, certificates and acts of the said corporation shall pass and be authenticated, and the same seal at their pleasure to break and devise a new one

IV. That the said trustees shall meet at the town of Alle-Meeting of gheny on the third Monday of May next, for the purpose of trustees. concerting such measures as they may deem correct in consequence of this act, with power to adjourn to such time and place as they shall see cause, notice thereof being given in one or more of the newspapers published in the city of Pittsburg. And a majority of such board shall be capable of doing and Majority catransacting all the business and concerns of the institution; pable of maparticularly of making and enacting ordinances, rules or king rules, regulations for the government of the said university; of &c. electing trustees in the place or stead of those who shall resign their places, or who shall die; of electing and appointing the principal and professors of the said university; of fixing their salaries and emoluments and removing them for misconduct; of appointing committees of their own body to carry into execution the resolutions of their own board; of appointing a secretary, treasurer, librarian, stewards, mana. Appointing gers, auditors and other necessary officers for the care and officers. management of the property of the institution: Provided, Proviso. That no ordinances shall be of force repugnant to the constitution and laws of this state or of the United States.

V. No person acting as principal or professor shall be capable of the office of trustee of this institution.

VI. The principal and professors or a majority of them, shall be styled "The Faculty of the University," which fac-Faculty, ulty shall have the power of enforcing the regulations for the government of the pupils, by rewarding or censuring them, Theirpower, and finally by suspending such of them as shall continue refractory, until the determination of the trustees can be had. And of granting and confirming by and with the approbation of the trustees, signified by their mandamus, such degrees in

the liberal arts and sciences, to such pupils of the university or others, distinguished for their proficiency or merit, as they shall think worthy of such degrees, as are usually granted and conferred in other universities in the United States of America; and to grant to such graduates, diplomas or certificates under their common seal and signed by the faculty, to authenticate and perpetuate the memory of such graduation.

VII. Persons of every religious denomination shall be capable of being elected trustees, nor shall any person either as principal professor or pupil, be refused admittance for his conscientious persuasion in matters of religion: Provided,

Sect. 2. And be it further enacted by the authority aforesaid, That no misnomer of the said corporation shall defeat or annul any gifts, grants, devise or bequest, to, or from the not to annul said corporation, provided the intent of the parties shall sufficiently appear upon the face of the gift, grant, will or other writing, whereby any estate or interest was intended to pass to or from the said corporation; nor shall any disuse or nonnot to create user of the rights, liberties, privileges, jurisdictions and au-

thorities hereby granted to the said corporation or any of them, create or cause a forfeiture thereof.

SECT. 3. And be it further enacted by the authority aforesaid, That forty acres of the vacant lands belonging to the commonwealth, bounded by or adjoining the out lots of the town of Allegheny, be, and they are hereby granted to the trustees of "The Western University of Pennsylvania," to be forthwith laid off in one entire body, in such part as the trustees shall designate upon which the University shall be erected; to have and to hold the same to them and their successors forever. And upon the application of any person duly authorised by the said trustees, to the deputy surveyor of Atlegheny county, he shall survey or cause to be surveyed the lands as aforesaid, and make return thereof, and thereupon a Patent there- patent shall be granted, free of expense, to the trustees of "The Western University of Pennsylvania," in the usual manner and form under the laws of this state in such case made and provided.

Sect. 4. And be it further enacted by the authority aforesaid, That the trustees of the Pittsburg academy be authoriestate author. sed, and they are hereby empowered to transfer and convey all the estate real, personal and mixed of the said academy, to the trustees of "The Western University of Pennsylvaised. nia," and their successors and assigns for ever, for the use of the said University.

SECT. 5. And be it further enacted by the authority afore-Oath, &c. ta-said, That the trustees of "The Western University of Penncers of the in-sylvania," and their successors, the principal professors, and all other officers of the said institution, before they enter on their duties, shall each, and every of them take and subscribe stitution.

## CHAPTER XXXIX.

## AN ACT

Authorising the guardians of the minor children of William Hutchison, deceased, to execute a conveyance to James Todd.

WHEREAS it has been represented to the legislature that Robert Hutchison did sell unto James Todd, one hundred and two acres of land with the usual allowance, situate in Centre township, Indiana county, adjoining lands of James Kelly, James McLain, and others, surveyed on a warrant in the name of John Hutchison, and that William Hutchison, at, and immediately before the time of his decease, was seized of an equal undivided moiety or half part of said land; that said William Hutchison died intestate, leaving several children who are now in their minority, to whom the said moiety of land descended in equal parts, that the sale is deemed fair and advantageous to the parties concerned, and it is their wish to have the sale confirmed.

#### Therefore,

Sect. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That the guardians of the minor children of William Hutchison, deceased, be, and they are hereby authorised and empowered to make and execute a good and sufficient title in the said minor children are entitled, of one hundred and two acres of land, more or less, with the usual allowance, situate in Centre township, Indiana county, adjoining lands of James Kelly, James M'Lain and others, surveyed on a warrant in the name of John Hutchison: Provided, The said James
