AN ACT

Sect. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That all the estate and interest derived by virtue of any escheat, for want of heirs or known kindred, capable of inheriting the estate of Thomas Laughlin, late of the county of Franklin, deceased, in and to the estate, real and personal, whereof the said Thomas Laughlin died, seized and possessed, be, and the same is hereby vested in John Boyles and Agnes his wife, their heirs and assigns, forever: Provided, That nothing in this act contained, shall be construed to prejudice or defeat the right of any other individual or individuals.
