BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That George Baird, John Marshell, James Clerk, Thomas M'Call, David Craig, Daniel Huston, Robert Hervey and David T.
