And be it further enacted by the authority aforesaid, That before the said banks or companies shall be enabled to recover under this act, it shall be the duty of the said banks or companies, to give security to the court of common pleas, of Fayette county, in such sum and in such manner, as the said court may think proper to require, for the faithful payment and redemption of all the notes by them issued: Provided, That nothing herein contained, shall be so construed as to enable the said banks or companies, to recover any debt contracted by any future loan or accommodation.

CHAPTER XCII.

BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the Before whom same, That all bargains and sales, deeds, conveyances and other instruments of writing, concerning any lands, tenements or hereditaments within this state, that may hereafter be made out of this state, the execution whereof, being duly acknowledged by the party or parties executing the same, or proved by the oath or affirmation of one or more of the subscribing witnesses thereto, before one of the judges of the supreme court of the United States, or before a judge of the district court of the United States, or before any one of the judges or justices of the supreme or superior courts or courts of common pleas, of any state or territory within the United States, and so certified under the hand of the said judge and seal of the court, shall be as valid, to all intents and purposes, and shall have the like effect, and be in like manner entitled to be recorded, as if the same had been made, acknowledged or proved, and certified in conformity with any law of this commonwealth. And in the In the case of case of a feme covert, the said judges and justices respect a feme covert tively, shall be, and they are hereby authorised to take her acknowledgment and separate examination, and to certify the same, with the same effect as any judge, justice, or officer now authorised by law, to that effect may or can do.
