SECT. 3. And be it further enacted by the authority aforesaid, That if any person or persons, in the city or counties Penalty for aforesaid, shall use for the measuring of lime, a bushel of any using a bushother dimensions, or not stamped as is hereinbefore directed, el of other dihe or they shall forfeit and pay the sum of five dollars for mensions or every such offence, to be recovered before any alderman or not stamped, justice of the peace, upon due proof to him made, in the same manner that debts of the like sum are recoverable, to be paid to the treasurer of the county wherein the offence was committed, for the use of the county.

## CHAPTER XCVIII.

## AN ACT

To authorise the printing of the Pamphlet Laws of this commonwealth.

SECT. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That the Secretary of the Commonwealth, be, and hereby is authorised and required, to contract for the printing of three thousand copies of the laws of the three succeeding sessions of the legislature, on the best and most advantageous terms for the commonwealth, not to exceed the rate of fifty dollars per sheet, of sixteen pages, exacting a sufficient secu-

rity for the faithful performance of the said contract, to be printed in octavo form, on paper number two of a medium size, with a good long-primer type, each page to contain not less than eighteen hundred m's, including the marginal references; and the execution of the work generally to correspond with the pamphlet editions of the laws lately published by Jacob Elder, each of said copies to be stitched and covered in pamphlet form, and to be delivered at the office of the Secretary of the Commonwealth, at Harrisburg, within forty days after the close of each session of the legislature, in each and every year.
