CHAPTER CVIII.

AN ACT

To prevent the removal of flag staffs, beacons or buoys in any of the navigable streams within this commonwealth.

Penalty for

SECT. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That if any person or persons shall wilfully or maliciously take down, injure, remove, or in any manner damage injuring, &c. or destroy any flag, flag staff, beacon, buoy, or other way flags, buoys, marks, or water maks, which now are or hereafter may be &c. in navigable streams. put up, erected, or placed in any of the streams that are or may be declared public highways within the jurisdiction of this commonwealth, under the direction or by order of any commissioners appointed, or hereafter to be appointed to superintend the expenditure of any appropriation made by the legislature for the improvement of the navigation of any of the said streams, shall upon due proof made in the usual manner before any court of quarter sessions having competent jurisdiction, and on conviction thereof forfeit and pay for every such offence, any sum not less than twenty dollars nor more than two hundred dollars, and be liable to imprisonment for any period not exceeding six months; and the fines and forfeitures so accruing shall be paid into the treasury of the proper county, and so much thereof as will be necessary to replace or repair the flag, flag staff, beacon, buoy
