AN ACT

Making appropriations to defray certain expenses of government therein mentioned.

Sect. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the Clerk hire in same, That for the payment of the expenses hereinafter menthe offices of tioned, the following sums are hereby appropriated, viz. for the Secretary clerk hire in the office of the Secretary of the Commonwealth, of the Comfor one year, two thousand three hundred dollars; for clerk monwealth, Auditor Gen- hire in the office of the Auditor General, nine hundred dollars, in addition to the permanent appropriations of one thou-Treasurer, sand dollars, and a further sum of thirty-eight dollars and Secretary of eighty cents, to pay a debt for extra clerk hire for the last the Land Office and Sur-year; for cierk hire in the office of the State Treasurer, eight veyor Gener hundred dollars, in addition to the permanent appropriation of two thousand and sixty-six dollars and sixty-six cents, for clerk hire in the office of the Secretary of the Land Office, for one year, commencing on the first of April, one thousand eight hundred and nineteen, the sum of three thousand seven hundred dollars; which, together with the permanent appropriation of sixteen hundred dollars, may be expended by said officer in the employment of as many clerks in his office as he may find necessary; for clerk hire in the office of the Surveyor General, for one year, commencing on the first of April aforesaid: the sum of two thousand two hundred dollars; which, together with the permanent appropriation of two thousand dollars for that office, may be expended by the Surveyor General, in the employment of as many clerks in his office, as he may find necessary; and the clerk hire aforesaid, shall be paid quarterly, in the usual manner; for contingent expenses, in the office of the Secretary of the Commonwealth, for one year, two thousand five hundred dollars; for contingent expenses in the office of the Secretary of the Land Office, for one year, one thousand dollars; for contingent expenses in the office of the Surveyor General, for one year, including the expenses of the board of property, six hundred dollars; for contingent expenses in the Auditor General's office, two hundred dollars, in addition to the standing appropriation of four hundred dollars; and the sums hereby appropriated shall be paid by the State Treasurer, out of any money in the treasury, previous to which, the officers holding the aforesaid offices, shall exhibit their accounts and vouchers

CHAPTER CXIII.

A SUPPLEMENT
