CHAPTER CXXI.

AN ACT

To prevent the fishing with Seines in certain streams of water, and to increase the penalty for fishing in the river Susquehanna, on days prohibited by law, and for other purposes.

Sect. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That from and after the first day of August next, any person or persons, who shall draw any seine or brush net, or shall be aiding or assisting therein, in the waters of Penns seine, &c. or creek, below the mouth of Sinking creek, and above the mouth of Pine creek, in Centre county, shall pay a fine of five dolcertain parts lars for every such offence, to be recovered as debts of equal amount are by law recoverable, on being legally convicted thereof, on the testimony of one or more credible witnesses, before any justice of the peace of said county, one moiety

And be it further enacted by the authority aforesaid, That from and after the passage of this act, any person Additional or persons who shall cast or draw, or direct, permit or aid, fishing bethe casting or drawing of any seine or net, between the first tweencertain day of April and fifteenth day of June, in each and every periods, &c. year, in the river Susquehanna, between the Maryland line and the forks of the aforesaid river, near the town of Northumberland, on the days prohibited by law, shall forfeit and pay (in addition to the penalty already provided by law) the sum of two thousand five hundred dollars, to be recovered in the same manner, and applied to the same purposes, as the penalties already imposed are to be recovered and applied.
