

tion, to be administered as aforesaid, that the share or shares of stock, standing in his name is, or are really his own, and not by him held in trust for any other person or persons.

SECT. 3. *And be it further enacted by the authority aforesaid,* That the stockholders of the Farmers and Mechanics bank of Pittsburg, shall be, and they are hereby authorised at their next election, for directors of said bank, and annually thereafter, during the existence of the charter thereof, to choose from amongst the stockholders of said bank, six persons as directors, who are not by occupation mechanics or farmers; and that so much of the first section of the act, entitled "An act, Regulating Banks," as is hereby altered, be, and the same is hereby repealed.

CHAPTER CXXIV.

AN ACT

To enable the trustees of four several congregations of Presbyterian or Reformed Churches, in the townships of Cocalico, Earle and Warwick, in the county of Lancaster, to sell and convey certain real estate.

WHEREAS it has been represented to the legislature that a certain John Balmer, of Cocalico township, in the county of Lancaster, and Rachel his wife, sold and conveyed by deed, bearing date the eleventh day of September, seventeen hundred and seventy-nine, and recorded in the office for recording deeds in the county of Lancaster, in book A. A. page 292, a certain plantation or tract of land situate in the township of Cocalico, in the county aforesaid, containing one hundred and twenty-eight acres and allowance, unto Adam Krill, Peter Fanghauser, John Miller and others therein named, elders and trustees of four several congregations of the Presbyterian or Reformed Churches, in the townships of Cocalico, Earle and Warwick; to have and to hold to the said Adam Krill and others, their heirs and successors, for the use and behoof of the aforesaid four several congregations, as a glebe

for the minister of the gospel for the time being. And whereas it is also represented to the legislature, that through the lapse of time, the old churches belonging to the congregations aforesaid became decayed, and required expensive repairs, to effect which, considerable appropriations have been made and debts incurred. And whereas also, the trustees, elders and members of the said several congregations, have petitioned the legislature for leave to dispose of forty acres of the aforesaid tract of land, for the purpose of enabling them to pay and satisfy the debts incurred by reason of the aforesaid repairs, leaving in the opinion of the petitioners, a sufficient quantity for the use of the minister.

SECT. 1. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That Matthias Shirk, Adam Grill, Christian Wolf and Jacob Rock, or a majority of them, be, and they are hereby authorised and empowered to sell and convey in fee simple, forty acres of wood land, be the same more or less, situate in Cocalico township, in the county of Lancaster, bounded on the north-east by the Downingstown and Ephrata turnpike, adjoining lands of William Senseman and others, being a part of a tract of land containing one hundred and twenty-eight acres and allowance, sold and conveyed by John Balmer, of Cocalico township, in the county of Lancaster, and Rachel his wife, by deed, bearing date the eleventh day of December, seventeen hundred and seventy-nine, to Adam Grill, Peter Fanghauser and others, elders and trustees of four several congregations of Presbyterian or Reformed Churches, in the townships of Cocalico, Earle and Warwick, their heirs and successors, to and for the use and behoof of the aforesaid several congregations, as a glebe for the minister for the time being.*

Monies how
distributed.

SECT. 2. *And be it further enacted by the authority aforesaid, That the monies arising from the sale of the aforesaid forty acres of land, shall be divided into four equal parts and distributed by the aforesaid Matthias Shirk, Adam Grill, Christian Wolf and Jacob Rock, the survivors or survivor of them, among the trustees for the use of the four several congregations aforesaid, share and share alike.*
