names of the persons so elected to the next court of general quarter sessions holden in said county, one of whom shall be appointed by the judges of said court constable for said borough, in the same manner with like power and authority, and subject to the same regulations and penalties as are contained in the laws now existing, or that may hereafter exist respecting constables in this commonwealth, and the constable elected by the citizens of the said borough for the year one thousand eight hundred and nineteen, is hereby authorised and required to give the previous notice, and to hold the first election in the said borough in pursuance of this act; and so much of any law of this commonwealth as is hereby altered or supplied, be, and the same is hereby repealed.

### CHAPTER CXL.

### AN ACT

Authorising the trustees of the Lutheran Congregation of Springfield, in the county of Bucks, to sell and convey certain real estate.

WHEREAS it appears that the Lutheran Congregation of Springfield township, in the county of Bucks, by virtue of an indenture duly executed by Elias Biddleman and Anna Maria his wife, bearing date the first day of August seventeen hundred and sixty-eight, became seized and possessed of a certain lot or piece of land situate in the said township, containing one acre and one hundred and thirty-six perches, and being desirous to sell the same for the benefit of the said congregation.

# Therefore,

SECT. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That Paul Apple and Michael Barnet, trustees of the

Lutheran Congregation of Springfield township in the county of Bucks, be, and they are hereby authorised to sell and convey a certain lot or piece of land containing one acre and one hundred and thirty-six perches be the same more or less, situate in the township aforesaid and bounded by lands of Elias Biddleman, Casper Heiter and others: *Provided*, That the proceeds of the sale of the said lot of land be applied to the use and benefit of the said congregation.

### CHAPTER CXLI.

### AN ACT

To authorise the managers of certain turnpike roads to apply the surplus tolls to the extinguishment of debts heretofore by them incurred.

SECT. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That the surplus tolls arising annually from the Perkiomen and Reading Turnpike road, after deducting the necessary and unavoidable expenses of the corporation, be, and they are hereby indefeasibly vested in those persons who are now or hereafter may be bound in their individual capacities for the payment of the debts by them heretofore incurred, until the same shall be fully satisfied, or the said individuals be otherwise exonerated.

SECT. 2. And be it further enacted by the authority aforesaid, That no officer or officers chosen by the stockholders of the corporation of said turnpike road, at any future election held in pursuance of the act to which this is a further supplement, shall be entitled to enter on the discharge of the duties of his office, until he or they shall have released his predecessor in office from all personal liability on account of the debts above mentioned, or shall have given bond with se-

curity to the Governor of this commonwealth in the sum of three thousand dollars each, conditioned for the appropria-
