CHAPTER XXIX.

A SUPPLEMENT

To an act, entitled "An act appointing commissioners for exploring a route for opening a direct communication from the town of Milford, in the county of Pike, to the borough of Wilkesbarre, in the county of Luzerne.

SECT. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That the surveying, marking and laying out a road beginning at the town of Milford, in the county of Pike, and from thence to the borough of Wilkesbarre, in the county of Luzerne, by Isaac A. Chapman and John Broadhead, two of the commissioners appointed by the act to which this is a supplement, be and the same is hereby confirmed as fully and effectually as if all three of the commissioners named in said act had been present at the surveying and marking thereof, and in the same manner as if the road had been surveyed, marked and laid out before the first day of August last, and that the said commissioners shall be entitled to receive the same compensation for their services, and for the hands necessarily employed by them in running and marking said road. from the treasurers of the counties of Wayne, Pike and Luzerne, as is provided in and by the second section of the act to which this is a supplement.

CHAPTER XXX.

AN ACT

To authorise John Agnew and others, guardians of their minor children to sell and convey certain real estate in Washington county.

Sect. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the

same, That it shall and may be lawful for John Agnew, James Agnew, Samuel Agnew, Robert Marshell and Robert Anderson, the parents and natural guardians of their children, Samuel C. Agnew, Samuel A. Marshell, Samuel Agnew, Samuel M. Agnew and Samuel A. Anderson, the survivors or survivor of them, to grant, bargain and sell for the best price that can be obtained to any person or persons, their heirs and assigns, all the estate, right and title of their minor children aforesaid, in and to the real estate in Washington county, devised to them by their grandfather, Samuel Agnew, and to execute, seal and deliver, and in due form of law acknowledge such conveyance and assurances of the said real estate unto the purchaser or purchasers thereof, their heirs and assigns forever, as shall be requisite, in as full and ample a manner as the said children could if they were of full age: Provided, That the said John Agnew, James Agnew, Samuel Agnew, Robert Marshell and Robert Anderson shall enter into recognizance in the orphans' court of the county of Washington with sufficient sureties to the satisfaction of the said court, conditioned that the proceeds of the sale of the said real estate shall be invested in other real estate at least equally valuable or in some profitable stock for the use and benefit of the minors aforesaid respectively.
