

Power to enter in and upon lands.      ments and inclosures, in, through and over which the said intended turnpike road may be thought proper to pass, and examine the ground most proper for the purpose, as well as the materials in the vicinity that may be necessary in making and constructing the said turnpike road, and to survey, lay down, ascertain, mark and fix such route or track for the said road, as in the best of their skill and judgment will combine shortness of distance with the most practicable ground from or near the house of Philip Swartz, in Providence township, Luzerne county, the nearest and best route to intersect the Milford and Owego turnpike road where it crosses the Wallen-Paupack creek, in Wayne county, passing through the townships of Blakely, Salem and Palmyra, and generally they shall have like powers, authorities and privileges necessary for carrying on and completing the said turnpike road, and be subject to all the duties, qualifications, restrictions, penalties, fines and forfeitures, and be entitled to like tolls and profits in proportion to the distance as are given and granted to the president, managers and company of the Coshecton and Great Bend turnpike road: *Provided*, That if the said company shall not proceed to carry on the said work in five years after the passing of this act, or shall not within ten years afterwards complete the said road according to the true intent and meaning of this act, then and in either of these cases it shall and may be lawful for the Legislature of this Commonwealth to resume all and singular the rights, privileges, liberties and franchises by this act granted to the said company.

## CHAPTER XXXII.

### *AN ACT*

For the relief of Peter Gordon, an old soldier.

SECT. 1. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That the State Treasurer be and he is hereby required*

to pay to Peter Gordon of the district of Southwark, in the county of Philadelphia, or to his order, forty dollars immediately after the passing of this act, and an annuity of forty dollars during life, to be paid half yearly, to commence on the first day of January, one thousand eight hundred and twenty.

CHAPTER XXXIII.

*AN ACT*

To authorise the president, managers and company, for erecting a bridge over the Susquehanna river, in the county of Lancaster, at or near the town of Columbia, to recover debts due to them and for other purposes.

SECT. 1. *BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same,* That from and after the passage of this act, the president, managers and company for erecting a bridge over the Susquehanna river, in the county of Lancaster, at or near the town of Columbia, shall have the same remedy by suit or action which is given by law to any bank, association or individual, for the recovery of any debt or sum of money due to said company, from any company, individual or individuals who may have procured accommodation of or from said company, whether the note, bond or other evidence of debt be made payable to said president, managers and company for erecting a bridge over the Susquehanna river, in the county of Lancaster, at or near the town of Columbia, or to any officer or individual in behalf of the same.

SECT. 2. *And be it further enacted by the authority aforesaid,* That the president, managers and company for erecting a bridge over the Susquehanna river, in the county of Lancaster, at or near the town of Columbia, their assignee or assignees shall at all times be bound to receive the notes issued by them, in payment of any debt or sum of money due to said company, their assignee or assignees, whether tendered by any
