## CHAPTER XCV.

## AN ACT

Altering the times of holding the Courts in the Fifth Judicial District.

SECT. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That from and after the next holding the Courts of the Fifth Judicial District of this Commonwealth, the said Courts shall commence and be held as follow, to wit: In the county of Butler on the first Mondays of January, April, July and

October; in the county of Beaver on the second Mondays of January, April, and the fourth Mondays of August, and the third Mondays of October; and in the county of Allegheny on the third Mondays of January, April, and first Mondays

of August and November.

SECT. 2. And be it further enacted by the authority aforesaid, That so much of the act passed the twenty-ninth day of March, eighteen hundred and nineteen, entitled "A supplement to an act, entitled An act-to establish a Fourteenth Judicial District, and for other purposes," as is hereby altered or supplied, shall be and the same is hereby repealed.

## CHAPTER XCVI.

## AN ACT

To revive certain acts in relation to the Lock Navigation of the waters of Brandywine creek.

Former act revived.

Commission-

SECT. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That the act, entitled "An act to enable the Governor of this Commonwealth to incorporate a company for opening a canal and lock navigation on the waters of Brandywine creek," passed the tenth day of April, seventeen hundred and ninety three, and a supplement thereto, passed the twenty-first February, seventeen hundred and ninety-five. be, and the same are hereby revived, except that part of the first section of the first named act, which names the commissioners: And the aforesaid acts are declared to be in as full force and virtue as if the provisions of the same were herein recapitulated and re-enacted, any thing in the said acts to the contrary in anywise notwithstanding.

SECT. 2. And be it further enacted by the authority aforesaid, That to supply the places of the aforesaid commissioners, John Pimm, Abraham Bailey, Thomas A. Parke, Charles Lukens and Caleb Brinton, junior, of the county of Chester,
