CHAPTER CLII.

AN ACT

To authorise the laying out of a state road from Mount Pleasant in Westmoreland county, to intersect the national road east of Washington in Washington county.

SECT. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That Ephraim Estep and James Wier, of Washington Commission. county, and Charles Fulwood, of Westmoreland county, be, ersappointed and they are hereby appointed commissioners to view, lay to lay out and out and mark a state road from the town of Mount Pleasant, mark a state in Westmoreland county, through Bellvernon and Bentleys Mount Pleasant, road from ville to intersect the national turnpike not further east of sant, &c, Washington than the house of Peter Dager, by the nearest and best route, so that the ascent and descent of said road shall not exceed five degrees from a horizontal line.

Sect. 2. And be it further enacted by the authority aforesaid, That it shall be the duty of the said commissioners. before they enter upon the duties required of them by this To be under act, to take and subscribe an oath or affirmation before some oath, &c. justice of the peace faithfully and impartially to perform the duties enjoined upon them by this act, and shall receive one dollar and fifty cents for each day they shall necessarily be Their comemployed in said work, together with a reasonable allowance expenses for chain carriers; and the accounts of said commissioners how paid. shall be adjusted and settled by the commissioners of the counties through which said road shall pass, and the expenses shall be paid by the respective counties in proportion to the distance said road shall pass through the same, the money to be paid by warrants drawn by the commissioners of the respective counties and paid by the treasurer.

SECT. 3. And be it further enacted by the authority aforesaid, That it shall be the duty of said commissioners, after performing the duties required of them by this act, to make out a draft of said road to be deposited in the office of the Draft of the Secretary of the Commonwealth, and shall also deposit a copy made, and of said draft in the office of the clerk of the courts of quarter where deposessions of the respective counties through which said road sited. may pass, which shall be a record thereof, and from thenceforth the said road shall be to all intents and purposes a public highway, and shall be opened and repaired in all respects as other roads are opened and repaired which are laid out by order of the courts of quarter sessions of the counties aforesaid; and the commissioners appointed by this act shall per-

form the duties required of them before the first day of October next.

CHAPTER CLIII.

A FURTHER SUPPLEMENT

To the act, entitled "An act for the consolidation and amendment of the laws as far as they respect the poor of the city of Philadelphia, the district of Southwark, and the township of the Northern Liberties, and for other purposes."

SECT. 1. BE it enacted by the Senate and House of Repre-

Philadelphia, the district of Southwark, and township of the notto be con- Northern Liberties, to be directly or indirectly concerned in cerned in any any contract for the supply or delivery of any article of goods, wares, merchandize, food, or other thing intended to be used or consumed in the alms house, house of employment, or children's asylum; and if any such guardian shall be convicted before any alderman or justice of the peace, of having been directly or indirectly concerned or engaged in any such contract, he shall pay a fine of one hundred dollars for the use of the poor of the city of Philadelphia, the district of Southwark, and township of the Northern Liberties, to be recovered as penalties are now recovered for offences under the jurisdiction of justices of the peace.

SECT. 2.
