## AN ACT

SECT. 1. *Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same,* That the State Treasurer be and he is hereby authorised and required to pay to Catharine Currey, of Allegheny county, the widow of a revolutionary soldier, or to her order, forty dollars, as a gratuity. <sup>\$40 gratuity granted.</sup>

## A SUPPLEMENT

To an act entitled "An act reviving an act incorporating the borough of Waynesburg, and changing the name thereof to Waynesboro," approved the twenty-fifth January, one thousand eight hundred and thirty-one.
