## RESOLUTION

Relative to the use of Anthracite Coal in Locomotive Steam Engines.

WHEREAS, Lewis Teese has invented the model of a boiler for the purpose of burning anthracite coal in locomotive engines ;

Therefore,

*RESOLVED, By the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, That the canal commissioners be, and are hereby authorized, if they deem it expedient, to prepare an engine, according to the plan proposed by Lewis Teese, for the pur-*

pose of testing the utility of his boiler, constructed to burn Canal Com's anthracite coal as fuel in locomotives. And the said canal commissioners are hereby further authorized, if they deem it expedient, to contract with Philip Garrett and his associates, or others, for the alteration and management of a portion of the locomotive power on the Philadelphia and Columbia rail road, by the use of anthracite coal for fuel. *Provided*, The same can be done at a less cost than at present.
