AN ACT

To enable the court of common pleas of Susquehanna county to grant a new trial in a certain case therein named.

SECTION 1. *Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That it shall be lawful for the court of common pleas of Susquehanna county, upon cause shewn, to grant a new trial in a certain case tried in the said court, in which David Taylor was plaintiff, and Amos Taylor, defendant, wherein a verdict was rendered for the defendant.*

AN ACT

To authorize the adjutant general to furnish arms to the Covington Guards; and to exempt the Bethlehem Artillerists, in the county of Northampton, and the Exeter Rifle Rangers, of Berks county, from parading with the militia; relative to the Schuylkill Valley navigation and railroad company; and to a school district in Cambria county.

SECTION 1. *Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That the adjutant general is hereby authorized and directed to furnish, out of any unappropriated arms and accoutrements, upon the requisition of the proper brigade inspector, to the company styled the Covington Guards, attached to the volunteer battalion, in the bounds of Tioga county, the second brigade, ninth division, Pennsylvania militia, under such regulations and restrictions as are now provided by law.*

SECTION 2. That the volunteer company, organized and known by the name of the Bethlehem Artillerists, in the county of Northampton, and the Exeter Rifle Rangers, of Berks county, shall from and after the passage of this act, be exempted from parading or drilling with any

regiment or battalion, except at the discretion of said company : *Provided*, That the above named company shall meet the proper number of days required by law, in their companies' capacity.

SECTION 3. That the time in which the second track of the railroad Schuylkill Valley navigation and railroad company, between Middleport and Tuscarora, is required to be completed by the act, entitled "A supplement to the several acts incorporating the Schuylkill Valley navigation and railroad company," approved the twenty-fourth day of January, one thousand eight hundred and forty-five, be and the same is hereby extended until the twenty-fourth day of March, one thousand eight hundred and fifty-three, or until the quantity of coal transported over that section of the road exceeds three hundred thousand tons per annum.

SECTION 4. That the farms and residences of the following persons, citizens of the township of Allegheny, in the county of Cambria, viz: H. P. Gallagher, Bryan Manoy, Peter Forester, John Crous, John B. Myers, James G. Carroll, Francis J. Cochran, John C. Cook, John P. Stevenson, Patrick B. Lynch, Thomas P. Mathews, Patrick A. Demsey, James A. Orwin, Michael Kelly, Thomas Kelly, Samuel M'Mullen, Augustus Walters, Mark M'Glaughlin, Daniel Kearney and Daniel Miller, be and the same are hereby annexed to the school district composed of the borough of Loretto, in said county, for school purposes.

AN ACT

To incorporate the Rio del Norte turnpike road company.

SECTION 1. *Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same*, That William F. Dutcher, Martin D. Graham, Moses Brink, P. V. M'Carty, Jacob Kimble, Joseph Kimble, John A. Tinsman, Abraham Shimer, Daniel Decker, James Lord, William Roberts and Esben Roberts, or a majority of them, all being citizens of the county of Pike, be and they are hereby appointed commissioners to open books, receive subscriptions and organize a company, by the name, style and title of "The Rio del Norte turnpike road company," with power to construct a turnpike road, commencing at or near the mouth of the Lackawaxen river, Location.
