CHAPTER LXII.

A SUPPLEMENT to the act, entitled "An act to authorise the governor to incorporate a company to erect a toll bridge over Big Beaver creek, at or near Wolf lane, in the county of Beaver."

Sect. 1. CHAPTER LXIII.

An ACT making further provision for the support of the Board of Wardens for the port of Philadelphia.

Sect. 1.
