person and to all depositors and other creditors whose claims [have been filed as aforesaid] have been disallowed by the secretary, or excepted or objected to by other depositors, creditors, or stockholders, as well as to those depositors, creditors, or stockholders, who have objected to the account or to claims allowed in the account. Said notice shall also set forth that all parties whose claims are disputed or objected to must appear at said time and place and prove their claims or be debarred from coming in upon the fund for distribution.

To amend sections two hundred and twenty, two hundred and twentyfive and two hundred and eighty-five of an act, approved the second day of May, one thousand nine hundred and twenty-five (Pamphlet Laws, four hundred forty-eight), entitled "An act relating to fish; and amending, revising, consolidating, and changing the law relating to fish in the inland waters and the boundary lakes and boundary rivers of the Commonwealth"; increasing the resident fishing license fee, and making the county treasurer the agent of the Commonwealth in the collection of license fees.

Section 1. Be it enacted, &c., That section two hundred Fish. and twenty of an act, approved the second day of May, one thousand nine hundred and twenty-five (Pamphlet Laws, four hundred and forty-eight), entitled "An act relating to fish; and amending, revising, consolidating, and changing the law relating to fish in the inland waters and the boundary lakes and boundary rivers of the Commonwealth," is hereby amended to read as follows:

Section 220. Resident Fishing License Fees.—For the Resident fishing purposes of this article every person sixteen years of age license fees. and upward, upon application to any county treasurer within the Commonwealth or to the board and the presentation of proof that he has been a bona fide resident of this Commonwealth for a period of thirty days next preceding his application and was born in the United States or was fully naturalized under the laws of the United States, shall, upon the payment to the county treasurer or the board of a license fee of [one dollar] one dollar and fifty cents for the use of the Commonwealth and a fee of ten cents for the use of the county treasurer, be entitled to the license herein referred to as "a resident fishing license."

Section 2. That section two hundred and twenty-five of Section 225 said act is hereby amended to read as follows:

Section 225. County Treasurer to Be Agent of the Commonwealth—Monthly Payments to State Treasurer—agent of Commonwealth.—The county treasurers of the several counties shall be agents of the Commonwealth for the collection of said license fees. For services rendered in collecting and paying over the same the said agents shall be allowed to retain for their own use the sum of ten cents for each resident Compensation.
