AN ACT

Making it unlawful to counterfeit electric railway car tokens, bus tickets, commercial air vehicle tickets, tickets having a money, commercial or other value; those evidencing the right to admission to games, contests, public exhibitions, theatrical, or other places of amusement; and also making it unlawful to alter, possess, utter, publish, or circulate the same; and providing penalties therefor.

Section 1. Be it enacted, &c., That it is unlawful for any person to make, forge, circulate, publish, transfer, deliver, stamp, print, sign, alter, engrave, or prepare an imitation, counterfeit or duplicate, of any ticket having a money, commercial or other value, or ticket, card, token, pass, or other written, printed, engraved or stamped means of admission to, or evidence of, the right to secure passage on any electric railway car, bus, or commercial air vehicle, or the right to enter any place where games, contests, theatrical performances or other places where public exhibitions are held.

Section 2. It is unlawful for any person to cause or procure to be made, forged, circulated, uttered, published, transferred, delivered, stamped, printed, signed, altered, engraved, prepared, or to aid or assist in the making, forging, circulating, publishing, transferring, delivering, stamping, printing, signing, altering, engraving or preparing, or in causing to be made, engraved, prepared, or printed an imitation, counterfeit or duplicate, of any ticket having a money, commercial or other value, or ticket, card, token, pass, or other written, printed, engraved, or stamped means of admission to, or evidence of, the right to secure passage on any electric railway car, bus, or commercial air vehicle, or the right to enter any place where public exhibitions, games, contests, theatrical performances or entertainment, or other places where public performances are held.

Section 3. It shall be unlawful for any person to have in his or her custody, or his or her possession, any such tickets having a money, commercial or other value, or tickets, cards, tokens, passes, or other written, printed, engraved or stamped means of admission to, or evidence of, the right to secure passage on any electric

Prima facie evidence.	railway, car, bus, or commercial air vehicle, or means of admission to, or evidence of, the right to enter any place where public exhibitions, games, contests, or theatrical or entertainment performances are held, and that possession of such shall be prima facie evidence of the violation of the first and second sections of this act.
Possession of type, plate, etc.	Section 4. It shall be unlawful for any person to have any metallic type, plate, or other substance in his or her possession which may be used by any person in the violation of this act.
Misdemeanor.	Section 5. Any person violating the provisions of this act shall be guilty of a misdemeanor, and, upon conviction, shall be sentenced to pay a fine not exceeding one thousand dollars (\$1,000), or undergo imprisonment not exceeding two years, or both, at the discretion of the court.
Penalty.	
Constitutionality.	Section 6. If any provision of this act is held to be unconstitutional, the decision shall not be construed to affect any other provision of this act. It is hereby declared as the legislative intent that this act would have been adopted had such unconstitutional provision not been included therein.

Repeal.	Section 7. All acts or parts of acts inconsistent with this act are hereby repealed.

AN ACT

To amend section one of the act, approved the twenty-fourth day of June, one thousand eight hundred and ninety-five (Pamphlet Laws, two hundred fifty-eight), entitled "An act relating to and regulating the issue and transfer of certificates of stock by companies incorporated under the laws of this Commonwealth," as amended, by permitting the signatures, countersignatures, and seals thereon in facsimile printed or engraved, when the certificate is signed by a transfer agent or assistant transfer agent and registrar; and permitting the use of certificates bearing the signature or countersignature, or facsimile signature or countersignature, of any officer who has ceased to be such when the certificate is issued.
