AN ACT

Making an appropriation to carry into effect the provisions of an act, approved the tenth day of July, one thousand nine hundred and nineteen (Pamphlet Laws, eight hundred ninety-three), entitled "An act providing for assistance to certain mothers; providing for the appointment of boards of trustees for the several counties of the Commonwealth, and for the appointment of a State supervisor and assistants, and fixing the salaries of such State supervisor and assistants; defining the powers and duties of boards of trustees, including the power of appointing assistants and investigators, and the distribution of funds at their disposal; providing for the apportionment of the State appropriation among the several counties, and requiring counties coming under the provisions of this act to appropriate certain moneys; and providing penalties," as amended.

Section 1. Be it enacted, &c., That the sum of four million one hundred and fifteen thousand and nine hundred and thirty-eight dollars (\$4,115,938) is hereby specifically appropriated, for the two fiscal years beginning the first day of June, one thousand nine hundred and thirty-one, for the purpose of carrying into effect the provisions of the act, approved the tenth day of July, one thousand nine hundred and nineteen (Pamphlet Laws, eight hundred ninety-three), entitled "An act providing for assistance to certain mothers; providing for the appointment of boards of trustees for the several counties of the Commonwealth, and for the appointment of a State supervisor and assistants, and fixing the salaries of such State supervisor and assistants; defining the powers and duties of boards of trustees, including the power of appointing assistants and investigators, and the distribution of funds at their disposal; providing for the apportionment of the State appropriation among the several counties, and requiring counties coming under the provisions of this act to appropriate certain moneys; and providing penalties," as amended.

Section 2. Upon the approval of this act, the State Treasurer, after deducting from the entire amount appropriated for salaries and office expenses and for the unorganized counties, shall divide the balance into two equal parts.

The one part, hereinafter referred to as the second part, shall be held intact for distribution on and after the first day of June, one thousand nine hundred and thirty-two, in the manner hereinafter provided.

The other part shall, upon the approval of this act, be distributed among the several counties organized under the Mothers' Assistance System, according to a budget for each county prepared by the Secretary of Welfare, after taking into consideration the following basis of distribution:

(1) The number of families receiving assistance on the thirty-first day of May, one thousand nine hundred and thirty; (2) in addition, provision for other eligible families which could not be aided from the fund available for the past biennium, the number of additional families needing aid in each county to be determined by the following formula:

In counties where the number of eligible families on the waiting

list the thirty-first day of May, one thousand nine hundred and thirty, was greater than the number representing the average yearly increase of families aided during the biennium ending the thirty-first day of May, one thousand nine hundred and thirty, allowance may be determined by the former number. In counties where the average yearly increase of families aided is the greater number, allowance may be determined by this number rather than by the eligible waiting list. The apportionment to each county shall be based upon the average grant per family prevailing in such county during the year ending the thirty-first day of May, one thousand nine hundred and thirty.

Section 3. On the first day of June, one thousand nine hundred and thirty-two, the State Treasurer shall set aside, out of the second part to each county organized at the beginning of the biennium under the Mothers' Assistance System, a sum equal to that apportioned to it under the preceding section by the Secretary of Welfare, provided the amount so set aside to any county, together with the unexpended balance of the amount apportioned to the county during the first year, shall constitute the State's assistance during the second year to such county.

Section 4. No county shall receive its allotment of the State appropriation, available for any year under the method of distribution provided by this act, unless such county has accepted the provisions of the act of July tenth, one thousand nine hundred and nineteen (Pamphlet Laws, eight hundred ninety-three), as amended, and has placed at the disposal of the board of trustees a sum equal to the amount available from the State appropriation for such year. No county shall receive any sum from the State, under sections two and three of this act, unless such county shall appropriate a like sum for the same purpose.

Section 5. Out of the amount hereinbefore appropriated, the sum of ten thousand dollars (\$10,000), or so much thereof as may be necessary, shall be set apart to be apportioned to the counties heretofore unorganized under the Mothers' Assistance System. At the beginning of the first year of the biennium, the State Treasurer shall set aside for each of the counties unorganized prior to the first day of June, one thousand nine hundred and thirty-one, equal parts of ten thousand dollars (\$10,000). At the beginning of the second fiscal year of the biennium, the State Treasurer shall set aside for the counties which have organized during the first fiscal year the amounts designated by the Secretary of Welfare, who shall, on the first day of June, one thousand nine hundred and thirty-two, reapportion to the counties organizing during the first fiscal year the balance remaining on that date of the sum set aside for the unorganized counties, the reapportionment to be determined by the need as presented by the counties.

Section 6. Out of the amount hereinbefore appropriated, the sum of fifty thousand dollars (\$50,000), or so much thereof as may be necessary, shall be set apart and applied for the payment of the salaries of the State Supervisor of the Mothers' Assistance Fund, and of such assistants, clerks and other employes as may be required for the proper conduct of the work of the supervisor, for the traveling, hotel and other expenses of the supervisor and her assistants,

for the cost of making special investigations, and for incidental contingent and other expenses of every kind and description necessary for the proper administration of the Mothers' Assistance System.

A SUPPLEMENT

To the act, approved the fourth day of May, one thousand nine hundred and twenty-seven (Pamphlet Laws, seven hundred sixty-one), entitled "An act providing for the preparation of plans and specifications, and for the erection of the Eastern State Penitentiary on lands acquired therefor; imposing duties in connection therewith upon the Governor, the Board of Trustees of Eastern State Penitentiary, and the Department of Welfare; and making an appropriation," its amendments and supplements; making an appropriation to the Department of Property and Supplies for the further construction of buildings and facilities, and the purchase of furnishings and equipment for the new Eastern State Penitentiary at Graterford, and the development of the grounds thereof.

Section 1. Be it enacted, &c., That the sum of three million dollars (\$3,000,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Property and Supplies for the construction of buildings and facilities and the purchase of furnishings and equipment for, and the development of the grounds of, the new Eastern State Penitentiary, at Graterford, now in course of construction under the act, approved the fourth day of May, one thousand nine hundred twenty-seven (Pamphlet Laws, seven hundred sixty-one), entitled "An act providing for the preparation of plans and specifications, and for the erection of the Eastern State Penitentiary on lands acquired therefor; imposing duties in connection therewith upon the Governor, the Board of Trustees of Eastern State Penitentiary, and the Department of Welfare; and making an appropriation," as amended by the act approved, the twenty-sixth day of April, one thousand nine hundred twenty-nine (Pamphlet Laws, eight hundred twenty-six), entitled "An act to amend section four of the act, approved the fourth day of May, one thousand nine hundred and twenty-seven (Pamphlet Laws, seven hundred sixty-one), entitled 'An act providing for the preparation of plans and specifications, and for the erection of the Eastern State Penitentiary on lands acquired therefor; imposing duties in connection therewith upon the Governor, the Board of Trustees of Eastern State Penitentiary, and the Department of Welfare; and making an appropriation,' providing for the transfer to and employment of inmates at the said penitentiary, the payment of wages to such inmates, and the payment by the counties of the expense of keeping prisoners at the site of said new penitentiary," and supplemented by the act, approved the fifteenth day of May, one thousand nine hundred twenty-nine (Appropriation Acts,

page one hundred sixty-four), entitled "A supplement to the act, approved the fourth day of May one thousand nine hundred and twenty-seven (Pamphlet Laws, seven hundred sixty-one), entitled 'An act providing for the preparation of plans and specifications, and for the erection of the Eastern State Penitentiary on lands acquired therefor; imposing duties in connection therewith upon the Governor, the Board of Trustees of Eastern State Penitentiary, and the Department of Welfare; and making an appropriation,' providing for further construction of buildings, and development and improvement of grounds of the new Eastern State Penitentiary; and making appropriations to the Department of Property and Supplies for the use of the Board of Trustees of Eastern State Penitentiary."

Section 2. The appropriation made by this act shall be expended by the Department of Property and Supplies for furnishings and equipment recommended by the Board of Trustees of the Eastern State Penitentiary and approved by the Department of Welfare, for the further construction of buildings and facilities under the plans and specifications already approved, subject, however, to any modifications thereof which may be made with the approval of the Governor, the Department of Welfare, and the Department of Property and Supplies, and for the further development of the grounds as recommended by the Board of Trustees of Eastern State Penitentiary with the approval of the Department of Welfare.

Section 3. All construction work and all work incident to the development of grounds shall be under the immediate supervision of the superintendent of construction heretofore selected, or such other superintendent or superintendents as may hereafter be selected by the Department of Property and Supplies with the approval of the Governor.

Section 4. All contracts for the purchase of furnishings, equipment, materials, or supplies, and all other contracts which it may become necessary to award and execute for carrying out the provisions of the act to which this is a supplement, and its amendments, shall be made by the Department of Property and Supplies; and any contract made hereunder, which shall involve an expenditure of more than five hundred dollars (\$500), shall be made after advertisement and competitive bidding.

Section 5. This act shall be effective immediately upon its passage, and approval by the Governor.

APPROVED—The 12th day of June, A. D. 1931.

I approve this bill on the definite understanding that the item of \$3,000,000 will not be spent to the amount of over \$2,000,000 unless and until sufficient revenues have accrued to cover it nor without special permission of the Governor.

No. 18-A.

AN ACT

Making an appropriation to the Department of Property and Supplies for the acquisition of land and buildings for the Commonwealth, and the erection and construction of new buildings and additions, alterations or improvements to and replacement of new or existing buildings of the Commonwealth, including fixtures and heating or sewerage systems and service lines for the accommodation of buildings.

Section 1. Be it enacted, &c., That the sum of eleven million nine hundred sixteen thousand ten dollars (\$11,916,010), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Property and Supplies for the purchase or condemnation of land for the Commonwealth, and the erection and construction of new buildings, and for altering, improving, adding to, or replacing existing buildings of the Commonwealth, namely:

DEPARTMENT OF AGRICULTURE

For improvements on and for the Farm Show Building and the grounds adjacent thereto, and for the purchase of land therefor, the sum of one hundred eighty-seven thousand seven hundred dollars (\$187,700).

DEPARTMENT OF HEALTH

For the acquisition of land, the erection and construction of new buildings, and for additions and alterations to improvement or replacement of existing buildings, for the State Sanatoria for Tuberculosis and the State Hospital for Crippled Children, the sum of one million dollars (\$1,000,000).

DEPARTMENT OF MILITARY AFFAIRS

For the acquisition of land, and the erection and construction of armories and armory facilities, necessary roadways and sidewalks for the use of the Pennsylvania National Guard, the sum of seven hundred fifty thousand dollars (\$750,000).

For the purchase for armory purposes of any suitable building erected by any person or persons, and for additions and alterations to or replacement of and repairs to such building, the sum of fifty thousand dollars (\$50,000).

For the acquisition of land, and the erection and construction of sewers and a sewage disposal plant, for the State Military Reservation, the sum of fifty-three thousand three hundred dollars (\$53,300).

DEPARTMENT OF PUBLIC INSTRUCTION

For the acquisition of land, the erection and construction of new buildings, and for additions and alterations to improvement or replacement of existing buildings for State Normal Schools, State Teachers' Colleges, Cheyney Training School for Teachers, the sum of one million nine hundred fifteen thousand dollars (\$1,915,000).

For the erection and construction of new buildings, and for additions

and alterations to or replacement of existing buildings, for the Pennsylvania State Oral School for the Deaf, at Scranton, Pennsylvania, the sum of one hundred seventy-five thousand dollars (\$175,000).

For the erection and construction of new buildings, and for additions and alterations to or replacement of existing buildings, for the Pennsylvania Soldiers' Orphan School, at Scotland, Pennsylvania, the sum of two hundred eighty thousand dollars (\$280,000).

For the erection and construction of new buildings, and for additions and alterations to or replacement of existing buildings, for the Home for Training in Speech of Deaf Children, at Philadelphia, Pennsylvania, the sum of twenty-two thousand dollars (\$22,000).

DEPARTMENT OF WELFARE

Hospitals for the Insane

For the acquisition of land for the Allentown State Hospital, at Allentown, Pennsylvania, the sum of thirty-two thousand five hundred dollars (\$32,500).

For the erection and construction of new buildings, and for additions and alterations to or replacement of existing buildings, for the Allentown State Hospital, at Allentown, Pennsylvania, the sum of three hundred eleven thousand nine hundred dollars (\$311,900).

For the acquisition of land for the Danville State Hospital, at Danville, Pennsylvania, the sum of five thousand dollars (\$5,000).

For the erection and construction of new buildings, and for additions and alterations to or replacement of existing buildings, for the Danville State Hospital, at Danville, Pennsylvania, the sum of four hundred eighty thousand dollars (\$480,000).

For the erection and construction of new buildings, and for additions and alterations to or replacement of existing buildings, for the Farview State Hospital, at Farview, Pennsylvania, the sum of four hundred sixty-seven thousand five hundred dollars (\$467,500).

For the erection and construction of new buildings, and for additions and alterations to or replacement of existing buildings, for the Harrisburg State Hospital, at Harrisburg, Pennsylvania, the sum of four hundred two thousand dollars (\$402,000).

For the erection and construction of new buildings, and for additions and alterations to or replacement of existing buildings, for the Norristown State Hospital, at Norristown, Pennsylvania, the sum of five hundred eighty-two thousand five hundred dollars (\$582,500).

For the erection and construction of new buildings, and for additions and alterations to or replacement of existing buildings, for the Torrance State Hospital, at Torrance, Pennsylvania, the sum of five hundred fifteen thousand dollars (\$515,000).

For the erection and construction of new buildings, and for additions and alterations to or replacement of existing buildings, for the Warren State Hospital, at Warren, Pennsylvania, the sum of two hundred ninety thousand dollars (\$290,000).

For the erection and construction of new buildings, and for additions and alterations to or replacement of existing buildings, for the Wernersville State Hospital, at Wernersville, Pennsylvania, the sum of three hundred thousand dollars (\$300,000).

Penal and Correctional Institutions

For the erection and construction of new buildings, and for additions and alterations to or replacement of existing buildings, for the Pennsylvania Industrial Reformatory, at Huntingdon, Pennsylvania, the sum of three hundred ninety-one thousand dollars (\$391,000).

For the erection and construction of new buildings, and for additions and alterations to or replacement of existing buildings, for the Pennsylvania Training School, at Morganza, Pennsylvania, the sum of four hundred fifteen thousand dollars (\$415,000).

For the erection and construction of new buildings, and for additions and alterations to or replacement of existing buildings, for the State Industrial Home for Women, at Muncy, Pennsylvania, the sum of one hundred seventy thousand dollars (\$170,000).

For the erection and construction of new buildings, and for additions and alterations to or replacement of existing buildings, for the Western State Penitentiary, at Pittsburgh, Pennsylvania, the sum of one hundred thirty-eight thousand dollars (\$138,000).

For the erection and construction of new buildings, and for additions and alterations to or replacement of existing buildings, for the Western State Penitentiary, at Rockview, Pennsylvania, the sum of three hundred fifty-eight thousand dollars (\$358,000).

Institutions for Feeble-Minded or Epileptics

For the erection and construction of new buildings, and for additions and alterations to or replacement of existing buildings, for the Selinsgrove State Colony for Epileptics, at Selinsgrove, Pennsylvania, the sum of seven hundred forty thousand dollars (\$740,000).

For the erection and construction of new buildings, and for additions and alterations to or replacement of existing buildings, for the Laurelton State Village, at Laurelton, Pennsylvania, the sum of four hundred thirteen thousand dollars (\$413,000).

For the erection and construction of new buildings, and for additions and alterations to or replacement of existing buildings, for the Pennhurst State School, at Pennhurst, Pennsylvania, the sum of six hundred eighty-eight thousand dollars (\$688,000).

For the erection and construction of new buildings, and for additions and alterations to or replacement of existing buildings, for the Polk State School, at Polk, Pennsylvania, the sum of four hundred fifty-three thousand five hundred dollars (\$453,500).

Medical and Surgical Hospitals

For the erection and construction of new buildings, and for additions and alterations to or replacement of existing buildings, for the Blossburg State Hospital, at Blossburg, Pennsylvania, the sum of one hundred sixty thousand dollars (\$160,000).

For the erection and construction of new buildings, and for additions and alterations to or replacement of existing buildings, for the Philipsburg State Hospital, at Philipsburg, Pennsylvania, the sum of one hundred forty thousand dollars (\$140,000).

For the acquisition of land for the Shamokin State Hospital at Shamokin, Pennsylvania, the sum of one hundred ten dollars (\$110).

For the erection and construction of new buildings, and for additions and alterations to or replacement of existing buildings for the Shamokin State Hospital at Shamokin, Pennsylvania, the sum of thirty thousand dollars (\$30,000).

Section 2. Within the meaning of this act, the erection and construction of or alterations or additions to buildings shall include the installation or replacement of fittings and equipment affixed to buildings, and the installation or replacement of heating systems, and heating, sewage and other service lines, within the grounds of an institution, armory, or stable, for the accommodation of a building or buildings; and the foregoing appropriations be and the same are hereby made available for the payment of the cost of necessary plans, specifications, advertising for bids, supervision, and architectural and engineering fees required for the purpose of this act.

Section 3. The amount of any of the foregoing appropriations to be expended for or upon any building or buildings for any particular institution shall be determined, with the approval of the Governor, by the Department of Property and Supplies and the department of the State Government operating such institution or with which the board of trustees of such institution is connected; and the amount of the foregoing appropriation to be expended for any particular armory or armory facility shall be determined, with the approval of the Governor, by the Department of Property and Supplies and the Armory Board of the Commonwealth of Pennsylvania.

Section 4. In the event of condemnation, the Department of Property and Supplies shall follow the procedure prescribed by law for the condemnation of lands by said department.

APPROVED—The 13th day of June, A. D. 1931, in the total amount of nine million six hundred forty-six thousand and ten dollars (\$9,646,010). I withhold my approval from the balance of the total amount of this bill because of insufficient State revenue.

I approve the appropriations for specific purposes as follows:

I approve, in the amount of five hundred seven thousand dollars (\$507,000), the item which provides as follows:

“For the acquisition of land, the erection and construction of new buildings, and for additions and alterations to improvement or replacement of existing buildings for the State Sanatoria for Tuberculosis and the State Hospital for Crippled Children, the sum of one million dollars (\$1,000,000).”

I approve, in the amount of two hundred fifty thousand dollars (\$250,000), the item which provides as follows:

“For the acquisition of land, and the erection and construction of armories and armory facilities, necessary roadways and sidewalks for the use of the Pennsylvania National Guard, the sum of seven hundred fifty thousand dollars (\$750,000).”

I approve, in the amount of nine hundred fifteen thousand dollars (\$915,000), the item which provides as follows:

“For the acquisition of land, the erection and construction of new buildings, and for additions and alterations to improvement or replacement of existing buildings for State Normal Schools, State Teachers Colleges, Cheyney Training School for Teachers, the sum of one million nine hundred fifteen thousand dollars (\$1,915,000).”

I approve, in the amount of one hundred fifty thousand dollars (\$150,000), the item which provides as follows:

“For the erection and construction of new buildings, and for additions and alterations to or replacement of existing buildings for the Pennsylvania State Oral School for the Deaf at Scranton, Pennsylvania, the sum of one hundred seventy-five thousand dollars (\$175,000).”

I approve, in the amount of five thousand dollars (\$5,000), the item which provides as follows:

“For the erection and construction of new buildings, and for additions and alterations to or replacement of existing buildings for the Home for Training in Speech of Deaf Children at Philadelphia, Pennsylvania, the sum of twenty-two thousand dollars (\$22,000).”

I approve, in the amount of two hundred seventy thousand dollars (\$270,000), the item which provides as follows:

“For the erection and construction of new buildings, and for additions and alterations to or replacement of existing buildings for the Pennsylvania Training School at Morganza, Pennsylvania, the sum of four hundred fifteen thousand dollars (\$415,000).”

I approve, in the amount of one hundred thousand dollars (\$100,000), the item which provides as follows:

“For the erection and construction of new buildings, and for additions and alterations to or replacement of existing buildings for the Blossburg State Hospital at Blossburg, Pennsylvania, the sum of one hundred sixty thousand dollars (\$160,000).”

I withhold my approval from the item which provides as follows:

“For the erection and construction of new buildings, and for additions and alterations to or replacement of existing buildings for the Shamokin State Hospital at Shamokin, Pennsylvania, the sum of thirty thousand dollars (\$30,000).”

No. 19-A.

AN ACT

Making an appropriation to the Department of Property and Supplies for the purpose of renovating, repairing, or replacing the roof on the main Capitol Building.

Section 1. Be it enacted, &c., That the sum of two hundred thousand dollars (\$200,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Property and Supplies for renovating, repairing, or replacing the roof on the main Capitol Building, including supervision, architectural and engineering fees, and any other necessary expense.

APPROVED—The 19th day of June, A. D. 1931.

No. 20-A.

AN ACT

Making an appropriation for the payment of gratuities towards the education of children of soldiers, sailors and marines who were killed in action or died during the World War; and conferring certain duties upon the State Veterans' Commission.

Section 1. Be it enacted, &c., That the sum of thirty-two thousand dollars (\$32,000), or so much thereof as may be necessary, is hereby appropriated to the Department of Military Affairs to be used, during the fiscal biennium beginning June first, one thousand nine hundred and thirty-one, for paying gratuities to the children, between the ages of sixteen and twenty-one years, of soldiers, sailors or marines of the United States who were killed in action or died from other cause during the World War, between the sixth day of April, one thousand nine hundred and seventeen, and the second day of July, one thousand nine hundred and twenty-one.

Section 2. Gratuities shall be paid out of the appropriation made by this act to or for the account of such children as shall be certified by the State Veterans' Commission as coming within the class described in section one of this act, and as attending any State or State-aided educational or training institution of a secondary or college grade or other institution of higher education within this Commonwealth. Payments, not to exceed the sum of two hundred dollars (\$200), per school year, per child, shall be made to such children upon the submission by them of proof that they have incurred bills or contracted for board and room rent in a definite amount for the current

school year. Such proof shall be submitted to the State Veterans' Commission, which shall attach the same to the requisitions prepared for payments out of the appropriation made by this act.

AN ACT

Making an appropriation to the Cresson Volunteer Fire Company for the protection of State Property.

Section 1. Be it enacted, &c., That the sum of one thousand (\$1000.00) dollars is hereby specifically appropriated to the Cresson Volunteer Fire Company, for the two fiscal years beginning June first, one thousand nine hundred and thirty-one, for the protection of State property at the Cresson Sanitarium.

AN ACT

Making an appropriation for the purpose of improving and maintaining the public roads through the Cornplanter Indian Reservation in Elk Township, Warren County, Pennsylvania.

Section 1. Be it enacted, &c., That the sum of six hundred dollars (\$600.00), or so much thereof as may be necessary, is hereby specifically appropriated, for the two fiscal years beginning June first, one thousand nine hundred and thirty-one, to be paid to the treasurer of Elk Township, Warren County, Pennsylvania, for the purpose of improving and maintaining in good repair the public roads and highways passing through the Cornplanter Indian Reservation in said township. Said money shall be paid on warrant drawn on the State Treasurer by the Auditor General, and shall be disbursed under the direction of the supervisors of Elk Township.

No. 23-A.

AN ACT

Making an appropriation to the several fire companies of the city of Harrisburg.

Section 1. Be it enacted, &c., That the sum of five thousand dollars (\$5,000), or so much thereof as may be necessary, is hereby specifically appropriated for the several fire companies of the city of Harrisburg, Pennsylvania, as compensation for protection from and extinguishment of any fire or fires that may occur in or on the Capitol buildings or grounds, for the two fiscal years beginning June first, one thousand nine hundred and thirty-one. Said sum to be distributed among said companies in equal amounts.

No. 24-A.

AN ACT

Making an appropriation to the Downingtown Industrial and Agricultural School, Downingtown, Pennsylvania.

Section 1. years beginning June first, one thousand nine hundred and thirty-one, for maintenance and the purchase of apparatus, supplies and equipment.

Be it enacted, &c., That the sum of five thousand (\$5000) dollars, or so much thereof as may be necessary, is hereby specifically appropriated to the Board of Finance and Revenue for the purpose of paying refunds to public utility companies where moneys have heretofore been, or may hereafter be, erroneously collected by the Commonwealth from public utility companies for the occupancy of bridges where such bridges did not become the obligation of the Commonwealth under the provisions of the act of Assembly, approved the first day of May, one thousand nine hundred and twenty-nine (Pamphlet Laws, one thousand fifty-four), entitled "An act providing that county bridges over streams on State highway routes in boroughs, towns and townships may, under certain circumstances, be taken over by the Commonwealth; and providing that all contracts for the construction, building, rebuilding, or repairing of such bridges hereafter made shall be subject to approval by the Department of Highways," and to which the Commonwealth has no rightful claim.

Section 2. All payments made from this appropriation shall be in accordance with existing laws governing refunds by the Board of Finance and Revenue.

Section 3. All acts or parts of acts inconsistent herewith be and the same are hereby repealed.

Section 4. This act shall become effective upon its approval by the Governor.

All supervision, architectural and engineering fees, and any other necessary expense shall be paid from the funds made available by this act.

Section 1. Be it enacted, &c., That the sum of four thousand eight hundred seventy-six dollars and nineteen cents (\$4,876.19), or as much thereof as may be necessary, out of the unexpended balance of the appropriation made to the Department of Property and Supplies by

the act, approved the sixteenth day of May, one thousand nine hundred and twenty-nine (Appropriation Acts, page one hundred seventy-four), entitled "An act making an appropriation to the Department of Property and Supplies for the acquisition of land for the Commonwealth, and the erection and construction of new buildings and additions and alterations to and replacements of existing buildings of the Commonwealth, including fixtures and heating or sewerage systems and service lines for the accommodation of buildings," for the erection and construction of new buildings, and for additions and alterations to and replacements of existing buildings, for the State Hospital for Crippled Children, at Elizabethtown, is hereby reappropriated to the Department of Property and Supplies for the payment of a bill owing to Everts and Overdeer, Lancaster, Pennsylvania, for plumbing and heating work at the State Hospital for Crippled Children, at Elizabethtown, which was authorized by the Department of Property and Supplies prior to the first day of June, one thousand nine hundred and twenty-nine.

Making an appropriation to the Department of Property and Supplies to be expended by it in the payment to the Harrisburg Railways Company, of the city of Harrisburg, of a part of the damages occasioned by the erection by the Commonwealth of the Soldiers and Sailors Memorial Bridge.

Whereas, The erection by the Commonwealth of the Soldiers and Sailors Memorial Bridge destroyed certain property of the Harrisburg Railways Company, including the double track line of street railway on State Street, in the city of Harrisburg, from Filbert Street to Thirteenth Street; and

Whereas, The said railways company presented to the Department of Property and Supplies, during the administration of the Honorable John S. Fisher, as Governor, its estimate of the damages due to said construction in the amount of eighty-seven thousand six hundred and ninety-six dollars and eighty-five cents (\$87,696.85); and

Whereas, The Secretary of Property and Supplies advised the Governor that, in his opinion, the said estimate was just and reasonable; and

Whereas, The Honorable John S. Fisher in his message to the Legislature on January sixth, one thousand nine hundred thirty-one, recommended the making of an appropriation to said railways company to pay it for the damages occasioned by the Commonwealth; and

Whereas, The Commonwealth requested the said railways company not to construct a double track street railway line on Filbert Street and on the Soldiers and Sailors Memorial Bridge, to which request the railways company agreed to accede if the Commonwealth would pay to

it as settlement for the above mentioned damages the sum of seventy-five thousand dollars (\$75,000); and

Whereas, It became necessary for the railways company to construct, as a substitute for the State Street line, a double track street railway line on Herr Street, from Seventh Street to Cameron Street, in order to get access to its car barns; and

Whereas, The actual cost of constructing said line on Herr Street was fifty-four thousand six hundred and twenty-three dollars and fourteen cents (\$54,623.14); therefore

Section 1. Be it enacted, &c., That fifty-four thousand six hundred and twenty-three dollars and fourteen cents (\$54,623.14), or as much thereof as may be necessary, be, and it hereby specifically is, appropriated to the Department of Property and Supplies to be paid by it to the Harrisburg Railways Company, in the city of Harrisburg, to reimburse said railways company for the actual cost of building the double track street railway line on Herr Street, from Seventh Street to Cameron Street, made necessary by the destruction of said company's line of street railway on State Street, being part of the damages occasioned by the building of the Soldiers and Sailors Memorial Bridge.

AN ACT

Making an appropriation to the Department of Welfare to pay for the care, treatment, removal, and maintenance of the indigent insane in Dixmont Hospital, at Dixmont, Allegheny County.

Section 1. Be it enacted, &c., That the sum of three hundred forty-six thousand five hundred dollars (\$346,500), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Welfare, for and during the two fiscal years beginning June first, one thousand nine hundred and thirty-one, to pay for the care, treatment, removal, and maintenance of the indigent insane at Dixmont Hospital, Dixmont, Allegheny County, at a rate not exceeding three dollars (\$3) per week for the care, treatment, and maintenance of each indigent patient in the hospital.

No warrant shall be drawn or settlement made until the directors or managers of the hospital shall have made, on oath or affirmation to the Department of Welfare, a monthly or quarterly report as may be required by the Department of Welfare, setting forth the actual total number of weeks of service rendered to indigent patients in said hospital during the period for which the report is made; nor until the Secretary of Welfare shall have certified to the Auditor General that the monthly or quarterly report of the cost of such care and treatment contains no charge except for "care, treatment, removal, and

maintenance," which words, as used in this act, shall be construed to mean medical and surgical treatment and nursing, food, and clothing.

Section 2. It shall be the duty of directors or managers of the hospital to make, on oath or affirmation to the Department of Welfare, a report on the fifteenth day of June, one thousand nine hundred and thirty-one, setting forth the name of each and every indigent patient resident in the hospital on the first day of June preceding. Such list shall show the date of admission or readmission of each such patient, the identification number of such patient, and the county or poor district from which such patient was committed.

Each month or quarter thereafter, during the period covered by this appropriation, as may be requested by the Secretary of Welfare, the directors or managers of the hospital shall make, on oath or affirmation, a report to the Department of Welfare setting forth the name of each indigent patient admitted or readmitted during the period of the report, together with the identification number of such patient, the date of admission or readmission, and the county or poor district from which such patient was committed. Such report shall also contain the name of each indigent patient removed from the hospital by death, discharge or parole, together with the identification number of such patient, the date of removal, and the county or poor district from which such patient was committed.

AN ACT

Making an appropriation to the Department of Welfare to pay for the care, treatment, removal, and maintenance of the indigent insane in county and poor district hospitals.

Section 1. Be it enacted, &c., That the sum of two million six hundred forty-seven thousand six hundred twenty-two dollars (\$2,647,622), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Welfare to pay for the care, treatment, removal, and maintenance of the indigent insane in county and poor district hospitals, for and during the two years beginning June first, one thousand nine hundred and thirty-one, and to pay for the deficiency in the care, treatment, removal, and maintenance of the indigent insane prior to June first, one thousand nine hundred and twenty-nine.

No warrant shall be drawn on this appropriation until the directors, trustees or managers of such hospitals shall have made, on oath or affirmation to the Department of Welfare, a monthly or quarterly report, as may be required by Secretary of Welfare, setting forth the actual total number of weeks of service rendered to indigent insane patients in such hospitals, respectively, during the period for which the re-

port is made; nor until the Secretary of Welfare shall have certified to the Auditor General that the monthly or quarterly report of the cost of such care and treatment contains no charge except for "care, treatment, removal, and maintenance," which words, as used in this act, shall be construed to mean medical and surgical treatment, nursing, food, and clothing.

Section 2. It shall be the duty of the directors, trustees or managers of such hospitals to make, on oath or affirmation to the Department of Welfare, a report on the fifteenth day of June, one thousand nine hundred and thirty-one, setting forth the name of each and every indigent insane patient resident in such hospitals, respectively, on the first day of June preceding. Such list shall show the date of admission or readmission of each such patient, the identification number of such patient, and the county or poor district from which such patient was committed.

Each month or quarter thereafter, during the period covered by this appropriation, as may be requested by the Secretary of Welfare, the directors, trustees or managers of such hospitals shall make, on oath or affirmation, a report to the Department of Welfare setting forth the name of each indigent insane patient admitted or readmitted during the period of the report, together with the identification number of such patient, the date of admission or readmission, and the county or poor district from which such patient was committed. Such report shall also contain the name of each indigent insane patient removed from such hospitals by death, discharge or parole, together with the identification number of such patient, the date of removal, and the county or poor district from which such patient was committed.

AN ACT

Making an appropriation to the Board of Finance and Revenue for the refund of certain moneys paid into the State Treasury.

Section 1. Be it enacted, &c., That the sum of two hundred dollars (\$200), or so much thereof as may be necessary, is hereby specifically appropriated to the Board of Finance and Revenue, in the Treasury Department of this Commonwealth, for the specific purpose of repaying or refunding to any individual, association, copartnership, or corporation such sum or sums, together with interest thereon, as may have been paid by such individual, association, copartnership, or corporation to the Department of Property and Supplies, and by that department paid into the State Treasury, as the purchase price of any material or supplies or personal property of whatever nature, which said department was unable or failed to deliver to such purchaser through no fault of such purchaser.

Any person, association, copartnership, or corporation, claiming such refund, shall make application therefor to the Board of Finance and Revenue, and said board, upon due proof of the applicant's claim, shall draw its requisition on the Auditor General for a refund of the amount to which such claimant is rightfully entitled, together with interest thereon, whereupon the Auditor General shall draw his warrant on the State Treasurer and payment shall be made accordingly.

Be it enacted, &c., That the sum of one hundred and fifty thousand dollars (\$150,000) is hereby specifically appropriated to the Department of Forests and Waters, for the two fiscal years beginning June first, one thousand nine hundred and thirty-one, for the supervision, maintenance, improvement, regulation and preservation of State parks, and for the acquisition, survey of boundary lines, and title examinations of lands to be set aside and held as State parks: Provided, however, That the amount expended as the purchase price for such lands shall not in any case exceed fifty dollars (\$50) per acre.

Making an appropriation to the Trustees of the University of Pittsburgh for the general maintenance of, and the purchase of apparatus and equipment for, the University of Pittsburgh, and for the maintenance of teaching facilities in hospitals for students in the School of Medicine.

Section 1. Be it enacted, &c., That the sum of one million six hundred and fifty thousand (\$1,650,000) dollars, or so much thereof as may be necessary, is hereby specifically appropriated to the Trustees of the University of Pittsburgh, for the two fiscal years beginning June first, one thousand nine hundred and thirty-one, for the general maintenance of the University of Pittsburgh, and the purchase of such apparatus and equipment as the Trustees may deem necessary for the best interests of the University of Pittsburgh, including maintenance of teaching facilities in hospitals for students in the School of Medicine of the University of Pittsburgh, including the Maternity Dispensary and other dispensaries.

APPROVED—The 23d day of June, A. D. 1931, in the sum of \$1,320,000. I withhold my approval from the remainder of said appropriation because of insufficient State revenue.

AN ACT

Making an appropriation to the Trustees of the University of Pennsylvania.

Section 1. Be it enacted, &c., That the sum of two million dollars (\$2,000,000), or so much thereof as may be necessary, be and the same is hereby specifically appropriated to the Trustees of the University of Pennsylvania, for the two fiscal years beginning June first, one thousand nine hundred and thirty-one, for the general maintenance of the University, and the purchase of such apparatus and equipment as the trustees may deem necessary for the best interests of the University of Pennsylvania.

APPROVED—The 23d day of June, A. D. 1931, in the sum of \$1,650,000. I withhold my approval from the remainder of said appropriation because of insufficient State revenue.

AN ACT

Making an appropriation to The Glen Mills Schools, situate in Delaware County, Pennsylvania.

Section 1. Be it enacted, &c., That the sum of three hundred forty-six thousand dollars (\$346,000), or so much thereof as may be necessary, be and the same is hereby specifically appropriated to The Glen Mills Schools, situate in Delaware County, Pennsylvania, for the two fiscal years beginning the first day of June, Anno Domini one thousand nine hundred and thirty-one, for the purpose of maintenance.

Section 2. The sum of twenty-five thousand dollars, or so much thereof as may be necessary, is hereby specifically appropriated to The Glen Mills Schools for the purpose of erecting, constructing and equipping an automobile repair shop at the Boys' School.

APPROVED—The 23d day of June, A. D. 1931, except as to the item of twenty-five thousand dollars (\$25,000) for the construction and equipment of an automobile repair shop at the Boys' School.

I withhold my approval from this item because of insufficient State revenue.

Making an appropriation to the Board of Trustees of the Ashland State Hospital for the payment of a deficiency in the construction of the nurses home at such hospital.

Section 1. Be it enacted, &c., That the sum of fifteen thousand four hundred fifty-nine dollars and sixty cents (\$15,459.60) is hereby specifically appropriated to the Board of Trustees of the Ashland State Hospital for the payment of a deficiency incurred by said board prior to June first, one thousand nine hundred and twenty-nine, in the erection and construction of the nurses home at the Ashland State Hospital.

AN ACT

Making an appropriation to the Board of Trustees of Philipsburg State Hospital, of Philipsburg, Pennsylvania, for the payment of notes issued by said board of trustees to pay for the construction and equipment of hospital buildings, and validating the action of the board in issuing such notes.

Whereas, By an act, approved the eleventh day of May, one thousand nine hundred and twenty-seven (Appropriation Acts, page one hundred ninety-three), an appropriation was made to the Board of Trustees of the Philipsburg State Hospital of eighty-eight thousand four hundred sixty-three dollars and fifty cents (\$88,463.50) for a deficiency in the construction of hospital buildings and equipment, which appropriation was reduced by the Governor to the sum of sixty thousand dollars (\$60,000.00); and

Whereas, The board of trustees borrowed the money necessary to pay the balance of the deficiency and executed and delivered, in the name of the board, eight promissory notes therefor, each in the amount of three thousand five hundred dollars, which notes were endorsed by the individual members of the board; and

Whereas, It was intended to have these notes, with interest thereon, paid off through funds raised locally, but this has been found to be impossible owing to the financial conditions in the mining industry in the community where the hospital is located; therefore

Section 1. Be it enacted, &c., That the sum of thirty-five thousand dollars (\$35,000.00), or as much thereof as may be necessary, is hereby specifically appropriated to the Board of Trustees of Philipsburg State Hospital, of Philipsburg, Pennsylvania, for the payment of the principal of and interest on notes issued by the board of trustees to borrow money to pay in full the cost of construction of hospital buildings and equipment; and the action of the board of trustees, in borrowing money and issuing notes therefor, is hereby validated as fully as if the General Assembly had by act of Assembly authorized the board of trustees to enter into the contracts out of which the construction deficiency arose and to borrow money and issue notes to procure funds to pay the deficiency in anticipation of an appropriation.

Making an appropriation to the Jefferson Medical College, of Philadelphia, Pennsylvania, for medical education.

Section 1. Be it enacted, &c., That the following sum, or so much thereof as may be necessary, be and the same is hereby specifically

appropriated to the Jefferson Medical College, of Philadelphia, Pennsylvania, for the two fiscal years beginning June first, one thousand nine hundred and thirty-one, for the following purpose, namely:

The sum of one hundred eighty thousand dollars (\$180,000), or so much thereof as may be necessary, for the support and promotion of medical education.

APPROVED—The 25th day of June, A. D. 1931, in the sum of \$180,000.

AN ACT

Making an appropriation to the Department of Military Affairs for the purchase of distinctive uniforms and equipment for the Governor's Troop of the Pennsylvania National Guard.

Section 1. Be it enacted, &c., That the sum of five thousand five hundred (\$5,500) dollars, or so much thereof as may be necessary, is hereby specifically appropriated to the Department of Military Affairs for the purpose of purchasing special and distinctive uniforms and equipment for the officers and enlisted men of the Governor's Troop of the Pennsylvania National Guard, commensurate with the dignity of the Commonwealth, and of such style and pattern as a majority of its officers may select and the Governor, as Commander-in-Chief, approve.

Providing for the lapsing of certain balances of State-aid appropriations.

Section 1. Be it enacted, &c., That any balances of any State-aid appropriations from the Motor License Fund heretofore made, which are unobligated prior to the first day of June, one thousand nine hundred and thirty-one, or are remaining after the completion of work covered by agreements dated prior to the first day of June, one thousand nine hundred and thirty-one, shall lapse and become a part of the Motor License Fund.

Section 2. All acts or parts of acts inconsistent with this act are hereby repealed.

Section 3. This act shall become effective upon its approval by the Governor.

Section 2. The sum of twenty thousand dollars (\$20,000), or so much thereof as may be necessary, is hereby specifically appropriated to the Sleighton Farm School for Girls for the purpose of constructing and equipping a reservoir and the necessary connections for fire protection at the Girls' School.

APPROVED—The 26th day of June, A. D. 1931, except as to the item of twenty thousand dollars (\$20,000) for the construction and equipment of a reservoir and the necessary connections for fire protection at the Girls' School.

I withhold my approval from this item because the condition of the State revenues does not warrant an appropriation for capital purposes at a State-aided institution.

Making an appropriation to the Woman's Medical College of Pennsylvania, located at East Falls, Philadelphia.

Section 1. Be it enacted, &c., That the sum of one hundred thousand dollars (\$100,000), or so much thereof as may be necessary, is hereby specifically appropriated to the Woman's Medical College of Pennsylvania, located at East Falls, Philadelphia, for the support

and promotion of medical education, for the two fiscal years beginning June first, one thousand nine hundred and thirty-one, payment to be made on requisitions approved by the Superintendent of Public Instruction.

APPROVED—The 26th day of June, A. D. 1931, in the sum of \$90,000. I withhold my approval from the remainder of said appropriation because of insufficient State revenue.

AN ACT

Making an appropriation to the Philadelphia School of Design for Women, at Philadelphia, Pennsylvania.

Section 1. Be it enacted, &c., That the sum of eighty thousand dollars (\$80,000), or so much thereof as may be necessary, is hereby specifically appropriated to the Philadelphia School of Design for Women, at Philadelphia, Pennsylvania, for the two fiscal years beginning June first, one thousand nine hundred and thirty-one, for general maintenance: Provided, That in such school there shall be maintained a free scholarship for one pupil of each county in the State, to be filled by appointment of the Governor of the Commonwealth, except that for counties having more than one Senator as many scholarships shall be provided as there are senatorial districts in such counties, and in the case of the failure of any county to be properly represented by an appointee or appointees at the opening of any school year, October first, then the Governor shall have the power to fill such vacancy or vacancies by the appointment of applicants from other counties of the State. In each quarterly statement by the board of directors of the said institution to the Auditor General shall be included a statement of the names and residences of all pupils filling free scholarships, as provided by this act.

APPROVED—The 26th day of June, A. D. 1931, in the sum of \$44,000. I withhold my approval from the remainder of said appropriation because of insufficient State revenue.

AN ACT

Making an appropriation to certain educational institutions for the preparation, exhibition, and distribution of collections and educational material.

Section 1. Be it enacted, &c., That the sum of seventy thousand dollars (\$70,000), be and the same is hereby specifically appropriated

to certain educational institutions, as follows: To the Board of Trustees of the Philadelphia Museums for the distribution of geographical collections and educational material among the public and other free schools of this Commonwealth, and for the preparation and installation of exhibits, for the two fiscal years beginning June first, one thousand nine hundred and thirty-one, the sum of thirty-five thousand dollars (\$35,000), payment to be made on requisition approved by the Department of Public Instruction. To the Carnegie Institute of Pittsburgh, Pennsylvania, for the exhibition and distribution of biological and geological collections and educational material among the public and other free schools of this Commonwealth, for the preparation, installation and exhibition of such collections and exhibitions, for the two fiscal years beginning June first, one thousand nine hundred and thirty-one, the sum of thirty-five thousand dollars (\$35,000), payment to be made on requisition approved by the Department of Public Instruction.

APPROVED—The 26th day of June, A. D. 1931, in the amount of thirty-five thousand dollars (\$35,000) to the Board of Trustees of the Philadelphia Museums.

I withhold my approval from the item of thirty-five thousand dollars (\$35,000) to the Carnegie Institute of Pittsburgh because of insufficient State revenue.

Making an appropriation to the Johnson Industrial School, of Scranton, Pennsylvania.

Section 1. Be it enacted, &c., That the sum of fifty thousand dollars (\$50,000), or so much thereof as may be necessary, is hereby specifically appropriated to the Johnson Industrial School, of Scranton, Pennsylvania, for the two fiscal years beginning June first, one thousand nine hundred and thirty-one, for the purpose of maintenance and the purchase of supplies and equipment.

A FURTHER SUPPLEMENT

To an act, approved the first day of April, one thousand eight hundred and sixty-three (Pamphlet Laws, two hundred thirteen), entitled "An act to accept the grant of public lands by the United States to the several States for the endowment of Agricultural Colleges," and making an appropriation for carrying the same into effect.

Section 1. Be it enacted, &c., That in order to carry into effect the act of Congress, approved July second, one thousand eight hundred and sixty-two, granting public land to the several States for educational purposes, and subsequent acts of Congress related thereto, and the act of the Legislature of Pennsylvania, approved April first, one thousand eight hundred and sixty-three, and subsequent acts of the Legislature of Pennsylvania, accepting the provisions and conditions of said acts of Congress and pledging the faith of the State to carry the same into effect, the sum of four million eight hundred and forty-four thousand seven hundred and eighty-one dollars (\$4,844,781) is hereby specifically appropriated, for the two fiscal years beginning June first, one thousand nine hundred and thirty-one, to the Trustees of the Pennsylvania State College, for the following purposes:

For the general maintenance of instruction, research and extension in the School of Agriculture, the School of Engineering, the School of Liberal Arts, the School of Mineral Industries, the School of Chemistry and Physics, the School of Education, the Graduate School, the School of Physical Education and Athletics, the Department of Military Science, the Carnegie Library, and for the general maintenance of other departments, offices, and services, including repairs and improvements to grounds and buildings, service of light, heat, power, water, and sewage disposal, salaries and wages, materials and supplies and equipment, street paving, insurance, and interest, and such other expenditures as the trustees may deem necessary and practicable, including any payments becoming due under a cooperative agreement between the Commonwealth and the trustees for the joint use of the facilities of the Pennsylvania State Forest School, at Mont Alto, the sum of four million dollars (\$4,000,000).

For the erection of new buildings and the enlargement, improvement or alteration of existing buildings, including equipment, furnishings, and the necessary extension of electric, water, steam, and sewage service lines as, in the judgment of the trustees, may be required, the sum of eight hundred forty-four thousand seven hundred eighty-one dollars (\$844,781).

APPROVED—The 26th day of June, A. D. 1931, except as to the item which provides as follows:

For the erection of new buildings and the enlargement, improvement or alteration of existing buildings, including equipment, furnishings, and the necessary extension of electric, water, steam, and sewage service lines as, in the judgment of the trustees, may be required, the sum of eight hundred forty-four thousand seven hundred eighty-one dollars (\$844,781)."

I approve this item in the amount of one hundred and twenty thousand dollars (\$120,000). I withhold my approval from the remainder of the item because of insufficient State revenue.

AN ACT.

Making an appropriation to the Department of Welfare for the maintenance of certain hospitals.

Section 1. Be it enacted, &c., That the sum of eight million thirty-three thousand dollars (\$8,033,000), or as much thereof as may be necessary, is hereby appropriated to the Department of Welfare, for the two fiscal years beginning June first, one thousand nine hundred and thirty-one, to be by it paid to the hospitals hereinafter designated, in the amounts hereinafter specified, for the purpose of the maintenance of such hospitals, in the manner prescribed by law, at the rate of three dollars (\$3) per diem for the medical and surgical services rendered to and maintenance of persons treated in such hospitals who are entitled to free service; and for each day of part pay service, such proportion of the three dollars (\$3) per diem rate as the part of the regular charge which the person treated is not able to pay bears to the regular ward charge for free service, except that no hospital shall receive compensation at a rate exceeding the actual cost of service per capita in its public ward.

A SUPPLEMENT

To the act, approved the twenty-sixth day of April, one thousand nine hundred twenty-nine (Appropriation Acts, page twenty-five), entitled "An act making an appropriation to the Department of Property and Supplies for the erection of additional State buildings in Harrisburg, and for grading and terracing the ground surrounding the same," and for exterior lighting of the building and park surrounding it.

Whereas, By the act to which this is a supplement, the General Assembly made an appropriation to the Department of Property and Supplies for the erection and construction of an additional office building in Capitol Park, to be located east of the South Office Building, which building will hereafter in this act be designated "South Office Building, Number Two," and for grading and terracing the grounds surrounding such building when constructed, and also for the erection, construction and completion of the "Farm Show Building;" and

Whereas, Out of said appropriation, the sum of forty thousand dollars (\$40,000) was expended for the cost of a railroad siding leading to the Farm Show Building and for improving the grounds surrounding the same, which amount was not contemplated at the time of the passage of the act to which this is a supplement; and

Whereas, The cost of grading, paving, drainage and terracing around South Office Building, Number Two, and for park lights and exterior building, was underestimated by one hundred forty thousand dollars (\$140,000); and

Whereas, On October third, one thousand nine hundred and thirty, a fire occurred in the auditorium of South Office Building, Number Two, causing substantial damage to the building; and

Whereas, The contractors who were erecting South Office Building, Number Two, disputed their liability to repair the damage caused by

said fire and litigation was necessary to adjudicate the respective liabilities of the Commonwealth and said contractors; and

Whereas, Litigation is still pending with respect to the liability of said contractors involving approximately two hundred thousand dollars (\$200,000) of fire damage; and

Whereas, The main contractor has gone into the hands of a receiver and it will be necessary for the Commonwealth to cause another contractor or other contractors to complete the building and to pay such contractor or contractors for so doing, pending collection by the Commonwealth from the surety company of the cost of completion; and

Whereas, It is estimated that for all purposes incident to the completion of South Office Building, Number Two, an additional sum of one million dollars (\$1,000,000) may be required, of which, however, all or the major portion thereof will subsequently be collected from the several contractors or their sureties.

Section 1. Be it enacted, &c., That the sum of one million one hundred eighty thousand dollars (\$1,180,000) is hereby appropriated to the Department of Property and Supplies for the purpose of completing the erection and construction of South Office Building, Number Two, and for grading, paving and terracing around said building when completed, and for exterior lighting of the building and the park surrounding it.

Section 2. As much of the appropriation made by this act as shall not be required for the purposes specified in section one of this act shall lapse into the General Fund of the State Treasury immediately upon the filing by the Secretary of Property and Supplies, with the Auditor General and State Treasurer, of a certificate stating that there will be no further expenditures from said appropriation.

Section 3. This act shall be effective immediately upon its approval by the Governor:

APPROVED—The 27th day of June, A. D. 1931, in the sum of \$785,000. I withhold my approval from the remainder of said appropriation because of insufficient State revenue.
