LAWS AND RESOLUTIONS

OF THE GENERAL ASSEMBLY PASSED AT THE EXTRAORDINARY SESSION OF 1931

No. 1-E

AN ACT

To provide for the expenses of the extraordinary session of the Legislature, assembled November ninth, Anno Domini one thousand nine hundred thirty-one, in pursuance of the proclamation of the Governor of the Commonwealth, dated October thirty-first, Anno Domini one thousand nine hundred thirty-one.

Section 1. Be it enacted, &c., That the following sums, or as much thereof as may be necessary, be and the same are hereby specifically appropriated for the payment of the expenses of the Legislature, assembled in extraordinary session the ninth day of November, Anno Domini one thousand nine hundred thirty-one, in pursuance of the proclamation of the Governor, dated the thirty-first day of October, Anno Domini one thousand nine hundred thirty-one.

TO THE SENATE

The total sum of one hundred and five thousand one hundred twenty-one dollars and eighty cents (\$105,-121.80), or as much thereof as may be necessary, to be paid in the manner prescribed by law.

For the payment of the salaries of the Senators, and extra compensation allowed by law to the President Pro Tempore of the Senate.

For the payment of the mileage of the Senators.

For the payment of the postage allowed by law to each Senator, the sum of fifty dollars (\$50.00).

To the chief clerk and assistants for the payment of postage, the sum of seventy-five dollars (\$75.00).

To the chief clerk for the payment of the postage on the Legislative Journal, bills and calendars, the sum of two thousand dollars (\$2,000).

For the payment of the salaries of the officers and employes of the Senate during and for the completion of the work of the extraordinary session, also for the payment of the mileage of the officers and employes of the Senate.

For the payment of the expenses of the Committee on Appropriations of the Senate, special session of one thousand nine hundred thirty-one, the sum of one thousand five hundred dollars (\$1,500), or as much thereof as may be necessary, to be paid on warrant of the Auditor General drawn in favor of the chairman of

the committee, on the presentation of his requisition for the same; the chairman to file an account with the Auditor General thirty days after the adjournment of

the special session of the Legislature.

For the contingent expenses, including extra clerical and stenographic charges, of the President Pro Tempore of the Senate during the period of the extraordinary session, the sum of five hundred dollars (\$500.00), or so much thereof as may be necessary; and for the payment of the necessary expenses, including extra labor, in the office of the chief clerk, during the extraordinary session, the sum of six thousand dollars (\$6,000), or so much thereof as may be necessary.

To the chief clerk of the Senate for the payment of extra services in connection with the compilation of the history of legislation in the Senate during the extraordinary session, the sum of five hundred dollars

(\$500.00).

TO THE HOUSE OF REPRESENTATIVES

The total sum of two hundred and fifty-eight thousand nine hundred thirty-one dollars twenty-four cents (\$258,931.24), or as much thereof as may be necessary, to be paid in the manner prescribed by law.

For the payment of the salaries of the Members of the House of Representatives, and extra compensation

allowed by law to the Speaker of the House.

For the payment of mileage of the Members.

For the postage allowed by law to each Member, the sum of fifty dollars (\$50.00).

To the chief clerk and assistants for the payment of postage, the sum of seventy-five dollars (\$75.00).

To the chief clerk for the payment of the postage on the Legislative Journal, bills and calendars, the sum of five thousand dollars (\$5,000).

For the payment of the salaries of the officers and employes of the House of Representatives during and for the completion of the work of the extraordinary session, also for the payment of the mileage of the officers and employes of the House of Representatives.

For the payment of the expenses of the Committee on Appropriations of the House of Representatives, special session of one thousand nine hundred thirty-one, the sum of two thousand six hundred dollars (\$2,600), or so much thereof as may be necessary, to be paid on warrant of the Auditor General drawn in favor of the chairman of the committee, on the presentation of his requisition for the same; said chairman to file an account with the Auditor General within thirty days after the adjournment of the special session of the Legislature.

For the contingent expenses, including extra clerical and stenographic charges, of the Speaker of the House of Representatives during the period of the extraordinary session, the sum of five hundred dollars

(\$500.00), or so much thereof as may be necessary: and for the payment of the necessary expenses, including extra labor, in the office of the chief clerk during the extraordinary session, the sum of ten thousand dollars (\$10,000), or as much thereof as may be necessary.

LEGISLATIVE JOURNAL

For payment to the chief clerk of the Senate and chief clerk of the House of Representatives for making indices of the journal of each house, for the extraordinary session, the sum of five hundred dollars (\$500.00).

For the work of the Legislative Journal officials, after the close of the extraordinary session, on the Legislative Journal, also proofreading of appendix and index thereto as provided by law, the sum of one thousand five hundred dollars (\$1,500).

For the payment of the person or persons appointed to index the Legislative Journal of the extraordinary session, in accordance with the act establishing said journal, the sum of five hundred dollars (\$500.00).

AN ACT

To amend section one of the act, approved the seventh day of May, one thousand nine hundred thirty-one (Act Number Seventy-seven), entitled "A supplement to the Act, approved the second day of May, one thousand nine hundred and twenty-nine (Pamphet Laws, one thousand five hundred thirty), entitled 'An act relating to the erection of a dam at the outlet of Pymatuning Swamp, and the establishment of a reservoir for the flood control of the Shenango and Beaver Rivers; conferring and continuing certain powers and duties on the Department of Forests and Waters in relation to the establishment and maintenance of such reservoir; providing for the acquisition of necessary lands therefor, and the necessary agreements and releases relating thereto, and the disposition of surplus land and materials,' authorizing the construction of a dam and spillway at the outlet of Pymatuning Swamp on lands acquired therefor, and making an appropriation to the Department of Forests and Waters."
