

Supplies for the construction, additions and alterations of buildings for the Torrance State Hospital, at Torrance, Pennsylvania, contained in section one of the act, approved the thirteenth day of June, one thousand nine hundred thirty one (Act Number Eighteen-A), under the heading "Hospitals for the Insane," be and the same is hereby amended to read as follows:

For the erection and construction of new buildings and for additions and alterations to or replacement of existing buildings, *for the construction of a dam and for the acquisition of the lands necessary for the construction of the dam*, for the Torrance State Hospital, at Torrance, Pennsylvania, the sum of five hundred fifteen thousand dollars (\$515,000).

A SUPPLEMENT

To the act, approved the eleventh day of June, one thousand nine hundred thirty-one (Act Number Fifteen-A), entitled "An act to provide for the ordinary expenses of the Executive, Legislative, and Judicial Departments of the Commonwealth, interest on the public debt, and the support of the public schools, for two years beginning June first, one thousand nine hundred and thirty-one; and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending May thirty-first, one thousand nine hundred and thirty-one," making additional appropriations to the Department of Military Affairs and to the Department of Welfare.

Section 1. Be it enacted, &c., That in addition to the appropriation made by the act, approved the eleventh day of June, one thousand nine hundred thirty-one, known as "The General Appropriation Act of one thousand nine hundred thirty-one" (Act Number Fifteen-A), to the Department of Military Affairs for the use of the State Veterans Commission, an additional sum of one hundred thousand dollars (\$100,000) is hereby appropriated to the Department of Military Affairs for the use of the State Veterans Commission in furnishing funds to provide the necessities of life for and to assist otherwise such Pennsylvania veterans of any war, or the widows and infant children or dependents of such veterans, as are sick, disabled, indigent or unemployed and who are in need and have no relatives or other persons legally liable and able to support them.

the use of State medical and surgical hospitals, the sum of two hundred fifty thousand dollars (\$250,000) is hereby appropriated to the Department of Welfare to be used by it for the maintenance of the several State medical and surgical hospitals, including the payment of salaries, wages or other compensation of the superintendents and other employes; for the expense and operation of automobiles and other equipment; for the payment to the Department of Property and Supplies of mileage charges for the use of automobiles; for the purchase of supplies, food and fuel; for minor repairs for the replacement of equipment, furniture and furnishings; for expenses of boards of trustees, and incidental expenses; and for all other expenses of maintenance and operation necessary for the proper conduct of the work of the said hospitals. The amounts of this appropriation to be expended by the Department of Welfare for the use of any particular State medical and surgical hospital shall be allocated and, from time to time, re-allocated by the department, with the approval of the Governor, and certified to the Auditor General and State Treasurer, who shall disburse the amounts allocated and re-allocated to the several State medical and surgical hospitals as in the case of appropriations made to the Department of Welfare for the use of particular State medical and surgical hospitals.
