AN ACT

Exempting the net amount payable under policies of accident and disability insurance from the claims of creditors.

Accident and disability insurance.

Exemption from claims of creditors.

When effective.

Section 1. Be it enacted, &c., That the net amount payable to any insured or any beneficiary under any policy of accident or disability insurance, or under accident or disability clauses attached to any policy of life insurance, shall be exempt and free and clear from the claims of all creditors of such insured or beneficiary, and from all legal and judicial processes of execution, attachment, or otherwise whatsoever.

Section 2. This act shall become effective immediately upon final enactment.

AN ACT

Fixing the compensation and mileage of jury commissioners in counties of the sixth class.

Counties of sixth class.

Compensation and mileage of jury commissioners.

Act of May 8, 1929 (P. L. 1634), repealed.

Section 1. Be it enacted, &c., That hereafter the compensation of the jury commissioners in counties of the sixth class shall be six dollars per diem for each and every day, not exceeding sixty-five days in any year, necessarily employed in the discharge of their duties, together with six cents per mile circular from and to their homes once each and every week so employed.

Section 2. The act approved the eighth day of May, one thousand nine hundred and twenty-nine (Pamphlet Laws, one thousand six hundred thirty-four), entitled "An act fixing the compensation and mileage of auditors and jury commissioners in counties of the sixth class," is hereby repealed in so far as it fixes the compensation of jury commissioners in counties of the sixth class.

To repeal the act, approved the eighth day of July, one thousand nine hundred nineteen (Pamphlet Laws, seven hundred seventy), entitled "An act creating a Division of Township Highways in the State Highway Department; conferring powers, and im-

posing duties upon officers of the State Highway Department; requiring certain duties of clerks of the courts of quarter sessions; and providing penalties."

Section 1. Be it enacted, &c., That the act approved the eighth day of July, one thousand nine hundred nineteen (Pamphlet Laws, seven hundred seventy), entitled "An act creating a Division of Township Highways in the State Highway Department; conferring powers, and imposing duties upon officers of the State Highway Department; requiring certain duties of clerks of the courts of quarter sessions; and providing penalties," and the amendments thereto, be and the same is hereby repealed.

AN ACT

Establishing portions of certain highways lying partially within the corporate limits of cities, boroughs, or incorporated towns as State highways; and providing for their construction and maintenance at the expense of the Commonwealth.

Section 1. Be it enacted, &c., That where the boundary line of any city, borough, or incorporated town is located within the legal limits of a highway established as a State highway, the portion of the highway within the corporate limits of the city, borough, or incorporated town is hereby established as a State highway, and shall be constructed and maintained by the Department of Highways in accordance with the provisions of existing laws governing State highways in cities or boroughs.

State highways.

Boundary highways partly within corporate limits.

Construction and maintenance

Section 2. As much of the money in the Motor License Fund as may be necessary to carry out the provisions of this act is hereby specifically appropriated to the Department of Highways for the purpose of this act.

Appropriation.

Section 3. All acts or parts of acts inconsistent with this act be and the same are hereby repealed.

Repeal.

Section 4. This act shall become effective upon its approval by the Governor.
