## AN ACT

To further amend section 21 of the act, approved the seventh day of June, one thousand nine hundred and fifteen (Pamphlet Laws, nine hundred), entitled "An act to provide for the immediate registration of all births and deaths throughout the Commonwealth of Pennsylvania, by means of certificates of births and deaths, and burial or removel permits; requiring prompt returns to the Central Bureau of Vital Statistics, as required to be established by the State Department of Health; and, in order to secure prompt and faithful registration of births, marriages, deaths, and diseases, of practitioners of medicine and surgery, of midwives, nurses, and undertakers, and of all persons whose occupation is deemed to be of importance in obtaining complete registration of births, deaths, marriages, and diseases throughout the State, as provided in section ten of an act, entitled "An act creating the Department of Health and defining its powers and duties," approved the twenty-seventh day of April, nineteen hundred and five, and providing penalties for violations of this act," by increasing the fee to be charged by the Department of Health for certified copies of records of births, deaths, or marriages.

Section 21. That the [State Registrar] Department of Health shall, upon request, furnish any applicant a certified copy of the record of any birth, death, or marriage registered under provisions of this act, for the making and certification of which he shall be entitled to a fee of [fifty cents] one dollar to be paid by the applicant; and any such copy of the record of a birth, or death, or marriage, when properly certified by the [State Registrar] Department of Health to be a true
