(b) White bass, rock-bass, crappie, strawberry or calico bass, fifteen;

(c) Small or large mouth bass, ten;

(d) Pike-perch, otherwise called wall-eyed pike, or Susquehanna salmon, ten;

(e) Pickerel, fifteen;

(f) Muscallonge, western and northern pike, three;

(g) Yellow perch, twenty-five;(h) Sunfish, twenty-five;

- (i) Catfish, twenty-five; (j) Suckers, twenty-five;
- (k) Chubs, twenty-five;
- (1) Fallfish, twenty-five:

(m) Rockfish or striped-bass, five;

(n) All other species of fish, including bait fish, not specifically mentioned in this section, except eels, fifty.

Section 2. This act shall become effective immediately when effective. upon final enactment.

## AN ACT

To amend section seven hundred and eighteen of the act, approved the twenty-fourth day of May, one thousand nine hundred and twenty-three (Pamphlet Laws, three hundred fifty-nine), entitled "An act concerning game and other wild birds and wild animals; and amending, revising, consolidating, and changing the law relating thereto," as amended, by permitting dogs to work on liberated or native wild game animals in field meets; and changing the fees for permits therefor.

Section 1. Be it enacted, &c., That section seven hundred and eighteen of the act, approved the twenty-fourth (P. L. 359), as (P. L. 359), as manded by day of May, one thousand nine hundred and twentythree (Pamphlet Laws, three hundred fifty-nine), en- section 1, act of June 9, 1931 titled "An act concerning game and other wild birds, and wild animals; and amending, revising, consolidating, and changing the law relating thereto," as amended by section one of the act, approved the ninth day of June, one thousand nine hundred and thirty-one (Pamphlet Laws, four hundred fifty-five), is hereby further amended to read as follows:

Training of Dogs on Certain Game.— Section 718. During the period between one hour before sunrise and ten o'clock post meridian, eastern standard time, dogs, when accompanied by and under control of their owner or handler, may be trained upon any game in this Commonwealth, excepting elk or deer or wild turkey, from the twentieth day of August to the last day of February next following, Sundays excepted, so long as no firearms usually raised at arm's length and fired from the shoul-

der are carried and no injury is inflicted upon said animals or birds. This section does not prohibit the training of dogs on raccoons during the nighttime. It shall also be lawful to hold field meets or trials for dogs with led game animals, at any time between the first day of March and the twentieth day of August next following, or field meets where [bird] dogs are permitted to work on liberated or native wild game [birds] in exhibition or contest, at any time during daylight hours, from the first day of March to the thirty-first day of March of each year, Sundays excepted, if a permit for such field meet of either kind or class has been applied for to the Board of Game Commissioners and issued by the board, and a fee of [twenty] five dollars [\$20] (\$5) has been paid by the applicant to the executive secretary of the board, whose duty it shall be to supervise the holding of such field meet, and to enforce the terms of the permits therefor, and the rules and regulations of the board for the holding of such meets. "Under control" is hereby defined to mean within call except when actually on a trail or track of legal game.

Any person who shall train a dog or dogs, or permit a dog or dogs under his control, to pursue or follow upon the track of any small game, contrary to the foregoing provisions, shall be liable to a fine of ten dollars

for each offense.
