AN ACT

To amend section two of the act, approved the first day of June, one thousand nine hundred and thirty-three (Pamphlet Laws, eleven hundred seventy-two), entitled "An act establishing certain streets in boroughs and incorporated towns as State highways, and providing for their construction and maintenance at the expense of the Commonwealth," as amended, by changing certain routes and adding certain new routes.

Section 1. Be it enacted, &c., That the following routes, established by the act, approved the first day of June, one thousand nine hundred and thirty-three (Pamphlet Laws, one thousand one hundred seventy-two), entitled "An act establishing certain streets in boroughs and incorporated towns as State highways, and providing for their construction and maintenance at the expense of the Commonwealth," are hereby amended to read as follows:

Ambridge Borough

Route 04089. Extending Route 04089.—Beginning at a point on the Ambridge Borough-Harmony Township line, [and extending over Fourth Street] *thence over Wilson Avenue and Glenwood Road to an intersection with Route 641, at [Fourth Street] Glenwood Road and Duss Avenue, in Ambridge Borough, Beaver County, a distance of about [0.2] 0.6 of a mile.*

Darlington Borough

[Route 04007. Extending Route 04007.—Beginning at a point on the Darlington Borough-Darlington Township line, thence in a northerly direction on Plum Street for a distance of forty feet, thence in a westerly direction on First Street to an intersection with Route 204 in the borough of Darlington, Beaver County, a distance of about 0.07 of a mile.]

New Brighton Borough

Route 04081. Extending Route 04081.—Beginning at a point on the New Brighton Borough-Pulaski Township line, thence in a southerly direction to an intersection with Allegheny Street, thence in a westerly direction on Allegheny Street to its intersection with Ninth Street, thence in a southwesterly direction on Ninth Street to *the new location of Route 77, in the borough of New Brighton, Beaver County, a distance of about [.63] 0.7 of a mile.*

Route 482. Extending Route 482.—Beginning on Route 482 at the New Brighton Borough line, thence over Mercer Avenue and Fifth Street to the intersection of Fifth Street and *the new location of State Highway Route 77, in the borough of New Brighton, Beaver County, a distance of about [0.97 of a] 1.0 mile.*

Canton Borough

Route 08036. Extending Route 08036.—Beginning at a point on the Canton Borough-Canton Township line, thence in a southeasterly direction on [Upper Mountain Road] *Fall Brook Street* to an intersection with Route 20, at [Upper Mountain Road] *Fall Brook Street* and Troy Street, in the borough of Canton, Bradford County, a distance of about .33 of a mile.

Vandling Borough

Route 35039. Extending Route 35039.—Beginning at a point on the Vandling Borough-Fell Township line, thence in a [northwesterly] *northerly* direction on the Northwest Road, thence in a [westerly] *northerly* direction on Clinton Street, [thence in a northerly direction on Oak Street] to an intersection with [a county road] *Route 35047*, in the borough of Vandling, Lackawanna County, a distance of about [.86 of a mile] *1.15 miles*.

Coopersburg Borough

Route 39008. Extending Route 39008.—Beginning at a point on the Coopersburg Borough-Upper Saucon Township line, thence in a southwesterly and westerly direction on Station Avenue to an intersection with Route 153-*Spur*, at Station Avenue and [Third] *Main Street*, in the borough of Coopersburg, Lehigh County, a distance of about [.38] *0.7* of a mile.

Duryea and Avoca Boroughs

Route 40104. Beginning at a point on Route [40103 at Foote Avenue and McAlpine Streets] *35055 at Phoenix and Main Streets*, in the borough of Duryea; thence over *Phoenix Street and McAlpine Street* in the boroughs of Duryea and [Hughestown] *Avoca* to an intersection with Route 5, at McAlpine and Main Streets, in Avoca, Luzerne County, a distance of about [1.1] *1.9* miles.

Sharpsville Borough

Route 43008. Extending Route 43008.—Beginning at a point on the Sharpsville Borough-Hickory Township line, thence in a northerly direction on Mercer Avenue to an intersection with Route [238] *43081*, at Mercer Avenue and [Walnut] *Main Street*, in the borough of Sharpsville, Mercer County, a distance of about [.7 of a mile] *one mile*.

Kulpmont Borough

Route 49085. Extending Route 49085.—Beginning at a point at or near the intersection of the northern line of Kulpmont Borough and the western line of Marion Heights Borough; thence in a southerly direction on

[Eleventh] *Sixth* Street to a point on Route 161, in the borough of Kulpmont, Northumberland County, a distance of about [0.03] *0.42* of a mile.

Route 49087. Extending Route 49087.—Beginning at a point on the Mount Carmel Township-Kulpmont Borough line; thence northerly on [Eighth] *Sixth* Street to an intersection with Route 161, at [Eighth] *Sixth* and Chestnut Streets, in the borough of Kulpmont, Northumberland County, a distance of about [0.08] *0.13* of a mile.

Penn Borough

[Traffic Route 193.] Application 5562. Beginning at a point on the Penn Borough-Hempfield Township line, thence in an easterly direction on [Application 5561 on] Coal Street to an intersection with [the continuation of Rural] Route 64096, at the intersection of [Harrison] *Youghioghenny* Street and Coal Street, in the borough of Penn, Westmoreland County, a distance of about [0.02] *.21* of a mile.

Route 64026. Extending Route 64026.—Beginning at a point on the Penn Borough-Penn Township line, thence in an easterly direction on Emma Street to a intersection with Harrison Street, thence in a [southerly] *northerly* direction on Harrison Street to an intersection with [Application 5561 or Coal] *Locust* Street, thence in an easterly direction on [Application 5561] *Locust Street* to an intersection with [the continuation of Rural] Route [64096 or Youghioghenny Street] *64233*, at *Locust and Eleventh Streets*, in the borough of Penn, Westmoreland County, a distance of about .53 of a mile.

Penn and Jeannette Boroughs

Route 64096. Extending Route 64096.—Beginning at a point on the Penn Borough-Hempfield Township line, thence in a northerly direction on Youghioghenny Street to an intersection with [Application 5561 or] Coal Street, [or the continuation of Rural Route 64026] *thence easterly on Coal Street to the Jeannette Borough line; thence easterly on Penn Avenue to Twelfth Street; thence north on Twelfth Street to Clay Avenue extension; thence east on Clay Avenue extension to Ninth Street; thence south on Ninth Street to Magee Avenue; thence east on Magee Avenue to a point on Route 64216, at Magee Avenue and Second Street*, in the [borough] *boroughs* of Penn and Jeannette, Westmoreland County, a distance of about [.05 of a mile] *2.0 miles*.

Scottdale Borough

Route 64126. Extending Route 64126.—Beginning at a point on the Scottdale Borough-East Huntingdon Township line, thence in a westerly direction on [the

Mount Pleasant-Scottdale Road] *Porter Avenue* to an intersection with Route 117, or Broadway Avenue, in the borough of Scottdale, Westmoreland County, a distance of about [.72] .2 of a mile.

Stewartstown Borough

Route 66119. Extending Route 66119.—Beginning at a point on the Hopewell Township-Stewartstown Borough line; *thence northeasterly over a borough street to Hill Street*; *thence easterly* over Hill Street to an intersection with Route 66011, at Hill and Mill Streets, in the borough of Stewartstown, York County, a distance of about 0.43 of a mile.

line; thence in an easterly direction on Mellon Street to an intersection with Route 221, in Patton Borough, Cambria County, a distance of about 0.14 of a mile.

Route 14016. Extending Route 14016.—Beginning at a point on the State College Borough-College Township line; thence in a southwesterly direction on East Park Avenue and West Park Avenue to a point on Route 404, at the intersection of West Park Avenue and Atherton Street, in the borough of State College, Centre County, a distance of about 0.85 of a mile.

CHESTER COUNTY

Atglen Borough

Route 15206. Extending Route 15206.—Beginning at a point on the west line of Atglen Borough about 0.1 of

a mile north of the West Fallowfield Township line; thence easterly over a borough street to a point on Route 215 about 0.1 of a mile north of the West Fallowfield Township line, in the borough of Atglen, Chester County, a distance of about 0.4 of a mile.

West Grove Borough

Route 15220. Extending Route 15220.—Beginning at a point on the north borough line of West Grove Borough; thence south over a borough street to a point on Route 131, in the borough of West Grove, Chester County, a distance of about 0.4 of a mile.

Extending Route 19098.—Beginning at a point on the Briar Creek Township-Berwick Borough line; thence in a southerly direction on Cemetery Road to Freas Avenue; thence easterly on Freas Avenue to its intersection with Route 19045, at Freas Avenue and Dickson Street, in Berwick Borough, Columbia County, a distance of about 1.2 miles.

Extending Route 66153.—Beginning at a point on the East Manchester Township-Mount Wolf Borough line; thence in a southwesterly direction over Main Street to an intersection with Route 716, at Main and Centre Streets, in the borough of Mount Wolf, York County, a distance of about 0.3 of a mile.

Red Lion Borough

Route 66181. Extending Route 66181.—Beginning at the York Township-Red Lion Borough line; thence easterly on West High Street to Application 402, at West High and North Main Streets, in the borough of Red Lion, York County, a distance of about 0.5 of a mile.

Yoe Borough

Route 66181. Extending Route 66181.—Beginning at the York Township-Yoe Borough line; thence northwesterly on South George Street to Route 66004, at South George and Main Streets, in the borough of Yoe, York County, a distance of about 0.25 of a mile.

York Haven Borough

Route 66153. Extending Route 66153.—Beginning at the East Manchester Township-York Haven Borough line; thence northerly, westerly, and northerly over Locust Street to Landvale Avenue; thence southwesterly over Landvale Avenue to an intersection with Route 250, at Landvale Avenue and Pennsylvania Avenue, in the

borough of York Haven, York County, a distance of about 0.6 of a mile.

Route 66184. *Extending Route 66184.—Beginning at the Newberry Township-York Haven Borough line; thence northerly over Dover Road to an intersection with Route 250, at Dover Road and Landvale Avenue, in the borough of York Haven, York County, a distance of about 0.02 of a mile.*

Route 66185. *Extending Route 66185.—Beginning at the Newberry Township-York Haven Borough line; thence southeasterly over Goldsboro Road to an intersection with Route 66153, at Goldsboro Road and Landvale Avenue, in the borough of York Haven, York County, a distance of about 0.3 of a mile.*

Section 3. This act shall become effective on the first day of January, one thousand nine hundred and thirty-eight. When effective.

AN ACT

To amend section one of the act, approved the twenty-second day of June, one thousand nine hundred and thirty-five (Pamphlet Laws, four hundred fifty), entitled "An act to promote public morals; abolishing civil causes of action for alienation of affections, except in certain cases, and breach of promise to marry; making it unlawful to file, cause to be filed, threaten to file, or threaten to cause to be filed any such action; fixing a time for the commencement of such causes of action heretofore accrued; declaring void all future contracts in settlement of such actions; making it unlawful to induce the execution of such a contract or payment thereunder or institution of suit thereon; and providing penalties," correcting an error in said section.

Section 1. Be it enacted, &c., That section one of the act, approved the twenty-second day of June, one thousand nine hundred and thirty-five (Pamphlet Laws, four hundred fifty), entitled "An act to promote public morals; abolishing civil causes of action for alienation of affections, except in certain cases, and breach of promise to marry; making it unlawful to file, cause to be filed, threaten to file, or threaten to cause to be filed any such action; fixing a time for the commencement of such causes of action heretofore accrued; declaring void all future contracts in settlement of such actions; making it unlawful to induce the execution of such a contract or payment thereunder or institution of suit thereon; and providing penalties," is hereby amended to read as follows:
