Penalty.—Any person operating or moving a tractor or trailer and its load, of a size or weight exceeding the maximum specified in this act, without first having obtained a permit or permits so to do, shall, upon summary conviction before a magistrate, be sentenced to pay a fine of fifty (\$50) dollars, and, in default of the payment thereof, shall undergo imprisonment for not more than ten (10) days.

## AN ACT

To further amend subsection (c) of section four hundred twelve of the act, approved the third day of June, one thousand nine hundred thirty-seven (Pamphlet Laws, one thousand three hundred thirty-three), entitled "An act concerning elections, including general, municipal, special and primary elections, the nomination of candidates, primary and election expenses and election contests; creating and defining membership of county boards of elections; imposing duties upon the Secretary of the Commonwealth, courts, county boards of elections, county commissioners; imposing penalties for violation of the act, and codifying, revising and consolidating the laws relating thereto; and repealing certain acts and parts of acts relating to elections," fixing the milage of judges of election for transmitting returns of primaries and elections and ballot boxes.

Pennsylvania Election Code.

Subsection (c) of section 412, act of June 3, 1937, P. L. 1333, as amended by act of June 15, 1939, P. L. 376, further amended.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Subsection (c) of section four hundred twelve of the act, approved the third day of June, one thousand nine hundred thirty-seven (Pamphlet Laws, one thousand three hundred thirty-three), entitled "An act concerning elections, including general, municipal, special and primary elections, the nomination of candidates, primary and election expenses and election contests; creating and defining membership of county boards of elections; imposing duties upon the Secretary of the Commonwealth, courts, county boards of elections, county commissioners; imposing penalties for violation of the act, and codifying, revising and consolidating the laws relating thereto; and repealing certain acts and parts of acts relating to elections," as amended by the act, approved the fifteenth day of June, one thousand nine hundred thirty-nine (Pamphlet Laws, three hundred seventy-six), is hereby further amended to read as follows:

Section 412. Compensation of Election Officers.—

\* \* \* \* \*

(c) For transmitting returns of primaries and elections and the ballot box or boxes, all judges of election shall be entitled to receive the additional sum of two dollars and fifty cents (\$2.50) and [three cents (\$.03)] five cents (\$.05) per mile for mileage, as full compensation for said services.

## AN ACT

To amend section seven hundred sixteen of the act, approved the third day of June, one thousand nine hundred thirty-seven (Pamphlet Laws, one thousand two hundred twenty-five), entitled "An act concerning game and other wild birds and wild animals; and amending, revising, consolidating, and changing the law relating thereto," authorizing the sale and purchase of hides of lawfully killed deer under certain circumstances, and making it unlawful to buy or sell raccoons for propagating purposes.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section seven hundred sixteen of the act, Section 716, act approved the third day of June, one thousand nine hun-of June 3, 1937, P. L. 1225, dred thirty-seven (Pamphlet Laws, one thousand two amended. hundred twenty-five), entitled "An act concerning game and other wild birds and wild animals; and amending, revising, consolidating, and changing the law relating thereto," is hereby amended to read as follows:

Section 716. Buying and Selling Game.—Except as Buying, selling otherwise provided by this act, it is unlawful for any person, at any time, to buy, sell, or barter, or offer for sale or barter, or have in possession for sale or barter, any game, or parts thereof, no matter where such game has been killed, excepting deer or rabbits killed in an- Exception. other state or nation, or the skins of raccoons and bears, no matter where killed, and other game legally killed and imported from another state or nation when tagged as herein required.

Except as otherwise provided by this act, it is unlawful for any person, at any time, to sell or barter, or offer for sale or barter, for human consumption, any species of game, or parts thereof, protected by this act or similar thereto, imported either dead or alive from another state or nation, except deer or rabbits, unless the carton containing such birds or animals, or the individual carcasses, shall have attached a tag identifying

Tagging imported game.
