

nine hundred fifty-three (Pamphlet Laws 1169), is amended to read:

Section 2561. Tuition Charges for Pupils of Other Districts.—A school district or vocational school district receiving elementary or high school pupils or vocational or other extension education pupils who are residents of another school district or another vocational school district shall compute the tuition charges as follows:

\* \* \* \* \*

(3) High School Tuition Charge. Add the salaries of supervisors, principals, clerks, assistants and teachers employed in the receiving district's high schools, the district's contribution to the retirement fund on behalf of teachers, supervisors and principals employed in the district's high schools, the cost of textbooks and supplies of the second class used in the district's high schools, and divide the sum so obtained by the total number of pupils in average daily membership in the receiving district's high schools. The quotient so obtained shall be designated as the "instruction cost per high school pupil." Add to the instruction cost per high school pupil the overhead cost per pupil and a rental charge of [ten dollars (\$10)] *eighteen dollars (\$18) per pupil* for the use of the receiving district's school plant. For the school years 1952-1953 and 1953-1954 only, but not thereafter, deduct from the amount so obtained the per pupil State appropriation on account of high school teaching units. The cost so determined shall be the "tuition charge per high school pupil."

AN ACT

Authorizing the Department of Property and Supplies, with the approval of the Governor, to sell and convey 84.69 acres, more or less, of land, situate in Butler Township, Adams County.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The Department of Property and Supplies, with the approval of the Governor, is hereby authorized on behalf of the Commonwealth of Pennsylvania, to sell at public sale to the highest bidder, the following described tract of land situate in the Township of Butler, County of Adams and Commonwealth of Pennsylvania, bounded and described as follows; to wit:

Beginning at a point in a public road on a line of Frank Newell and Herbert H. & Jesse F. Deckert, which

point is ascertained by measuring along a line in said road from an angle in said road at the intersection of the land of Bert Carey and Frank Newell, south 35 degrees west a distance of 895 feet; thence from said beginning point so ascertained by a line, south 39 degrees 45 minutes east a distance of 1450 feet to an iron pin; thence south 3 degrees 30 minutes west a distance of 290 feet to an iron pin; thence by a line south 43 degrees west a distance of 607 feet to an iron pin on a line of land now or formerly of Joseph Lopp; thence along said last mentioned line south 56 degrees east a distance of 830 feet to an iron pin on the line of the Philadelphia and Reading Railroad; thence along said railroad north 39 degrees 30 minutes east a distance of 405 feet to an iron pin; thence continuing along said railroad north 35 degrees 45 minutes east 1410 feet to an iron pin in an abandoned road; thence along said abandoned road and land now or formerly of Allen Thoman, north 36 degrees 30 minutes west a distance of 700 feet; thence along said abandoned road and line of Geiman and Ondorff, north 36 degrees west a distance of 1227 feet to an iron pin in said road; thence continuing along said road and line of land now or formerly of Geiman and Ondorff and Harry Van Dyke, north 12 degrees west 235 feet to a pin in the first mentioned public road; thence continuing along said public road and line of T. J. Moran, south 79 degrees 30 minutes west 435 feet to an iron pin; thence continuing in said road by a course north 17 degrees west 16½ feet to an iron pin on line of Bert Carey and T. J. Moran; thence along line of said Bert Carey and continuing in said road, south 53 degrees west 205 feet to an iron pin on line of land of Frank Newell and Bert Carey; thence continuing along said public road and land of Frank Newell, south 35 degrees west a distance of 895 feet to an iron pin at the place of beginning.

Being part of the same premises which E. R. Harbaugh and Annie N. Harbaugh his wife, by their deed dated April 2nd, 1917 and of record in the Recorders Office in Deed Book, Vol. 78 page 275, granted and conveyed unto Herbert H. Deckert and Jesse F. Deckert, parties of the first part hereto.

The conveyance shall be made under and subject to all easements, servitudes and rights of others, including but not confined to streets, roadways, and rights of any telephone, telegraph, water, electric, gas or pipe line companies, as well as under and subject to any estates

or tenancies vested in third persons, whether or not appearing of record, for any portion of the land or improvements erected thereon.

Section 2. The deed of conveyance shall be approved by the Department of Justice, and shall be executed by the Department of Property and Supplies in the name of the Commonwealth of Pennsylvania.

Section 3. All moneys received from the sale of the land shall be deposited in the General Fund.

Disposition of proceeds.

Section 4. This act shall take effect immediately.

AN ACT

Amending the act of May sixteen, one thousand nine hundred twenty-one (Pamphlet Laws 579), entitled, as amended, "An act providing for the better management of the jails or county prisons in the several counties of this Commonwealth of the third, fourth and fifth classes by creating, in such counties, a board to be known by the name and style of inspectors of the jail or county prison, with authority to appoint a warden of such prison, and by vesting in said board, and the officers appointed by it, the safe-keeping, discipline, and employment of prisoners and the government and management of said jails or county prisons," further regulating the expenditures of moneys by the board without advertising and awarding of contracts.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Jails and prisons—third, fourth and fifth class counties.

Section 1. Section three, act of May sixteen, one thousand nine hundred twenty-one (Pamphlet Laws 579), entitled, as amended, "An act providing for the better management of the jails or county prisons in the several counties of this Commonwealth of the third, fourth and fifth classes by creating, in such counties, a board to be known by the name and style of inspectors of the jail or county prison, with authority to appoint a warden of such prison, and by vesting in said board, and the officers appointed by it, the safe-keeping, discipline, and employment of prisoners and the government and management of said jails or county prisons,"
