The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: The Vehicle Code.

Section 1. Section 805, act of May 1, 1929 (P. L. 905), known as "The Vehicle Code," is amended by adding, after subsection (d), a new subsection to read: Section 805, act of May 1, 1929, P. L. 905, amended by adding a new subsection (e).

Section 805. Use, Test and Approval of Lamps.—

* * * * *

(e) The secretary shall have the authority to give tentative approval of equipment upon receipt of the manufacturer's laboratory report.

AN ACT

Amending the act of May 1, 1929 (P. L. 905), entitled "An act for the protection of the public safety; regulating the use of highways and the operation of vehicles, tractors, street cars, trackless trolley omnibuses, bicycles, pedestrians, and the riding of animals upon the highways of this Commonwealth; providing for the titling, including liens, encumbrances, and legal claims; registration of certain vehicles and licensing the operators thereof, upon payment of prescribed fees; prescribing and limiting the powers of local authorities to deal with the subject matter of this act; conferring powers and imposing duties upon the Department of Revenue, the Department of Highways, peace officers, mayors, burgesses, magistrates, aldermen, justices of the peace, the courts and the clerks thereof, owners of vehicles, and garage keepers; providing that records are admissible as evidence; imposing upon owners, counties, cities, boroughs, incorporated towns, townships, within the Commonwealth, liability for damages caused by the negligent operation of their motor vehicles; imposing penalties; imposing certain costs upon counties; providing for the disposition of fines, forfeitures, fees, and miscellaneous receipts; making an appropriation and providing for refunds," further regulating school bus lighting equipment.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: The Vehicle Code.

Section 1. Clause (9) of subsection (b) of section 828, act of May 1, 1929 (P. L. 905), known as "The Vehicle Code," added May 26, 1949 (P. L. 1884), is amended to read:

Section 828. School Buses; Safety Requirements.—

* * * * *

(b) No person shall own or operate a school bus carrying school children on the highways of this Commonwealth in a school bus that, in addition to the other requirements of this act, does not conform with the following:

* * * * *

(9) Every school bus shall, [be equipped with two electrical or mechanical stop signal devices, one to the front and one to the rear thereof, in addition to the stop signal devices otherwise required by this act.] *in addition to any other equipment and distinctive markings required by this act, be equipped with one signal lamp visible from the front and one other visible from the rear, each showing a flashing red light. Each lamp shall be mounted as high as practicable upon the body of the bus.* Each such additional device shall be plainly visible to operators of approaching vehicles in normal sunlight and at night from a distance of one hundred (100) feet to the front or rear, as the case may be, shall not project a glaring light, and shall be of types approved by the secretary.

AN ACT

Amending the act of May 4, 1927 (P. L. 519), entitled "An act concerning boroughs, and revising, amending, and consolidating the law relating to boroughs," providing for the term of office of a borough manager to be determined by the borough council.

The Borough Code.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1140, act of May 4, 1927, P. L. 519, reenacted and amended July 10, 1947, P. L. 1621, and amended July 19, 1951, P. L. 1026, further amended.

Section 1. Section 1140, act of May 4, 1927 (P. L. 519), known as "The Borough Code," reenacted and amended July 10, 1947 (P. L. 1621), and amended July 19, 1951 (P. L. 1026), is amended to read:

Section 1140. Borough Manager May Be Created By Ordinance; Election.—The council of any borough may, at its discretion, at any time, create by ordinance the
