The General Assembly of the Commonwealth of **Liquor Code.**
*Pennsylvania hereby enacts as follows:

Section 1. The definition of "population" in section 102, act of April 12, 1951 (P. L. 90), known as the "Liquor Code," is amended to read: **Definition of "population," section 102, act of April 12, 1951, P. L. 90, amended.**

Section 102. Definitions.—The following words or phrases, unless the context clearly indicates otherwise, shall have the meanings ascribed to them in this section:

* * * * *

"Population" shall mean the [population] *number of inhabitants as determined by the last preceding decennial census of the United States, or by any other census subsequently taken by the census bureau of the United States and so certified by it: Provided, however, That such other census shall not be a basis for the fixing of license fees as provided in article IV. sections 405 and 439.*

AN ACT

Consenting to the acquisition by the United States of land, water, or land and water, within the Commonwealth of Pennsylvania for migratory-bird reservations, authorized by Act of Congress of February 18, 1929.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: **Migratory-bird reservations.**

Section 1. Consent of the Commonwealth of Pennsylvania is given to the acquisition by the United States by purchase, gift, devise or lease, of such areas of land or water or of land and water anywhere in the Commonwealth of Pennsylvania, except in the County of **Establishment of reservations by the United States from land of Pennsylvania with certain reservations of power.**

Delaware, as the United States, with the consent of the executive director of the Pennsylvania Game Commission and the Governor, may deem necessary for the establishment of migratory-bird reservations in accordance with the Act of Congress, approved February eighteenth, one thousand nine hundred twenty-nine, entitled "An act to more effectively meet the obligations of the United States under the Migratory Bird Treaty with Great Britain by lessening the dangers threatening migratory game birds from drainage and other causes, by the acquisition of areas of land and of water to furnish in perpetuity reservations for the adequate protection of such birds; and authorizing appropriations for the establishment of such areas, their maintenance and improvement, and for other purposes," reserving, however, to the Commonwealth of Pennsylvania full and complete jurisdiction and authority over all such areas not incompatible with the administration, maintenance, protection and control thereof, by the United States under the terms of said Act of Congress.

Effective
immediately.

Section 2. The provisions of this act shall become effective immediately upon final enactment.
