AN ACT

Amending the act of April 9, 1929 (P. L. 177), entitled "An act providing for and reorganizing the conduct of the executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative departments, boards, commissions, and officers thereof, including the boards of trustees of State Normal Schools, or Teachers Colleges; abolishing, creating, reorganizing or authorizing the reorganization of certain administrative departments, boards, and commissions; defining the powers and duties of the Governor and other executive and administrative officers and of the several administrative departments, boards, commissions, and officers; fixing the salaries of the Governor, Lieutenant Governor, and certain other executive and administrative officers; providing for the appointment of certain administrative officers, and of all deputies and other assistants and employes in certain departments, boards, and commissions; and prescribing the manner in which the number and compensation of the deputies and all other assistants and employes of certain departments, boards and commissions shall be determined," making certain changes in the fiscal period.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

The Administrative Code of 1929.

Section 1. Article VI., act of April 9, 1929 (P. L. 177), known as "The Administrative Code of 1929," is amended by adding, at the end thereof, a new section to read:

Article VI., act of April 9, 1929, P. L. 177, amended by adding a new section 608.

*Section 608. Fiscal Period.—All books and accounts kept by the Auditor General, Secretary of Internal Affairs and the State Treasurer and every department, board and commission shall be kept as of the fiscal year or period. The fiscal period shall begin June 1, 1961, and shall not be deemed ended until June 30, 1962. Thereafter, the fiscal year shall be the period beginning on the first day of July of each calendar year and ending on the thirtieth day of June of the calendar year next succeeding.*

*The Auditor General and the Department of the Auditor General shall submit to any accountants appointed by the Governor for the purpose of making an audit of the affairs of the Auditor General and the Department of the Auditor General all books, papers and records in any way pertaining to such affairs.*

Section 607, act of April 9, 1929, P. L. 177, as amended, repealed.

Section 2. Section 607 of the act of April 9, 1929 (P. L. 177), known as "The Administrative Code of 1929," amended by the acts of May 21, 1943 (P. L. 467) and June 3, 1943 (P. L. 833) is repealed.

Effective date.

Section 3. This act shall take effect June 1, 1961.

AN ACT

Amending the act of July 8, 1957 (P. L. 594), entitled "An act to provide revenue by imposing a State tax upon sales or gifts of cigarettes; requiring persons engaged in the sale of cigarettes to secure licenses; prescribing the method and manner of collecting such tax; making it unlawful to sell or possess cigarettes upon which the tax has not been paid; conferring powers and imposing duties on the Department of Revenue and other persons; making an appropriation and providing penalties," providing that license fees be paid into the General Fund.

Pennsylvania

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 410, act of July 8, 1957, P. L. 594, added December 16, 1959, P. L. 1857, further amended.

Section 1. Section 410, act of July 8, 1957 (P. L. 594), known as the "Pennsylvania Cigarette Tax Act," added December 16, 1959 (P. L. 1857), is amended to read:

Section 410. Disposition of License Fees.—All license fees imposed and collected under the provisions of this act shall be [payable to this Commonwealth and are hereby appropriated to the department to be used for enforcing this act] *paid into the General Fund of the State Treasury.*
