

butterine or other similar substance, not in imitation of yellow butter, is sold at retail from such tub or re-packaged in print, roll or other form before being delivered to the purchaser, it shall be wrapped in wrappers, plainly stamped on the outside thereof, with the word "Oleomargarine" or "*Margarine*" printed or stamped thereon in letters one-fourth inch square, and said wrapper shall also contain the name and address of the seller, and the quantity sold with no other words thereon except the word "Oleomargarine" or "*Margarine*."

AN ACT

Amending the act of March 10, 1949 (P. L. 30), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial schools; amending, revising, consolidating and changing the laws relating thereto," changing assessment provisions relating to certain third class school districts.

Public School
Code of 1949.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 676, act
of March 10,
1949, P. L. 30,
amended.

Section 1. Section 676, act of March 10, 1949 (P. L. 30), known as the "Public School Code of 1949," is amended to read:

Section 676. Property Subject to Tax; Districts Third and Fourth Class.—In all school districts of the third class, excepting school districts of that class which are located wholly within the boundary lines of cities of the third class and where such third class school districts comprise the same territory as such city of the third class in which the same is so located, and in all school districts of the fourth class, the school taxes shall be levied and assessed upon all the property upon which the county taxes are levied and assessed.

In all school districts of the third class which are located wholly within the boundary lines of any city of the third class, and where such third class school district comprises the same territory as such city of the third class in which the same is so located, the school taxes shall be levied and assessed on the real estate and personal property therein as contained in the assessment made for city tax purposes: *Provided, That in any such school district of the third class which is situated within a county of the fourth to the eighth class, the board*

of school directors may, by resolution, accept the provisions of "The Fourth to Eighth Class County Assessment Law" irrespective of whether or not the city has accepted the provisions of such assessment law, and in such case the school taxes shall be levied and assessed upon all the property upon which the county taxes are levied and assessed.

Section 2. This act shall take effect immediately.

AN ACT

Authorizing the Department of Property and Supplies, with the approval of the Governor, to convey to the Borough of Bristol certain real property located in the borough.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Real property.

Section 1. The Department of Property and Supplies, with the approval of the Governor, is authorized, on behalf of the Commonwealth of Pennsylvania, to grant and convey to the Borough of Bristol all those certain parcels of land situate in the Borough of Bristol, County of Bucks, Commonwealth of Pennsylvania, comprising that portion of the Delaware Division of the Pennsylvania Canal, which begins at the northerly boundary line of another part of the canal lying south of Mill Street, in the Borough of Bristol, heretofore granted and conveyed to the Borough of Bristol by the Department of Property and Supplies on behalf of the Commonwealth of Pennsylvania pursuant to the act of May 1, 1947 (P. L. 131), more specifically at the northerly boundary line of Tract No. 2, as described in the Act of Assembly, and which extends northeastwardly and northwardly through the Borough of Bristol to Adams Hollow Creek as more particularly described according to a base line description thereof prepared according to a survey and plan thereof by Pickering, Corts & Summerson, Civil Engineers and Registered Pennsylvania Surveyors, dated the eleventh day of April, A. D. 1955, as follows:

Authority granted to Department of Property and Supplies, with approval of Governor, to convey certain land in Bristol Borough, Bucks County.

Beginning at a point in the towpath on the easterly side of the canal at a distance of 160 feet, more or less, measured in a northerly direction from the westerly end of Lock No. 1, as shown on said plan; thence up the towpath and along the said canal parallel to and generally 6 feet from the water's edge on the towpath side
