AN ACT

Amending the act of June 24, 1931 (P. L. 1206), entitled "An act concerning townships of the first class; amending, revising, consolidating and changing the law relating thereto," authorizing the establishment and maintenance of certain places used and maintained for the collection, storage and disposal of certain goods and materials to be licensed.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

The First Class Township Code.

Section 1. Clause XLIII. of section 1502, act of June 24, 1931 (P. L. 1206), known as "The First Class Township Code," reenacted and amended May 27, 1949 (P. L. 1955), is amended to read:

Clause XLIII., section 1502, act of June 24, 1931, P. L. 1206, reenacted and amended May 27, 1949, P. L. 1955, further amended.

Section 1502. The corporate power of a township of the first class shall be vested in the board of township commissioners. The board shall have power:

XLIII. Junk Dealers, Pawnbrokers, Auctions. To regulate and license junk dealers, pawnbrokers, hucksters, peddlers, vendors, and public auctions and auctioneers and to regulate and license the establishment and maintenance of junk yards, salvage yards and other places used and maintained for the collection, storage and disposal of used and second-hand goods and materials.

Section 2. This act shall take effect immediately.

AN ACT

Amending the act of May 1, 1933 (P. L. 103), entitled "An act concerning townships of the second class; and amending, revising, consolidating, and changing the law relating thereto," authorizing the licensing of junk dealers, junk yards and scrap yards.

The Second Class Township Code.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Clause LVIII., section 702, act of May 1, 1933, P. L. 103, reenacted and amended July 10, 1947, P. L. 1481 and added March 11, 1959, P. L. 13, amended.

Section 1. Clause LVIII. of section 702, act of May 1, 1933 (P. L. 103), known as "The Second Class Township Code," reenacted and amended July 10, 1947 (P. L. 1481) and added March 11, 1959 (P. L. 13), is amended to read:

Section 702. Supervisors to Exercise Powers.—The corporate powers of townships of the second class shall be exercised by the township supervisors. Where no specific authority is given for the expenditures incident to the exercise of any power hereinafter conferred, or where no specific fund is designated from which such expenditures shall be made, appropriations for such expenditures shall be made only from the general township fund. In addition to the duties imposed upon them by section 516 hereof, they shall have power—

\* \* \* \* \*

LVIII. Junk Dealers and Junk Yards.—To regulate and license junk dealers and the establishment and maintenance of junk yards and scrap yards including, but not limited to, automobile junk or grave yards.

Act effective immediately.

Section 2. This act shall take effect immediately.

AN ACT

Amending the act of June 23, 1931 (P. L. 932) entitled "An act relating to cities of the third class; and amending, revising, and consolidating the law relating thereto," authorizing the regulation and licensing of junk dealers, junk yards and scrap yards.

The Third Class City Code.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 2403, act of June 23, 1931, P. L. 932, reenacted and amended June 28, 1951, P. L. 662, amended by adding a new clause 63.

Section 1. Section 2403, act of June 23, 1931 (P. L. 932), known as "The Third Class City Code," reenacted and amended June 28, 1951 (P. L. 662), is amended by adding, at the end thereof, a new clause to read:

Section 2403. Specific Powers.—In addition to other powers granted by this act, the council of each city shall have power, by ordinance:
