

said constitutional amendment and legislation passed in conformity therewith, may be made upon the establishment of the qualifications of those entitled thereto.

Section 10. Interest Computations.—The Governor, the Auditor General and the State Treasurer shall determine the amount of money necessary for the payment of interest on the bonds and the principal thereof, if any, and the times of such payments.

Section 11. Appropriations.—The Board of Finance and Revenue shall determine the amount of money necessary for the payment of interest on the bonds and the principal thereof, if any, for the fiscal period beginning June 1, 1961, and ending June 30, 1962, and the times and amounts of such payments and the amount so determined shall be transferred from the General Fund to the World War II Veterans' Compensation Sinking Fund, and for such purpose as much of the money as may be necessary is hereby appropriated from the General Fund.

For the purpose of providing for the bonds, for the payment of the cost of advertising the same, for payment of the compensation of the loan and transfer agent for the fiscal period commencing June 1, 1961, and ending June 30, 1962, for all other costs and expenses in connection with the issue of and sale and registration of said bonds, there is hereby appropriated from the World War *II Veterans' Compensation Fund to the State Treasurer the sum of \$25,000. Payments from this appropriation to be made by requisition of the State Treasurer after approval of voucher by the Governor, the Auditor General and the State Treasurer.

Section 12. Effective Date.—This act shall take effect immediately.

AN ACT

Amending the act of April 29, 1959 (P. L. 58), entitled "An act consolidating and revising the Vehicle Code, the Tractor Code, the Motor Vehicle Financial Responsibility Act and other acts relating to the ownership, possession and use of vehicles and tractors," requiring operators to depress their headlights when following or overtaking another vehicle, and providing penalties.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

The Vehicle Code.

Section 1. Subsection (b) of section 1034, act of April 29, 1959 (P. L. 58), known as "The Vehicle Code," is amended to read:

Section 1034.) Use of Multiple Beam Road Lighting
Equipment.—

* * * * *

(b) Whenever the operator of a vehicle approaches an oncoming vehicle within five hundred (500) feet or follows or overtakes another vehicle within three hundred (300) feet, such driver shall depress [, dim] or use a distribution of light or composite beam so aimed that the glaring rays are not projected into the eyes of the oncoming driver while such driver is approaching, or so that the glaring rays are not projected into the rear view mirror of the car being followed or overtaken, and in no case shall the high intensity portion, which is projected to the left of the prolongation of the extreme left side of the vehicle, be aimed higher than the center of the lamp from which it comes at a distance of twenty-five (25) feet ahead, and in no case higher than a level of forty-two (42) inches above the level upon which the vehicle stands at a distance of seventy-five (75) feet ahead.

Penalty.—Any person violating any of the provisions of this section, shall, upon summary conviction before a magistrate, be sentenced to pay a fine of ten dollars (\$10.00) and costs of prosecution, and, in default of the payment thereof, shall undergo imprisonment for not more than five (5) days.
