

A PROCLAMATION BY THE GOVERNOR

PROCLAMATION

I, David L. Lawrence, Governor of the Commonwealth of Pennsylvania, have caused this Proclamation to issue, and in compliance with the provisions of Article IV, Section 15, of the Constitution thereof, do hereby give notice that I have filed in the Office of the Secretary of the Commonwealth, with my objections thereto, the following bills passed by both Houses of the General Assembly at the Regular Session of 1961, viz.:

House Bill No. 301, entitled "An Act amending the act of March 10, 1949 (P. L. 30), entitled 'An act relating to the public school system, including certain provisions applicable as well to private and parochial schools; amending, revising, consolidating and changing the laws relating thereto,' providing for separate computation of tuition for junior high school tuition pupils and senior high school tuition pupils at the request of the receiving district."

Senate Bill No. 920, entitled "An Act amending the act of March 10, 1949 (P. L. 30), entitled 'An act relating to the public school system, including certain provisions applicable as well to private and parochial schools; amending, revising, consolidating and changing the laws relating thereto,' further regulating the election and term of office of school directors when districts are formed into union or merged districts."

House Bill No. 65, entitled "An Act providing for pensions for war veterans blinded through service connected injuries; conferring powers and imposing duties on the Department of Military Affairs and the Adjutant General, and making an appropriation."

Senate Bill No. 568, entitled "An Act amending the act of June 4, 1937 (P. L. 1643), entitled 'An act relating to certain existing beneficial societies; conferring certain rights, powers and duties upon them, their officers and members; and authorizing the payment of benefits by them in the event of sickness, accident, disability or death; regulating such societies and corporations; and limiting the amount for which they may issue membership certificates or policies; providing for reserves; imposing penalties; and repealing certain existing laws and parts of law,' further regulating contracts and payments of death benefits and providing for annual filing of certificates regarding surplus requirements."

House Bill No. 719, entitled "An Act amending the act of April 29, 1959 (P. L. 58), entitled 'An act consolidating and revising the Vehicle Code, the Tractor Code, the Motor Vehicle Financial Responsibility Act and other acts relating to the ownership, possession and use of vehicles and tractors,' eliminating duplicate revocations or suspensions arising out of same event or occurrence in certain cases."

Senate Bill No. 826, entitled "An Act prohibiting the expression by the judge before the jury or any juror in a criminal proceeding of his belief, opinion or thought concerning the guilt or innocence of any defendant in such proceeding."

Senate Bill No. 96, entitled "An Act authorizing the Department of Highways, with the approval of the Governor, to construct a highway and to erect and maintain a bridge over the Kiskiminetas River in Westmoreland and Armstrong Counties and to provide the necessary approaches and connections with State highways; empowering counties to pay certain damages."

Senate Bill No. 787, entitled "An Act providing for the acquisition by the Department of Forests and Waters of the Kinzua Bridge and certain adjoining grounds for a State park."

House Bill No. 1030, entitled "An Act authorizing additional pension and retirement payments to members of pension and retirement funds after termination of services and providing for appropriations by counties, cities, boroughs, towns and townships."

Senate Bill No. 931, entitled "An Act amending the act of April 9, 1929 (P. L. 177), entitled 'An act providing for and reorganizing the conduct of the executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative departments, boards, commissions, and officers thereof, including the boards of trustees of State Normal Schools, or Teachers Colleges;

abolishing, creating, reorganizing or authorizing the reorganization of certain administrative departments, boards, and commissions; defining the powers and duties of the Governor and other executive and administrative officers, and of the several administrative departments, boards, commissions, and officers; fixing the salaries of the Governor, Lieutenant Governor, and certain other executive and administrative officers; providing for the appointment of certain administrative officers, and of all deputies and other assistants and employes in certain departments, boards, and commissions; and prescribing the manner in which the number and compensation of the deputies and all other assistants and employes of certain departments, boards and commissions shall be determined,' imposing powers and duties on the General Assembly relative to the allocation of certain space in the State Capitol building."

House Bill No. 1013, entitled "An Act making an appropriation to the Cystic Fibrosis Laboratory at the Albert Einstein Medical Center in Philadelphia."

Senate Bill No. 202, entitled "An Act authorizing the Department of Property and Supplies, with the approval of the Governor, to acquire a tract of land with buildings, improvements and antiques and other personal property therein in the Borough of Brownsville, Fayette County, for preservation, care and maintenance as a historical site by the Pennsylvania Historical and Museum Commission."

House Bill No. 1050, entitled "An Act making an appropriation to the Paoli Memorial Association for improvements and repairs and for re-erection of a wall on the Paoli Parade Ground situate in Malvern Borough, Chester County."

House Bill No. 1802, entitled "An Act amending the act of May 5, 1933 (P. L. 364), entitled 'An act relating to business corporations; defining and providing for the organization, merger, consolidation, reorganization, winding up and dissolution of such corporations; conferring certain rights, powers, duties and immunities upon them and their officers and shareholders; prescribing the conditions on which such corporations may exercise their powers; providing for the inclusion of certain existing corporations of the second class within the provisions of this act; prescribing the terms and conditions upon which foreign business corporations may be admitted, or may continue, to do business within the Commonwealth; conferring powers and imposing duties on the courts of common pleas, and certain State departments, commissions, and officers; authorizing certain State departments, boards, and commissions, or officers to collect fees for services required to be rendered by this act; imposing penalties; and repealing certain acts and parts of acts relating to corporations,' further providing for the payment of dividends."

House Bill No. 1219, entitled "An Act amending the act of June 1, 1959 (P. L. 392), entitled 'An act relating to the retirement of State employes; amending, revising, consolidating and changing the laws

relating thereto,' preventing the diminution of the present value of a superannuation retirement allowance for all classes of membership and removing the eighty percent limitation upon the superannuation retirement allowance in the case of Class E membership but imposing a one hundred (100) percent limitation thereon.'"
