No. 1-A.

AN ACT

Making an appropriation to the General Assembly for the payment of expenses of its Inaugural Committee.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of twenty-five thousand dollars (\$25,000), or as much thereof as may be necessary, is hereby appropriated to the General Assembly for the payment of the expenses of its Inaugural Committee in making and carrying out the arrangements for the Inauguration of the Governor-elect on January 15, 1963.

Section 2. This act shall take effect immediately.

AN ACT

Making a supplemental appropriation to the Department of Commerce for the Pennsylvania Industrial Development Authority.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of four million dollars (\$4,000,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Commerce as a supplemental appropriation for the Pennsylvania Industrial Development Authority as set forth in the act of May 17, 1956 (P. L. 1609), the Pennsylvania Industrial Development Authority Act.

Section 2. This act shall take effect immediately.

## APPROPRIATION ACTS,

No. 3-A.

## AN ACT

Making an appropriation to the Department of Justice for the payment of a claim of the United States against the Commonwealth of Pennsylvania.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Findings of Fact.—A claim of the Federal government against the Commonwealth has grown out of the surplus food program initiated in Pennsylvania in 1953. The Commonwealth entered into a direct contract with the Federal government for the distribution of surplus food in Pennsylvania, and the various counties desiring to participate in the program entered into agreements with the Commonwealth. Westmoreland County was one of the counties joining in the program.

The volume of surplus food made available to each county was determined on the basis of a certification by the county to the Commonwealth of the number of needy persons eligible to receive surplus food. The Commonwealth in turn certified the requirements for each county to the United States Department of Agriculture on the basis of the county certification.

During the period of July 1, 1956, to March 30, 1959, the certifications for surplus food from Westmoreland County were grossly in excess of the actual number of the persons eligible for surplus food. State and Federal investigations showed that the improper certifications were made deliberately by county surplus food personnel and that some surplus food was illegally sold in the county. The former Westmoreland County Surplus Food Director, his assistant and two others involved in the illegal sale of surplus food were indicted and convicted in the Federal and State courts in 1960. The sentences contain no provision for restitution and a recent check made by the State Police at the request of the Department of Justice discloses that none of the convicted parties now released has any assets.

Following negotiations with the United States Department of Justice that began in January, 1961, a settlement of the claim was reached on July 27, 1962, in the sum of one hundred sixty-five thousand dollars (\$165,000). The original claim of the Federal government was approximately four hundred thousand dollars (\$400,000).

Of the one hundred sixty-five thousand dollar (\$165,000) amount, twenty-one thousand nine hundred forty-eight dollars and fifty-eight cents (\$21,948.58) has been paid directly by Westmoreland County to the United States, representing the proceeds of fidelity bonds on the former county personnel responsible for the losses and wages withheld from them. There remains the amount of one hundred forty-three thousand and fifty-two dollars (\$143,052) for which the Commonwealth is liable directly to the Federal government.

Section 2. Appropriation.—The sum of one hundred forty-three thousand and fifty-two dollars (\$143,052), or as much thereof as is

necessary, is appropriated to the Department of Justice for the purpose of paying the claim of the United States against the Commonwealth of Pennsylvania described in section 1 of this act.

Section 3. Effective Date.—This act shall take effect immediately.

A SUPPLEMENT

To the act of March 7, 1962 (Appropriation Act 1-A), entitled "An act to provide for the ordinary expenses of the Executive, Legislative and Judicial Departments of the Commonwealth, interest on the public debt, and for public schools for the fiscal \*year July 1, 1962, to June 30, 1963, and for the payment of bills incurred and remaining unpaid at the close of the fiscal period ending June 30, 1962," by providing for deficiencies in appropriations made by the act for the fiscal period ending June thirtieth, one thousand nine hundred sixty-three.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The following sums, or as much thereof as may be necessary, for deficiencies in certain appropriations made to the Department of Public Instruction and the Department of Public Welfare by the act to which this is a supplement are hereby specifically appropriated to such departments as follows:

I. EXECUTIVE DEPARTMENT

To the Department of Public Instruction

For the payment of the deficiency in the appropriation for payments to school districts on account of \*\*instructional cost of pupil education as provided in sections 2502 and 2502.2 of the Public School Code of 1949: Provided, That the Superintendent of Public Instruction, with the approval of the Governor, may make payments from this appropriation in advance of the due dates prescribed by law to school districts which are financially handicapped whenever he shall deem it necessary to make such advanced payments to enable school districts to keep their public schools open .....

To the Department of Public Welfare

For the payment of the deficiency in the appropriation for assistance payments and county administration as provided in the acts of June 24, 1937 (P. L. 2017, 2045 and 2051), June 24, 1939 (P. L. 872), June 27, 1939 (P. L. 1184), April 23, 1941 (P. L. 20), March 10, 1949

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The following sum, or as much thereof as may be necessary, for the deficiency in the appropriation made to the Department of Labor and Industry by the act to which this is a supplement is hereby specifically appropriated as follows:

I. EXECUTIVE DEPARTMENT

To the Department of Labor and Industry

For the payment of the deficiency in the appropriation for payments to employes and charges for medical services incurred in connection with the defense of claims against the Commonwealth under the Pennsylvania Occupational Disease Act of June 21, 1939 (P. L. 566) and Act No. 710, September 30, 1961 ..... \$2,700,000

AN ACT

Amending the act of March 7, 1962 (Appropriation Act 1-A), entitled "An act to provide for the ordinary expenses of the Executive, Legislative and Judicial Departments of the Commonwealth, interest on the public debt, and for public schools for the fiscal year July 1, 1962, to June 30, 1963, and for the payment

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The item in section 2 of the act of March 7, 1962 (Appropriation Act 1-A), known as the "General Appropriation Act of 1962," making an appropriation to the Department of State for payment of State contributions into the State Employees' Retirement Fund, is hereby amended to read:

Section 2. The following sums, or as much thereof as may be necessary, are hereby specifically appropriated from the General Fund to the several hereinafter named agencies of the Executive, Legislative and Judicial Departments of the Commonwealth for the payment of the salaries, wages or other compensation and travel expense of the duly elected or appointed officers and employes of the Commonwealth, for payment of fees for contractual services rendered, for the purchase or rental of goods, services, printing, equipment, land and buildings, and for payment of any other expenses as provided by law or by this act necessary for the proper conduct of the duties, functions and activities and for the purposes hereinafter set forth for the fiscal year beginning July 1, 1962, and for the payment of bills incurred and remaining unpaid at the close of the fiscal period ending June 30, 1962:

Section 2. The General Assembly hereby declares its intention to restore to the Department of State by subsequent legislation the funds withheld from it by this act.

AN ACT

Making an appropriation to the State Treasurer, for the purpose of paying salaries and wages of State officers and employes and other ordinary and

general expenses in the interim between \* June 30, 1963, and such time as the funds provided by the General Appropriation Act and other appropriation acts become available; and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 1963.

Whereas, Under the Constitution and the laws of this Commonwealth the State Treasurer may not pay out any moneys unless they be specifically appropriated by act of the General Assembly; therefore,

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of one hundred million dollars (\$100,000,000), or as much thereof as may be necessary, is hereby specifically appropriated to the State Treasurer of the Commonwealth of Pennsylvania, for the purpose of paying the salaries and wages of the officers and employes and other ordinary and general expenses of the State government in the interim between \* June 30, 1963, and such time as moneys appropriated by the General Appropriation Act and other appropriation acts of 1963 may become available for such purposes; and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 1963.

Section 2. Payments out of the appropriation of this act shall be made by the State Treasurer upon requisitions by the several departments, boards, commissions or officers, in the same manner as payments are ordinarily made.

Section 3. All amounts paid by the State Treasurer in accordance with this act shall be charged against the appropriations made for the salaries and wages of the officers and employes and other ordinary and general expenses of the State government in the General Appropriation Act and other appropriation acts of 1963.

Section 4. This act shall become effective immediately upon its final enactment.

No. 8-A.

AN ACT

Making an appropriation to the Department of Public Welfare and providing for certain allocations therefrom for the purpose of carrying out the Public Assistance Law, for the year beginning July 1, 1963, and for the payment of assistance and expenses accrued or incurred prior to and remaining unpaid on June 30, 1963, and limiting the amount thereof available for administrative expenses.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

\* "the" in original.

Section 1. The sum of twenty-five million dollars (\$25,000,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Public Welfare, for the payment of assistance for the fiscal year beginning July 1, 1963, and for the payment of assistance and administrative expenses incurred prior to and remaining unpaid on June 30, 1963.

Section 2. Out of the moneys appropriated by this act, the Department of Public Welfare shall allocate funds from time to time for the several assistance programs (old age assistance, aid to dependent children, pensions for the blind, aid to the disabled, general assistance and other programs provided by the Public Assistance Law), for administrative expenses of the several county boards of assistance, for such administrative expenses incurred by the department which are chargeable to such boards, and for the payment of attorneys' fees and court costs necessary for the proper conduct of the work of the department.

Section 3. Out of the moneys appropriated by this act, allocations shall be made to the Department of the Auditor General and the Treasury Department, respectively, in such amounts as may be deemed necessary to pay the administrative expenses of such departments in auditing and disbursing appropriations for or relating to public assistance, including any Federal sums supplementing such appropriations. In the case of the Department of the Auditor General, said allocation shall be made by the Governor, President pro tempore of the Senate, Speaker of the House of Representatives, Secretary of Public Welfare and the Auditor General, or a majority thereof, and in the case of allocations made to the Treasury Department, such allocations shall be made by the Governor, President pro tempore of the Senate, Speaker of the House of Representatives, Secretary of Public Welfare and the State Treasurer, or a majority thereof.

Section 4. Out of the moneys appropriated by this act, the Department of Public Welfare shall allocate funds from time to time to provide necessary medical, dental and surgical care for children as provided in the act of March 10, 1949 (P. L. 30).

Section 5. Out of moneys appropriated by section one of this act, not over one-half of one per centum thereof may be used under the direction of the Governor for surveys, investigations and studies relative to the more efficient enforcement of the public assistance law.

Section 6. This act shall become effective immediately upon its final enactment.

## AN ACT

Making an appropriation from the Motor License Fund to the Department of Property and Supplies for the payment of costs incurred by that department in acting as purchasing agent for the Department of Highways.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of one hundred twenty-five thousand six hundred seventy-five dollars (\$125,675), or as much thereof as may be necessary, is hereby specifically appropriated from the Motor License Fund to the Department of Property and Supplies for the fiscal year July 1, 1963, to June 30, 1964, for the payment of salaries, wages or other compensation of such bureau or division chiefs, experts, engineers, accountants, secretaries, auditors, inspectors, examiners, statisticians, clerks, stenographers, bookkeepers, messengers and other assistants and employes; for the payment of postage, traveling expenses, telephone toll charges, telegrams, newspaper advertising and notices; for the payment of the costs of advertising schedules of supplies, proposals for executing any contract work, readvertising any schedules or proposals, when necessary, for the purchase of office supplies and equipment, stationery, printing, printing supplies and printing processes; for the purchase of all materials, supplies and equipment; and for the payment of such other expenses as may be necessary for the proper conduct of the work of the department in acting as purchasing agent for the Department of Highways.

## AN ACT

Making an appropriation out of the Motor License Fund to the Department of Public Instruction to promote highway safety education.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of thirteen thousand dollars (\$13,000), or as much thereof as may be necessary, is hereby appropriated out of the Motor License Fund to the Department of Public Instruction for the fiscal year July 1, 1963, to June 30, 1964, for the purpose of promoting highway safety education through the schools in this Commonwealth.

AN ACT

Making a deficiency appropriation to the Department of Public Instruction for the payment of the deficiency in The State School Fund of Pennsylvania.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of six hundred three thousand two hundred eighty-one dollars (\$603,281), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Public Instruction for the payment of the deficiency in The State School Fund of Pennsylvania, and is to be expended on order of the State Council of Education in accordance with the provisions of sections 2603, 2604 and 2605 of the "Public School Code of 1949," the act of March 10, 1949 (P. L. 30), as amended, by the act of January 7, 1960 (P. L. 2101); Provided, however, That none of the money herein appropriated shall be expended on account of any project for which no application for payment was submitted to the Department of Public Instruction prior to December 27, 1961, nor shall any of the money hereby appropriated be expended for any purpose other than the purpose stated in this act.

Section 2. This act shall take effect immediately.

## AN ACT

Making a deficiency appropriation to the Department of Public Welfare to reimburse State-aided hospitals and Philadelphia General Hospital for part of the costs of training student nurses in approved schools of nursing.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of two hundred and twenty-five thousand dollars (\$225,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Public Welfare as a deficiency appropriation to be paid to State-aided medical and surgical hospitals and the Philadelphia General Hospital for the purpose of reimbursing such hospitals for part of the costs of training student nurses in approved schools of nursing at the rate of two hundred dollars (\$200) per annum for the thirteen month fiscal period ending June 30, 1962, and the fiscal year July 1, 1962, to June 30, 1963. Payments from the deficiency appropriation herein made shall be made to such hospitals from time to time at a rate proportionate to the full amount of the appropriations for the respective fiscal periods and the number of nurses not to exceed two hundred dollars (\$200) per nurse per annum.

Section 2. The provisions of this act shall be administered under regulations established or to be established by the Department of Public Welfare and the Auditor General.

Section 3. This act shall take effect immediately.

## AN ACT

Making a deficiency appropriation to the Department of Commerce for promoting the One-hundredth Anniversary of the Battle of Gettysburg and Lincoln's Gettysburg Address.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of twenty-eight thousand dollars (\$28,000), or as much thereof as may be necessary, is hereby appropriated to the Department of Commerce for payment of the deficiency in the appropriation for promoting and celebrating the One-hundredth Anniversary of the Battle of Gettysburg and Lincoln's Gettysburg Address.

Section 2. This act shall take effect immediately.

## APPROPRIATION ACTS,

No. 16-A.

## AN ACT

Making an appropriation to the Department of Commerce for rendering financial assistance to industrial development agencies engaged in promoting the development and expansion of business, industry and commerce in the respective counties of the Commonwealth.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of three hundred fifty thousand dollars (\$350,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Commerce for payment of grants to recognized industrial development agencies to assist such agencies in the financing of their operational costs, for the purposes of making studies, surveys and investigations, the compilation of data and statistics, and in the carrying out of planning and promotional programs.

Section 2. Expenditures of the funds appropriated in section 1 shall be made by the Department of Commerce in accordance with the provisions of Industrial Development Assistance Law, the act of May 31, 1956 (P. L. 1911).

Section 3. This act shall take effect July 1, 1963.

## AN ACT

Making an appropriation for the maintenance, repair and improvement of the Port of Philadelphia.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of one hundred thousand dollars (\$100,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Commerce, Bureau of Port Operations of the City of Philadelphia, for the maintenance, repair and improvement of the Port of Philadelphia for the fiscal year July 1, 1963, to June 30, 1964.

The moneys so appropriated shall only be expended as authorized and directed by the Council of the City of Philadelphia, and shall be drawn from the State Treasury upon warrants drawn by the Auditor General upon requisition by the Chief of the Bureau of Port Operations of said city.

## AN ACT

Making an appropriation to the Department of Public Welfare for payment of grants to political subdivisions for services for the aging and making an additional appropriation of moneys received for such purposes.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of one hundred fifty thousand dollars (\$150,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Public Welfare for the fiscal year July 1, 1963, to June 30, 1964, for payment of grants to political subdivisions to finance demonstration projects for the aging, including but not limited to homemaking services, day-care services and counseling services.

Section 2. All moneys received from the Federal Government, or from any other source as contributions, for the program provided for in section 1 hereof shall be paid into the General Fund and are hereby specifically appropriated for such purposes.

## AN ACT

Making an appropriation to the Treasury Department out of various funds to pay replacement checks issued in lieu of outstanding checks when presented and to adjust errors.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The following sums of money are hereby appropriated to the Treasury Department for the payment of replacement checks issued by that department in accordance with the provisions of the act of July 12, 1935 (P. L. 996):

The sum of ten thousand dollars (\$10,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Pennsylvania Historical and Museum Commission to be expended by said commission for the repair and restoration of the historic Caleb Pusey House in the Borough of Upland, Delaware County, Pennsylvania.

Section 2. The moneys hereby appropriated shall be available and expended only at such time as a sum equal to the amount hereby appropriated by the Commonwealth is contributed to the Trustees of the Caleb Pusey House by local historical societies, associations or similar organizations or by individuals to be used for the repair and restoration of the said Caleb Pusey House, and upon further condition that one or more local historical societies, associations or similar organizations shall covenant with said trustees to thereafter preserve and maintain the Caleb Pusey House in a good state of repair. Previously appropriated State funds shall not be included in determining the amount contributed under the provisions hereof. Affidavits evidencing such contributions and covenants shall be submitted by said trustees to the Auditor General.
