

APPROPRIATION ACTS

No. 1-A.

AN ACT

Making appropriations to the Department of Property and Supplies for payment of grants to various municipalities or municipal authorities for the Commonwealth's share of expenses and charges in connection with sewage systems expansions.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of forty-four thousand dollars (\$44,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Property and Supplies for payment to the Borough of Slippery Rock, to cover the Commonwealth's share of projects expanding and extending municipal sewage systems to the State College at Slippery Rock.

Section 2. The sum of one hundred thirty thousand one hundred fifty-three dollars (\$130,153), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Property and Supplies for payment to the Borough of Cresson, to cover the Commonwealth's share of projects expanding and extending municipal sewage systems to the State Institution at Cresson.

Section 3. Whatsoever of the amount herein appropriated is unexpended or unencumbered as of June 30, 1966, shall lapse.

Section 4. This act shall take effect immediately.

AN ACT

Making an appropriation to the Department of Mines and Mineral Industries to defray expenses resulting from mine rescue operations at Sheppton.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of sixty-one thousand six hundred seven dollars (\$61,607), or as much thereof as may be necessary, is hereby

specifically appropriated to the Department of Mines and Mineral Industries for the fiscal year ending June 30, 1964, for payment of expenses resulting from the mine rescue operation at Sheppton, Pennsylvania.

Section 2. This act shall take effect immediately.

AN ACT

Making an appropriation to the Department of Mines and Mineral Industries for the purpose of extinguishing, curtailing and preventing the spread of mine refuse bank fires and for the establishing of a pilot plant in a program to eliminate mine refuse bank fires and return the land to useful purposes.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of three hundred twenty-five thousand dollars (\$325,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Mines and Mineral Industries for the purpose of extinguishing, curtailing and preventing the spread of mine refuse bank fires which may be starting or spreading, or which may start in the future, and to take whatever steps that may be necessary, including the establishing of a pilot plant to eliminate mine refuse bank fires and returning the land to useful purposes. In addition to this amount, all moneys received from the Federal Government, or from any other source, as contributions for this program shall be paid into the General Fund and credited to this appropriation.

Section 2. This act shall take effect immediately.

A SUPPLEMENT

To the act of August 13, 1963 (Appropriation Act No. 45-A), entitled "An act to provide for the ordinary expenses of the Executive, Legislative and Judicial Departments of the Commonwealth, interest on the public debt and for public schools for the fiscal year July 1, 1963, to June 30, 1964, and for the payment of bills incurred and remaining unpaid at the close of the fiscal period ending June 30, 1963," providing deficiencies in appropriations made by the act for the fiscal year ending June 30, 1964.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The following sums, or as much thereof as may be necessary, for deficiencies in certain appropriations made to the Department of Forests and Waters, the Department of Public Instruction, the State Tax Equalization Board and the Department of Agriculture by the act to which this is a supplement are hereby specifically appropriated to such departments, and board as follows:

I. EXECUTIVE DEPARTMENT

To the Department of Agriculture

For the payment of the deficiency in the appropriation out of the General Fund to be paid into the State Farm Products Show Fund to stage the Annual Pennsylvania Farm Show and to maintain the Farm Show Building as provided in section 1709 of The Administrative Code of 1929 \$23,600

To the Department of Forests and Waters

For the payment of the deficiency in the appropriation for the salaries, wages and all necessary expenses, for the proper administration of the Department of Forests and Waters as provided in the acts of May 4, 1905 (P. L. 385), June 25, 1913 (P. L. 555), May 31, 1923 (P. L. 487), May 5, 1927 (P. L. 817), May 2, 1929 (P. L. 1530), May 17, 1929 (P. L. 1798), June 12, 1931 (P. L. 528), April 24, 1933 (P. L. 61), July 9, 1935 (P. L. 619), June 24, 1939 (P. L. 842), June 4, 1945 (P. L. 1383), June 5, 1947 (P. L. 422), May 29, 1956 (P. L. 1848), June 15, 1961 (P. L. 418), September 16, 1961 (P. L. 1388), and The Administrative Code of 1929, including water resources-maintenance and regulation and forest and park services-maintenance 50,000

To the Department of Public Instruction

For the payment of the deficiency in the appropriation for payments to school districts on account of instructional cost of pupil education as provided in sections 2501, 2502 and 2502.2 of the Public School Code of 1949: Provided, That the Superintendent of Public Instruction, with the approval of the Governor, may make payments from this appropriation in advance of the due dates prescribed by law to school districts which are financially handicapped whenever he shall deem it necessary to make such advanced payments to enable school districts to keep their public schools open 3,052,805

For the payment of the deficiency in the appropriation for additional payments on account of instructional cost of pupil education to encourage the formation of joint and union districts as provided in section 2502 of the Public School Code of 1949 250,000

APPROPRIATION ACTS,

For the payment of the deficiency in the appropriation for payments to school districts in reimbursement of tuition paid to other districts as provided in section 2503 of the Public School Code of 1949 \$25,000

For the payment of the deficiency in the appropriation for payments for tuition to school districts providing education to nonresident orphaned children placed in private homes by the court and nonresident inmates of children's institutions as provided in sections 1305, 1306, 2503 of the Public School Code of 1949 250,000

To the State Tax Equalization Board

For the payment of the deficiency in the appropriation for the salaries, wages and all necessary expenses for the proper administration of the State Tax Equalization Board as provided in the acts of June 27, 1947 (P. L. 1046), December 30, 1959 (P. L. 2072) 10,000

Section 2. This act shall take effect immediately.

AN ACT

Making an appropriation to the Department of Mines and Mineral Industries for payment into the Bituminous Coal Open Pit Mining Reclamation Fund as additional funds to administer and enforce the act of May 31, 1945 (P. L. 1198), as amended.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of two hundred seventy-two thousand seventy dollars (\$272,070), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Mines and Mineral Industries for the fiscal year July 1, 1964, to June 30, 1965, for payment into the Bituminous Coal Open Pit Mining Reclamation Fund to provide additional funds to administer and enforce the Bituminous Coal Open Pit Mining Conservation Act, the act of May 31, 1945 (P. L. 1198), as amended.

Section 2. This act shall take effect July 1, 1964.

AN ACT

Making an appropriation to the Department of Commerce for housing and re-development assistance.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of seven million seven hundred fifty thousand dollars (\$7,750,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Commerce for the fiscal year July 1, 1964, to June 30, 1965, to be expended by making grants for housing and redevelopment assistance as authorized by the act of April 12, 1956 (P. L. 1449), as amended, and by payment for the costs of administering such act: Provided, That such costs do not exceed two per centum of this appropriation. No more than twenty per centum of the amount herein appropriated shall be allocated or granted to any one political subdivision.

Section 2. This act shall take effect July 1, 1964.

AN ACT

Making an appropriation to the Department of Public Welfare for payment of grants to political subdivisions for juvenile delinquency programs.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of seven hundred thousand dollars (\$700,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Public Welfare for the fiscal year July 1, 1964, to June 30, 1965, for payment of grants to political subdivisions to assist in the development of juvenile probation services and special police and crime prevention programs for juveniles by providing a part of the cost in accordance with the provisions of The Administrative Code of 1929.

Section 2. This act shall take effect July 1, 1964.

APPROPRIATION ACTS,

No. 8-A.

AN ACT

Making an appropriation to the Department of Military Affairs for veterans' assistance.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of six hundred fifty thousand dollars (\$650,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Military Affairs for the fiscal year July 1, 1964, to June 30, 1965, to provide assistance to veterans and their dependents as provided in the act of November 10, 1959 (P. L. 1468), and The Administrative Code of 1929.

Section 2. This act shall take effect July 1, 1964.

AN ACT

Amending the act of July 25, 1963 (Appropriation Act 20-A), entitled "An act making an appropriation to the Department of Commerce for payments of grants to local agencies for tourist promotional assistance," by deleting reference to the fiscal year.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section 1 of the act of July 25, 1963 (Appropriation Act 20-A), entitled "An act making an appropriation to the Department of Commerce for payments of grants to local agencies for tourist promotional assistance," is amended to read:

Section 1. The sum of three hundred fifty thousand dollars (\$350,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Commerce [for the fiscal year July 1, 1963, to June 30, 1964] for payment of grants to local agencies for tourist promotional assistance in accordance with the Tourist Promotion [Assistance] Law, act of April 28, 1961 (P. L. 111).

Section 2. This act shall take effect immediately.

AN ACT

Making an appropriation to the Department of Commerce for payments of grants to local agencies for tourist promotional assistance.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of three hundred fifty thousand dollars (\$350,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Commerce for payment of grants to local agencies for tourist promotional assistance in accordance with the Tourist Promotion Law, act of April 28, 1961 (P. L. 111).

Section 2. This act shall take effect July 1, 1964.

AN ACT

Making an appropriation to the Department of Health for payments to municipalities and municipality authorities under the provisions of the act of August 20, 1953 (P. L. 1217), entitled "An act providing for payments by the Commonwealth to municipalities which have expended money to acquire and construct sewage treatment plants in accordance with the Clean Streams Program and the act, approved the twenty-second day of June, one thousand nine hundred thirty-seven (Pamphlet Laws 1987), and making an appropriation," and for the repair, improvements or additions of certain sewage treatment plants.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of six million three hundred fifty-seven thousand dollars (\$6,357,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Health for payments to municipalities and municipality authorities toward the cost of maintaining, repairing, replacing and other expenses relating to sewage treatment plants an amount not to exceed two per centum of the cost (1) for the acquisition and construction of the sewage treatment plants by the municipalities and municipality authorities to control stream pollution expended by the municipalities and municipality authorities from the effective date of the act of June 22, 1937 (P. L. 1987), up to and including the thirty-first day of December of the year preceding the year in which the payment is made, as ascertained by the Secretary of Health and approved by the Governor as provided by the act of August 20, 1953 (P. L. 1217), entitled "An act providing for payments by the Commonwealth to municipalities which have expended money to acquire and construct sewage treatment plants in accordance with the Clean Streams Program and the

act, approved the twenty-second day of June, one thousand nine hundred thirty-seven (Pamphlet Laws 1937), and making an appropriation," and (2) for the repair, improvements or additions since 1937 of plants constructed prior to that date.

Section 2. Within the meaning of this act, the word "construction" shall include, in addition to the construction of new treatment works, pumping stations and intercepting sewers which are an integral part of the treatment facilities, (including those intercepting sewers of municipalities which collect at least fifty per cent of the sewage of the municipality which enters a public sewage system in the municipality and discharge same into the collection system of the municipality which has constructed the main sewage plant), the altering, improving or adding to of existing treatment works, pumping stations and intercepting sewers which are essential to the sewage treatment plant system.

Section 3. If any section, sentence, clause or part of this act is for any reason held to be unconstitutional, the decision of the court shall not affect or impair any of the remaining provisions of this act. It is hereby declared as the legislative intent that this act would have been adopted had such unconstitutional sentence, section, clause or part thereof, not been included herein.

Section 4. This act shall take effect July 1, 1964.

AN ACT

Making an appropriation to the Department of Commerce for the Pennsylvania Industrial Development Authority.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of twelve million five hundred thousand dollars (\$12,500,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Commerce for the Pennsylvania Industrial Development Authority for the purposes set forth in the act of May 17, 1956 (P. L. 1609), the Pennsylvania Industrial Development Authority Act, and Act No. 471 of August 14, 1963 *(P. L. 1106).

Section 2. This act shall take effect July 1, 1964.

No. 13-A.

AN ACT

Making an appropriation to the Department of Commerce for rendering financial assistance to industrial development agencies engaged in promoting the development and expansion of business, industry and commerce in the respective counties of the Commonwealth.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of three hundred fifty thousand dollars (\$350,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Commerce for payment of grants to recognized industrial development agencies to assist such agencies in the financing of their operational costs for the purposes of making studies, surveys and investigations, the compilation of data and statistics and in the carrying out of planning and promotional programs.

Section 2. Expenditures of the funds appropriated in section 1 shall be made by the Department of Commerce in accordance with the provisions of Industrial Development Assistance Law, the act of May 31, 1956 (P. L. 1911).

Section 3. This act shall take effect July 1, 1964.

AN ACT

Making an appropriation to the Department of Public Welfare for payment of grants to political subdivisions for services for the aging and making an additional appropriation of moneys received for such purposes.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of two hundred thousand dollars (\$200,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Public Welfare for the fiscal year July 1, 1964, to June 30, 1965, for payment of grants to political subdivisions to finance demonstration projects for the aging, including, but not limited to, homemaking services, day-care services and counseling services.

Section 2. All moneys received from the Federal government or from any other source as contribution for the program provided for in section 1 hereof shall be paid into the General Fund and are hereby specifically appropriated for such purposes.

Section 3. This act shall take effect July 1, 1964.

No. 15-A.

AN ACT

Making appropriations to the Department of Forests and Waters for certain capital improvements in accordance with long range planning for capital improvements designed to make the most effective use of the State's available resources.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of one million two hundred ninety-five thousand two hundred thirty-four dollars (\$1,295,234), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Forests and Waters for capital improvement projects for the *Forests and Park Services and Water Resources programs, including movable equipment for new projects, various types of general improvements, alterations and construction at State parks and monuments and State forest installations, and a beach rehabilitation project at Presque Isle Peninsula. Any reimbursements received from the Federal Government for the Presque Isle project shall be deposited in and credited to the General Fund.

Section 2. The sum of two thousand two hundred ninety-seven dollars (\$2,297), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Forests and Waters for the Pennsylvania State Park and Harbor Commission **of Erie, for the purchase of movable equipment for new projects.

Section 3. The sum of twenty thousand eight hundred and five dollars (\$20,805), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Forests and Waters for the Washington Crossing Park Commission for capital improvement projects at the park.

Section 4. Whatsoever of the amounts herein appropriated are unexpended or unencumbered as of June 30, 1966, shall lapse.

Section 5. This act shall take effect July 1, 1964.

Making an appropriation to the Department of Agriculture for certain capital improvements in accordance with long range planning for capital improvements designed to make the most effective use of the State's available resources.

Section 1. The sum of forty-three thousand seven hundred sixty-eight dollars (\$43,768), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Agriculture for movable equipment for the new office building and laboratory.

Section 2. Whatsoever of the amount herein appropriated is unexpended or unencumbered as of June 30, 1966, shall lapse.

Section 3. This act shall take effect July 1, 1964.

The sum of seven hundred thirty-two thousand two hundred thirty-one dollars (\$732,231), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Military Affairs Armory Planning and Functions program for capital improvement projects which includes movable equipment for new projects and for various types of general improvements and alterations and construction at various armory buildings.

Section 2. Whatsoever of the amount herein appropriated is unexpended or unencumbered as of June 30, 1966, shall lapse.

Section 3. This act shall take effect July 1, 1964.

AN ACT

Making appropriations to the Department of Public Welfare for certain capital improvements in accordance with long range planning for capital improvements designed to make the most effective use of the State's available resources.

Section 1. The sum of seventy-one thousand dollars (\$71,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Public Welfare for capital improvement projects for the General and Special Hospital Services program, including movable equipment for new projects and various types of general improvements and alterations and construction at the State General Hospitals.

Section 2. The sum of one million two hundred seven thousand two hundred sixty-nine dollars (\$1,207,269), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Public Welfare for capital improvement projects for the Mental Health Services program, including movable equipment for new projects and various types of general improvements and alterations and construction at the State mental institutions.

Section 3. The sum of fifty-seven thousand dollars (\$57,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Public Welfare for capital improvement projects for the Services for Children and Youth program, including movable equipment and various types of general improvements and alterations and construction at various State institutions.

Section 4. Whatsoever of the amounts herein appropriated are unexpended or unencumbered as of June 30, 1966, shall lapse.

Section 5. This act shall take effect July 1, 1964.

AN ACT

Making an appropriation to the Department of Property and Supplies for certain capital improvements in accordance with long range planning for capital improvements designed to make the most effective use of the State's available resources.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of three hundred sixty-three thousand eight hundred fifty-two dollars (\$363,852), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Property and Supplies for capital improvement projects for the maintenance and custody of State Office Buildings and Grounds program, including movable equipment for new projects and for various types of general improvements and alterations and construction for State buildings.

Section 2. Whatsoever of the amount herein appropriated is unexpended or unencumbered as of June 30, 1966, shall lapse.

Section 3. This act shall take effect July 1, 1964.

AN ACT

Making an appropriation to the Department of Public Instruction for the payment to The State School Fund of Pennsylvania for assisting public school districts to comply with required safety standards in certain cases.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of seventy-one thousand one hundred seventy-three dollars (\$71,173), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Public Instruction for payment to The State School Fund of Pennsylvania for assisting public school districts to comply with required safety standards in accordance with the provisions of sections 2603, 2604, and 2605 of the Public School Code of 1949, the act of March 10, 1949 (P. L. 30), as amended: Provided, however, That no moneys shall be expended for any project unless application for payment has been submitted to the Department of Public Instruction by June 30, 1964, nor shall any moneys hereby appropriated be expended for any purpose other than the purpose stated in this act.

Section 2. This act shall take effect immediately.

Making appropriations to the Pennsylvania Historical and Museum Commission for certain capital improvements in accordance with long range planning for capital improvements designed to make the most effective use of the State's available resources.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of one hundred thirty-one thousand five hundred dollars (\$131,500), or as much thereof as may be necessary, is

hereby specifically appropriated to the Pennsylvania Historical and Museum Commission for the Museums program for movable equipment for new projects.

Section 2. The sum of forty-eight thousand dollars (\$48,000), or as much thereof as may be necessary, is hereby specifically appropriated to the *Pennsylvania Historical and Museum Commission for capital improvement projects for the Historical Properties program including movable equipment for new projects, various types of general improvements and alterations and construction at historical properties.

Section 3. Whatsoever of the amounts herein appropriated are unexpended or unencumbered as of June 30, 1966, shall lapse.

Section 4. This act shall take effect July 1, 1964.

Making an appropriation to the Department of Justice for certain capital improvements in accordance with long range planning for capital improvements designed to make the most effective use of the State's available resources.

Section 1. The sum of one hundred two thousand six hundred twenty-one dollars (\$102,621), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Justice for capital improvement projects, including various types of general improvements and alterations and construction at correctional institutions.

Section 2. Whatsoever of the amount herein appropriated is unexpended or unencumbered as of June 30, 1966, shall lapse.

Section 3. This act shall take effect July 1, 1964.

The sum of thirty-one thousand five hundred eighty-four dollars (\$31,584), or as much thereof as may be necessary, is hereby appropriated from the Korean Conflict Veterans' Compensation Fund to the Department of Military Affairs for the fiscal year July 1, 1964, to June 30, 1965, for the purposes of paying salaries, wages, postage, printing and other necessary expenses incurred in payment of compensation to veterans as provided by the Korean Conflict Veterans' Compensation Act.

AN ACT

Making an appropriation to the Department of Public Instruction for establishing network facilities to link educational broadcasting facilities.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of one hundred fifty-four thousand five hundred sixty dollars (\$154,560), or as much thereof as may be necessary, is hereby appropriated to the Department of Public Instruction to establish network facilities to link educational broadcasting facilities as may be required by the State plan for educational broadcasting as authorized by the act of September 12, 1961 (P. L. 1272), amending section 523 and adding section 525 of the act, known as the Public School Code of 1949, as amended.

Section 2. This act shall take effect July 1, 1964.

Amending the act of August 13, 1963 (Appropriation Act 45-A), entitled "An act to provide for the ordinary expenses of the Executive, Legislative and Judicial Departments of the Commonwealth, interest on the public debt, and for public schools for the fiscal year July 1, 1963 to June 30, 1964, and for the payment of bills incurred and remaining unpaid at the close of the fiscal period ending June 30, 1963," providing that any amount up to a specified sum unexpended, uncommitted and unencumbered in the appropriation of the Department of Public Welfare for assistance payments and county administration shall be available for assistance payments in the fiscal year July 1, 1964 to June 30, 1965.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section 9, act of August 13, 1963 (Appropriation Act 45-A), known as "The General Appropriation Act of 1963," is amended to read:

Section 9. That part of all appropriations in this act unexpended, uncommitted and unencumbered as of June 30, 1964, shall automatically lapse as of that date: *Provided, however, That any amount up to four million five hundred thousand dollars (\$4,500,000) unexpended, uncommitted and unencumbered in the appropriation herein*

to the Department of Public Welfare for assistance payments and county administration shall be available in the fiscal year beginning July 1, 1964, and ending June 30, 1965, for assistance payments.

Section 2. This act shall take effect immediately.

AN ACT

Making an appropriation from various funds of the Commonwealth to the Department of Labor and Industry for payment into the Social Security Contribution Fund as retroactive reimbursement for the payment of the Commonwealth's share of Social Security taxes to the Federal government with respect to the liability for compensation for the fiscal years prior to July 1, 1964.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of one million four hundred sixty-four thousand six hundred twenty-five dollars (\$1,464,625), or as much thereof as may be necessary, is hereby appropriated to the Department of Labor and Industry from the various funds of the Commonwealth and in the amounts hereinafter listed for payment into the Social Security Contribution Fund as retroactive reimbursement for the payment of the Commonwealth's share of Social Security taxes to the Federal government with respect to the liability for compensation for the fiscal years prior to July 1, 1964, when appropriations were not made in amounts necessary to cover certain Revenue Department employes compensated from various funds and for certain other employes including those compensated from funds from which appropriations were not made:

(a) The sum of one million three hundred fifty thousand three hundred eighty-two dollars (\$1,350,382) out of the Motor License Fund.

(b) The sum of three thousand one hundred fifty dollars (\$3,150) out of the Fish Fund.

(c) The sum of three thousand two hundred sixty dollars (\$3,260) out of the Game Fund.

(d) The sum of forty-one thousand thirty-two dollars (\$41,032) out of the Oil and Gas Lease Fund.

(e) The sum of one thousand seven hundred eighteen dollars (\$1,718) out of the Historical Preservation Fund.

(f) The sum of one thousand six hundred seventy-nine dollars (\$1,679) out of the Anthracite Coal Open Pit Mining Reclamation Fund.

(g) The sum of four thousand eight hundred seventeen dollars (\$4,817) out of the Bituminous Coal Open Pit Mining Reclamation Fund.

(h) The sum of fifteen thousand one hundred one dollars (\$15,101) out of the Feed and Fertilizer Fund.

(i) The sum of twelve thousand six hundred sixty-nine dollars (\$12,669) out of the Korean Conflict Veterans' Compensation Fund.

(j) The sum of fourteen thousand six hundred twenty-six dollars (\$14,626) out of the State School Fund.

(k) The sum of three thousand three hundred sixty-five dollars (\$3,365) out of the State Employes' Retirement Fund.

(l) The sum of seven thousand three hundred twenty-eight dollars (\$7,328) out of the School Employes' Retirement Fund.

(m) The sum of one thousand two hundred twenty-three dollars (\$1,223) out of the Municipal Employes' Retirement Fund.

(n) The sum of four thousand two hundred seventy-five dollars (\$4,275) out of the Anthracite and Bituminous Coal Mine Subsidence Fund.

Section 2. This act shall take effect immediately.

Section 1. The sum of two hundred thirty-five thousand dollars (\$235,000), or as much thereof as may be necessary, is hereby specifically appropriated [for the fiscal year beginning July 1, 1963] to the Department of Property and Supplies for payment to the Clarion Area Authority to cover the Commonwealth's share of projects extending municipal sewage systems expansions to the State College at Clarion.

AN ACT

To provide for the ordinary expenses of the Executive, Legislative and Judicial Departments of the Commonwealth, interest on the public debt, and for public schools for the fiscal year July 1, 1964, to June 30, 1965, and for the payment of bills incurred and remaining unpaid at the close of the fiscal period ending June 30, 1964.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. This act shall be known and may be cited as "The General Appropriation Act of 1964."

Section 2. The following sums, or as much thereof as may be necessary, are hereby specifically appropriated from the General Fund to the several hereinafter named agencies of the Executive, Legislative and Judicial Departments of the Commonwealth for the payment of the salaries, wages or other compensation and travel expense of the duly elected or appointed officers and employees of the Commonwealth, for payment of fees for contractual services rendered, for the purchase or rental of goods, services, printing, equipment, land and buildings, and for payment of any other expenses as provided by law or by this act necessary for the proper conduct of the duties, functions and activities and for the purposes hereinafter set forth for the fiscal year beginning July 1, 1964, and for the payment of bills incurred and remaining unpaid at the close of the fiscal period ending June 30, 1964:

I. EXECUTIVE DEPARTMENT

To the Governor

For the salaries, wages and all necessary expenses for the following purposes and activities, including the maintenance of the executive mansion, the expenses of entertainment of official guests, participation in the Governor's Conference, the expenses of the Executive Board and for the payment of traveling expenses of persons other than employees of the Commonwealth appointed by the Governor to represent the Commonwealth.

Administration of the office of the Governor as provided in section 701 of The Administrative Code of 1929 and the act of May 20, 1949 (P. L. 1608) \$1,000,000

In addition to this amount, all moneys received as reimbursement for expenses incurred in the administration of the act of August 5, 1941 (P. L. 752), shall
