

sizes, the number of dwelling units proposed for the elderly, and the character of any commercial or community facilities included in the project.

Section 24. Reports.—In addition to any other material which an Authority must file with the [State Planning Board] Department of Community Affairs according to the provisions of this act, it shall file with said [board] department—

(a) A copy of any rules, regulations or resolutions, and amendments thereto, adopted by it from time to time.

(b) At least once each year, a report of its activities for the preceding year, and such other reports as said [board] department may require.

[(c) Copies of the plans, layout, estimated costs, and proposed method of financing of proposed housing projects, as well as of any changes which may be made in any such project.]

Section 2. Reorganization Plan No. 1 of 1955, printed at 1955 (P. L. 2045), is hereby suspended in so far as it is inconsistent with the provisions of this act.

Section 3. This act shall take effect immediately.

AN ACT

SB 309

Amending the act of June 9, 1939 (P. L. 324), entitled "An act authorizing the council of cities of the second class A, to fix the salaries of members of the fire department; and establishing minimum salaries," further providing for minimum salaries and increments.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section 1, act of June 9, 1939 (P. L. 324), entitled "An act authorizing the council of cities of the second class A, to fix the salaries of members of the fire department; and establishing minimum salaries," is amended to read:

Section 1. The salaries of the chief of the fire department, assistant chiefs of the fire department, and all other members of

the fire department of cities of the second class A of this Commonwealth, shall be fixed by the council of such cities [at a sum not lower than contained in the following schedule:

follows, at sums not lower than hereinafter stated:

(1) The minimum annual salary or compensation to be paid the officers and firemen by any city of the second class A shall be five thousand four hundred dollars (\$5400) with minimum annual increments of two hundred dollars (\$200) for the first three years of such employment. If the annual salary or compensation of any fireman employed by the city on the effective date of this amending act is less than five thousand four hundred dollars (\$5400), such salary or compensation shall be increased to five thousand four hundred dollars (\$5400), and such fireman shall receive minimum annual increments of two hundred dollars (\$200) for the next three years of such employment, to wit, 1968, 1969 and 1970.

(2) Officers, including the chief of the department, receiving salaries in excess of five thousand four hundred dollars (\$5400) shall also receive annual increments of two hundred dollars (\$200) as is provided in clause (1) hereof.

(3) The minimum annual starting salary or compensation to be paid to the members of the fire alarm bureau by any city of the second class A shall be five thousand dollars (\$5000) with minimum annual increments of two hundred dollars (\$200) for the first two

years of such employment. If the annual salary or compensation of any member of the fire alarm bureau employed by the city on the effective date of this act is less than five thousand dollars (\$5000), such salary or compensation shall be increased to five thousand dollars (\$5000) and such member shall receive annual increments of two hundred dollars (\$200) for the next two years of employment.

AN ACT

SB 632

Amending the act of May 23, 1945 (P. L. 903), entitled "An act authorizing cities of the third class to establish an optional retirement system for officers and employes independently of any pension system or systems existing in such cities," authorizing pensions for widowers of employes and providing for additional payments to be made to contributors who become entitled to the retirement allowance.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Subsection (d) of section 4, act of May 23, 1945 (P. L. 903), entitled "An act authorizing cities of the third class to establish an optional retirement system for officers and employes independently of any pension system or systems existing in such cities," added July 27, 1959 (P. L. 568), is amended to read:

Section 4. * * *

(d) If council elects by ordinance to make such payments, the widow or widower of an employe who retires on pension or is killed in the service on or after January 1, 1960, shall, during her or his lifetime or so long as she or he does not remarry, be entitled to receive a pension calculated at the rate of fifty (50) per centum of the pension the employe was receiving or would have been receiving had he or she been retired at the time of his or her death.

Section 2. Section 4 of the act is amended by adding at the end thereof, a new subsection to read:

Section 4. * * *

(e) In addition to the retirement allowance which is authorized
