The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section 205, act of April 9, 1929 (P. L. 177), known as "The Administrative Code of 1929," amended July 25, 1963 (P. L. 278), is amended by adding at the end thereof a new subsection to read:

Section 205. Pennsylvania State Police.—

\* \* \*

(f) All new cadets and troopers shall serve a probationary period of eighteen months from date of original enlistment, during which time they may be dismissed by the commissioner for violations of rules and regulations, incompetency, and inefficiency without action of a court-martial board or the right of appeal to a civil court.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Route 32038, established by the act of June 22, 1931 (P. L. 594), entitled "An act establishing certain township roads as State highways; authorizing their construction, maintenance, and

improvement under certain conditions and restrictions; limiting the obligation of the Commonwealth in the construction of certain structures located on such highways; conferring certain powers upon the Department of Highways and local authorities, persons, associations and corporations for sharing the cost of the maintenance and construction of such highways; and making an appropriation to carry out the provisions of said act," is amended to read:

Indiana County

Route 32038. Beginning at a road intersection approximately 1.25 miles northeast of the village of Mechanicsburg in Brush Valley Township, Indiana County; thence northeasterly through Brush Valley Township [to a point on the Brush Valley-Cherryhill Township line;] a distance of approximately 1.45 miles; beginning again in Cherryhill Township at an intersection with Township Road 746; thence northeasterly through Cherryhill Township to a point on Route 301 in the village of Pikes Peak; thence northerly to a point on State-aid Application 4597 in the village of Penn Run, [in Indiana County,] a distance of [about 6.8] approximately 3.22 miles, a total distance of approximately 4.67 miles in Brush Valley and Cherryhill Townships, Indiana County.

Section 2. This act shall take effect immediately.
