SB 1089

Amending the act of June 24, 1939 (P. L. 872), entitled "An act to consolidate, amend and revise the penal laws of the Commonwealth," regulating the storage of firearms by certain dealers and providing penalties.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Subclause V of clause (j) of section 628, act of June 24, 1939 (P. L. 872), known as "The Penal Code," amended May 21, 1943 (P. L. 485), is amended to read:

Section 628. Uniform Firearms Act.—* * *

(j) Issuance of Licenses; Form To Be Prescribed by the Commissioner of the Pennsylvania State Police; Conditions; Display of Firearms Prohibited; License Fee; Revocation.—The chief or head of any police force or police department of a city, and, elsewhere, the sheriff of the county, shall grant to reputable applicants licenses, in form prescribed by the Commissioner of the Pennsylvania State Police, effective for not more than one (1) year from date of issue, permitting the licensee to sell firearms direct to the consumer, subject to the following conditions in addition to those specified in clause (h) hereof, for breach of any of which the license shall be forfeited and the licensee subject to punishment as provided in this act.

* * *

V. No firearm or imitation thereof, or placard advertising the sale thereof, shall be displayed in any part of any premises where it can readily be seen from the outside. In the event that the Commissioner of the Pennsylvania State Police shall find a clear and present danger to public safety within the Commonwealth or any area thereof firearms, rifles and shotguns shall be stored by licensee during the hours when licensee is closed for business safeguarded pursuant to regulations to be established by the Pennsylvania State Police,

The fee for issuing said license shall be ten dollars (\$10.00), which fee shall be paid into the county treasury.

Section 2. Subsection (p) of section 628 of the act, amended May 21, 1943 (P. L. 485), is reenacted to read:

Section 628. Uniform Firearms Act.—* * *

(p) Violation Penalty.—Any person violating any of the provisions of this section is guilty of a misdemeanor, and upon conviction there-

of, shall be sentenced to pay a fine not exceeding three thousand dollars (\$3,000), or undergo imprisonment not exceeding three (3) years, or both.

Section 3. This act shall take effect in five days.

AN ACT

SB 1099

Authorizing the Department of Property and Supplies, with the approval of the Governor, to accept by deed, gift or device certain real property in Punxsutawney Borough, Jefferson County.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The Department of Property and Supplies, with the approval of the Governor, is hereby authorized to accept by deed, gift or devise, in the name of the Commonwealth of Pennsylvania, for use of the Indiana University of Pennsylvania, any or all of such right, title or estate as may be available in and to the following two tracts of land, in the Borough of Punxsutawney, County of Jefferson and Commonwealth of Pennsylvania, bounded and described as follows:

Tract No. 1. Beginning at a point being the southwesterly corner of the tract hereby conveyed which point is at the easterly side of Center Street and northwesterly corner of lot now or formerly of Alexander Flenner; thence north 7 degrees 30 minutes east along the easterly side or right-of-way line of Center Street, a distance of 500 feet to a stake; thence south 82 degrees 30 minutes east through other lands of which this is formerly a part, a distance of 400 feet to a point at lands of R. & P. Coal Company; thence south along said coal company land, a distance of 100 feet to a stake at lands which were formerly known as Macaroni Lot (now Punxsutawney School District); thence easterly along said coal company line and the former Macaroni Lot, a distance of 33 feet to the easterly boundary of the larger tract of which this was formerly a part; thence south 11 degrees 17 minutes west along other lands of R. & P. Coal Company, a distance of 310 feet, more or less, to an iron pin at the northerly extension of Foundry Street; thence north 82 degrees 30 minutes west along said Foundry Street, a distance of 42.7 feet to an iron pin; thence south 7 degrees 30 minutes west along the westerly side
