

townships having a population of less than four thousand, not more than nine hundred dollars per year in townships having a population of four thousand and more but less than ten thousand, not more than twelve hundred dollars per year in townships having a population of ten thousand and more but less than fifteen thousand, not more than two thousand dollars in townships having a population of not less than fifteen thousand and not more than twenty-five thousand, and not more than twenty-four hundred dollars in townships having a population in excess of twenty-five thousand. Such salaries shall be payable monthly or quarterly as full compensation for the duties imposed by the provisions of this act.

AN ACT

SB 1324

Authorizing the Department of Property and Supplies, with the approval of the Governor, to convey to the Township of Bensalem, in the County of Bucks, certain real property located in the township.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The Department of Property and Supplies, with the approval of the Governor, is hereby authorized on behalf of the Commonwealth of Pennsylvania, to grant and convey to the Township of Bensalem, County of Bucks, a tract of land in the Township of Bensalem, County of Bucks and Commonwealth of Pennsylvania, bounded and described according to a plan made by William S. Erwin, Registered Professional Engineer, Fairless Hills, Pennsylvania, on the 14th day of July 1967, as follows:

Beginning at a point in the Turnpike's southern right-of-way line, which point is normal to and 125 feet distant southerly from Turnpike Centerline Station 281 + 19.5, in Bucks County, Delaware River Extension; thence along the Turnpike southern right-of-way line south 73 degrees 34 minutes 5 seconds east, a distance of 994.08 feet to a point in the western right-of-way line of U. S. 1; continuing thence along the Commonwealth U. S. 1 property line, the following courses: by a curve in a southwesterly direction an arc length of 87.38 feet, the radius of said arc being 11,519.15 feet, to a point; thence south 26 degrees 45 minutes 24 seconds west, a distance of 61.46 feet to a point, thence north 63 degrees 14 minutes

36 seconds west, a distance of 24.0 feet to a point; thence by a curve in a southwesterly direction an arc length of 85.95 feet, the radius of said arc being 50.0 feet to a point; thence north 54 degrees 44 minutes 36 seconds west, a distance of 342.62 feet to a point; thence by a curve in a westerly direction an arc length of 282.39 feet, the radius of said arc being 306.0 feet to a corner of lands of Herman Cohen; thence along lands of Herman Cohen, Commonwealth of Pennsylvania and Josephine Tlush, north 53 degrees 05 minutes 23 seconds west, a distance of 305.92 feet to the point and place of beginning, less and excepting the following tract: beginning at a point in the southern right-of-way line of the Pennsylvania Turnpike, said point being opposite Turnpike Center-Line Station 280 + 79.33, 110 feet distant measured therefrom at right angles; thence along the southern right-of-way line of the Pennsylvania Turnpike the following five (5) courses and distances: south 73 degrees 34 <sup>1</sup> minutes 05 seconds east 361.29 feet to a point; south 28 degrees 34 minutes 05 seconds east 7.07 feet to a point; south 73 degrees 34 minutes 05 seconds east 145.01 feet to a point; north 61 degrees 25 minutes 55 seconds east 7.07 feet to a point; south 73 degrees 34 minutes 05 seconds east 186.50 feet to a point, said point being common to lands now or former of township of Bensalem and the Pennsylvania Turnpike; thence along lands now or former of township of Bensalem south 23 degrees 47 minutes 02 seconds west 117.46 feet to a point, said point being common to lands of township of Bensalem and other lands of the Commonwealth of Pennsylvania; thence along other lands of the Commonwealth of Pennsylvania north 54 degrees 44 minutes 36 seconds west 98.50 feet to a point; thence by a curve in a westerly direction an arc length of 281.16 feet, the radius of said arc being 306.00 feet to a corner of lands now or former of Herman Cohen; thence along lands now or former of Herman Cohen, Commonwealth of Pennsylvania and American Standard Corporation north 53 degrees 05 minutes 23 seconds west 345.98 feet to the point and place of beginning, containing 1.236 acres, more or less, of land and being a part of the same land conveyed to the Commonwealth of Pennsylvania by Deed of Friends Hospital, dated July 22, 1949 and recorded on July 29, 1949 in Bucks County Deed Book 911, page 420.

The conveyance shall be made under and subject, nevertheless, to all easements, servitudes and rights of others, including but not confined to streets, roadways and rights of any telephone, telegraph, water, electric, gas or pipeline companies as well as under and subject, nevertheless, to any estate or tenancies vested in third persons, whether or not appearing of record, for any portion of the said land or improvements erected thereon.

Section 2. The deed of conveyance shall be approved by the Department of Justice and shall be executed by the Secretary of Property and Supplies in the name of the Commonwealth of Pennsylvania.

Section 3. This act shall take effect immediately.

AN ACT

SB 1497

Amending the act of June 1, 1959 (P. L. 392), entitled "An act relating to the retirement of State employes; amending, revising, consolidating and changing the laws relating thereto," authorizing the payment of expenses to judges serving outside their judicial districts.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Subsection (4) of section 401 act of June 1, 1959 (P. L. 392), known as the "State Employes' Retirement Code of 1959," added October 5, 1967 (P. L. 355), is amended to read:

Section 401. Superannuation Retirement Allowances.—

\* \* \*

(4) Any member of Class E or E.1 who has retired, who has either actively served in such office by virtue of appointment or election for at least thirty (30) years continuously or otherwise regardless of age, or who has attained the age of seventy (70) years, who has served at least one full elected term or ten (10) years in the aggregate as a judge continuously or otherwise, and who shall hold himself in readiness to advise with his successor and his colleagues of the court of which he had been a member, and to perform such duties as may be imposed upon him as judge, special master, referee, auditor, or examiner, in such ways as he may reasonably be able to do, as assigned by the Chief Justice of the Supreme Court, may elect to receive during a period of time equal to the unexpired portion of his term or until death, whichever first occurs, a sum equal to the salary he was receiving immediately prior to his retirement. During the period that he is receiving such benefits such member shall not be permitted to practice as an attorney and shall receive no additional compensation for performing any judicial duties except expenses as are provided for judges when serving outside their judicial districts and retirement benefits as provided herein. Upon expiration of the aforesaid period of time, such member shall be entitled to receive the benefits, provided by the other provisions of this act, which he shall have earned by his service, including in the computation
